# **Non-Profit Guidelines for Purchasing City Houses**



## Purchasing City Houses for \$1

The city will sell to non-profit organizations at a reduced price of \$1 if the property has been on the market for AT LEAST 60 DAYS and the asking price is \$25,000 or less.



### Purchasing City Houses for \$1,000

The city will sell to non-profit organizations at a reduced price of \$1,000 if the property has been on the market for LESS THAN 60 DAYS and the asking price is \$25,000 or less.

#### Guidelines for both \$1 and \$1,000 purchases:

- Pay closing costs including but not limited to the Letter Report, closing fee, current tax bill if applicable, current water bill, and broker's commission if the property is listed with a broker.
- Must have been in operation for at least 12 months.
- Must have housing rehab experience and the intent of the purchase must be to rehabilitate the property.
- After rehabilitation is complete, the property may be sold to an owner-occupant or can be kept as an investment property.
- To view a City property on the Extended Listing, a Right of Entry agreement and key must be picked up by contacting David Dorsey at (414) 286-5645 or by email at <a href="mailto:ddorse@milwaukee.gov">ddorse@milwaukee.gov</a>. To view a City property that is listed with a broker, contact the broker directly.

#### Steps needed to secure such a purchase:

- Select a vacant property with a sales price equal to or less than \$25,000. Choose from properties marked as eligible on the <u>Extended Listing</u> (• Eligible for Community Based Organization [CBO] \$1 sale) or a property listed with one of our outside brokers. PLEASE NOTE: Additional properties are listed on the Multiple Listing Service (MLS). To get information on those properties contact a <u>Wisconsin licensed real estate agent</u>.
- 2. Provide letter stating the intent of the purchase, as stated above.
- 3. Examine the scope of work for the repairs (provided by the City).
- 4. Provide a timetable for the completion of the work.
- 5. Provide evidence of financing for the rehabilitation of the property (no gift letters).\*
- 6. Provide IRS Non-Profit 501(c)(3) letter and Articles of Incorporation.
- 7. Must be registered with Wisconsin Department of Financial Institutions
- 8. For properties on the Extended Listing, offers to purchase shall be made directly to the City real estate office on City forms. Submit <u>City of Milwaukee Offer to Purchase</u> to 809 N. Broadway, Milwaukee, WI 53202. Email offers to <u>ResidentialOffers@milwaukee.gov</u> or fax to (414) 286-0395. For properties listed through a broker, offers must be submitted directly to that broker.
- 9. A \$50.00 earnest money deposit made payable to the City of Milwaukee (cashier's check or money order and is non-refundable if offer is accepted).
- 10. Buyers must conform to standard City buyer policies.
- 11. Broker commissions will not be paid by the City on the sale of properties through this program.
