If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Gilbert Gwinn, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 05/11/94 at 11:05PM, officers conducted a tavern check at Ralph's Lounge located at 4538 W Lisbon Av. Officers spoke to licensee, Ralph Neely and asked Mr. Neely where the current class B license was as it was not posted in plain view. Mr. Neely produced the licenses from inside of the cash drawer. Mr. Neely was advised that the licenses must be posted and was given a written warning.
- 2. On 02/18/95 at 2:10AM, officers responded to a complaint of a fight at Ralph's Lounge located at 4538 W Lisbon AV. Officers found a front window had been smashed out and licensee, Ralph Neely was on the scene and stated he did not want to prosecute as the patrons involved were his relatives and were having a birthday party. Officers asked to see the current licenses, as they were not posted in plain view. Officers attempted to check the rest of the licensed premise and were told by Neely that they needed a warrant.

3. On 10/26/97 at 2:00AM, officers responded to a shooting in the parking lot of Ralph's Lounge located 4538 W Lisbon AV. Two people were shot in the parking lot. Investigation revealed that a fight broke out in the tavern and Neely attempted to close the bar down and the fight moved to the parking lot where the shooting occurred.

4. On 02/21/98, officers responded to a shooting at Ralph's Lounge located at 4538 W Lisbon Av. Upon arrival, officers spoke to licensee, Ralph Neely who stated there was only a fight and no one was shot. One 9-MM casing was found inside of the tavern. Officers interviewed a patron at ST Joseph's hospital who stated he was shot inside of the tavern.

7. Incident: On 08/30/98, at 2:20AM, officers were dispatched to a shooting in the parking lot of Ralph's Lounge, located at 4538 W Lisbon AV. An argument broke out in the lot at closing time and one patron produced a handgun and one person was shot. At the time of the investigation, the premise was not open for business.

8. On 12/17/98 at 1:50AM, officers were dispatched to Ralph's Lounge located at 4538 W Lisbon AV regarding trouble with a subject. Upon arrival, officers found the front door of the tavern locked and it took several minutes to gain entry. Officers were able to observe two patrons drinking in side of the tavern. Due to others calls, officers had to leave the premise. On 12/17/98 at 8:45PM special men conducted a follow-up investigation and spoke to Ralph Neely who stated that no one was drinking after hours. He was advised to keep the door unlocked when open for business.

9. On 02/27/99 at 12:32AM, officers were dispatched to shots fired in front of Ralph's Lounge located 4538 W Lisbon AV. Officers attempted to enter Ralph's Lounge to interview patrons regarding the shots fired complaint and found the front door was locked. Officers knocked several times before licensee, Ralph Neely let them in. A citation was issued to Mr. Neely.

- ❖ NOTE: On 06/08/99, items 1 thru 9 were heard at the Utilities & License hearing and a 30 day Suspension was recommended. On 06/10/99 the Common Council followed this recommendation and gave Mr. Neely the 30 day Suspension.
- 10. **Incident:**On 04/12/2000, officers were dispatched to the 2400 block of N Sherman for shots fired. Investigation revealed that the shooting occurred in the parking lot of Ralph's lounge located at 4538 W. Lisbon AV. Mr. Neely was uncooperative in the initial investigation and stated to officers that he had no control what happens outside in the parking lot. Shell casings were found in the bar parking lot on the east side of the building.
- 11. **Incident:** On 04/13/2000, officers were dispatched to shots fired at Ralph's Lounge located at 4538 W. Lisbon AV. Investigation revealed that a patron was backing her auto out of a space in the tavern lot and struck another parked vehicle. She stated that she got out of her auto and was confronted by a man who started to argue with her and pulled a semi-automatic handgun and fired several rounds into her empty vehicle. He then left the scene. Numerous bullet holes were observed in complainant's vehicle.

12. On 05/07/00 at about 1:00AM Officers conducted a tavern check at Ralph's Tavern located at 4538 W. Lisbon Av. Upon entering the tavern Officers found three underage persons inside the tavern. The licensee was on the scene.

- 13. On Wed. 2-21-2001 at 1:35am, Milwaukee Police filed a Battery Complaint from a victim who was punched by unknown persons outside Ralph's Lounge, 4538 W Lisbon Ave.
- 14. On Friday 4-6-2001 at 12:45am Milwaukee Police were dispatched to N 45th & W Lisbon to investigate a call for a wanted subject. The caller stated that her ex boyfriend, John E James had battered her a month ago and that charges were issued and that he has warrants. She indicated that James was inside of Ralph's Lounge, 4538 W Lisbon Ave. and gave the officers a description of James. After confirming that there were battery warrants for James, and after calling for an additional squad, patrons began to exit Ralph's and James was observed leaving the tavern. The caller identified James. Upon being approached by the officers and informing him that he was being arrested, he became combative and attempted to strike the officers. He was eventually taken into custody and a custodial search revealed suspected marijuana in a clear plastic baggy and suspected crack cocaine individually wrapped in 16 cornercut baggies. These narcotics were found in James' front pants pocket. The drugs later tested positive as THC and as cocaine.
- 15. On Friday, 4-13-2001 at 9:52pm a Milwaukee Police Officer was on the scene of a shooting at 4428 W Lisbon Ave. She was approached by a Milwaukee Detective who asked that she go to Ralph's Lounge, 4538 W Lisbon to investigate an Endangering Safety By Use Of Dangerous Weapon, possibly relating to the shooting at 4428 W Lisbon. The officer spoke to Ralph Neely who said that his brother, Willie Neely closed the bar about 12:30am on Fri 4-13-2001. Both Ralph and Willie came back to open the bar at about 8:30pm on 4-13-2001 and Ralph noticed some debris on the floor in front of the front door to the tavern. He saw what appeared to be a bullet hole in the upper left corner of the door. A mark was found on a decorative pillar about 20 feet inside the tavern. A misshapen round was found by Willie Neely on the sink behind the serving bar. This incident does not appear to be related to the shooting at 4428 W Lisbon Ave.

Page 5 RE: NEELY, Ralph

16. On Saturday, 5-12-2001 at 2:22am Milwaukee Police were dispatched to 4538 W Lisbon to respond to a subject down called in by Milwaukee Fire Dept. They observed a male about 45 years old lying in the parking lot of Ralph's Lounge. The victim identified as Tony Carter was unconscious and bleeding from his head. He was conveyed to Froedtert Hospital accompanied by a police officer.

A hospital security person, per their policy, searched Carter's belongings and discovered a clear plastic baggie containing 20 corner cut bags containing suspected crack cocaine. The security person gave the suspected cocaine to the police officer who conveyed it to the Vice Squad where it was tested positive to cocaine (.2 grams). Police Department records indicated that an anonymous female called that a black male was stomped to death, he's bleeding.

At the scene, officers observed a blood trail, leading from the victim to the tavern. Officers interview the licensee, who was uncooperative, who related that the victim had been given a "Counterfeit" one-hundred-dollar bill and pulled a gun, which was taken away from the victim. And used to beat the victim. One of the investigating officers "followed the blood trail into the tavern, around the bar and into the archway to a back room of the tavern. There was what appeared to be a large area of blood spots in this archway. This area was damp and appeared to have been cleaned up. Directly in front of these spots was a portal wet-carpet cleaner, which was plugged in. (Mr.) Neely denied that there was an attempt to clean up blood spots yelling "you must be fucking crazy, telling me this is a crime scene!" (Mr.) Neely repeated denied that any incident occurred inside of the tavern. On the east entrance where the blood trail entered the tavern, was a wooden porch, with brick stairs. This stairway was wet, consistent with being washed down with water. (Mr.) Neely denied that there was any attempt to clean up any blood, inside or outside of his tavern. (Mr.) Neely was extremely uncooperative with police, refusing to answer questions and attempting to order the (the police) to leave his tavern."

17. On 05/30/2001 at 12:59 AM officers responded to Ralph's Lounge at 4538 W Lisbon Av regarding a shooting. Investigation revealed that several patrons had been shot during a gunfight IN the tavern. Four patrons received various gun shot wounds, however, none were life threatening. Mr. NEELY, who was on the scene at the time, was described by the investigating officers as uncooperative. Mr. NEELY was observed sweeping up shell casings and bullets. Mr. NEELY was also over heard saying to patrons "Why are giving the police all that information. They don't need to know all of that". (Or words to that substantial effect.) Officers also discovered one 20-year-old patron, who had been sold alcohol by Mr. NEELY.

- 18. On 06/08/2001 at 12:30 AM officers made a lawful inspection of the licensed premises at 4538 W Lisbon Av, Ralph's Lounge. Officers observed a man, who was identified as a security guard. This guard was armed with a 9 MM semi-automatic handgun, in a holster, in plain view, however, he was NOT in any type uniform. Incident Report Filed
- NOTE: On 06/21/2001 the Class B Tavern license renewal filed by Ralph E Neely was withdrawn. He was facing a possible license denial. On 06/25/2002 the applicant's wife, Sandra POLK applied for a Class 'A' and Malt license for the above address. That application is still pending before the Utilities and Licenses Committee.
- 19. On 10-14-05 at 11:34pm, Milwaukee Police were dispatched to 4538 W Lisbon for a shooting. Investigation revealed a male subject, (identified as Kenneth McDade b/m 12-20-70 3620 N 12th St) was shot four times. McDade stated prior to his arrival at Ralphs Coffee Shop, he had snorted cocaine. He then arrived at Ralphs and had a couple of beers when a male approached him and stated, "Keep my name out of your mouth!" McDade stated words were exchanged and it then became a physical altercation. McDade stated the male left the tavern but returned later, walked up to McDade and stated, "Bitch Ass Nigga" and then started shooting. No violations were observed at the tavern and CIB handle the shooting investigation.
- 20. On 01/29/10 at 10:05 pm, Milwaukee police were dispatched to 46th and Lisbson for a Shots Fired complaint. An anonymous caller stated that a security guard from Ralphs Coffee was running after a vehicle shooting at it and further stated that 15-20 shots were fired. Milwaukee police also received two additional calls regarding shots being fired. Officers spoke with two patrons who stated they were in the bar waiting for a food order when they overheard two males at a near-by table, state he was going to get something from the trunk of his car. Both patrons stated they took this to mean he was going to get a gun so they immediately left the bar, got into their car and circled the block. As both patrons returned to the bar, they observed one of the males with a gun in waistband. Both patrons stated to police that they never observed any security at the bar and that while they were in the tavern, no altercations took place. Officers spoke to the bartender Willie Neely who stated he did not hear any gunshots being fired and that there were no incidents inside the tavern that night. Neely stated to police that they do have security cameras however they were not operating due to no tape being in the machine. No licensing violations were observed.
 - 21. On 05/20/11 at 9:35 pm, police were in the rear parking lot of Ralph's Coffee Shop located at 4538 W Lisbon Avenue. Officers have spoken to the owner of the property Ralph Neely regarding subjects loitering on the property with Neely stated he does not give permission to anyone to loiter in his parking lot and wants police action when subjects are found to be violating. Neely does have two signs posted in the parking lot that state, No Loitering. Officers observed a subject standing near the rear exit of the business who was holding an open intoxicant in his hand. A field interview was conducted and the investigation revealed that the subject was in possession of an illegal substance and because of this, began fighting with police. Because of this, a crowd of patrons began to gather around the police yelling obscenities causing officer to call for more squads. There are no surveillance cameras outside of the business. While on scene, police spoke to Willie Neely, brother of the owner, who stated he doesn't allow people to loiter outside the establishment, but is unable to watch every person.

- 22. On 09/22/11 at 11:00 pm, Milwaukee police were dispatched to 49th and Garfield for a Shots Fired complaint. Additional calls revealed the shots were fired from the parking lot of Ralph's Coffee located at 4538 W Lisbon. Investigation revealed shots were fired with casings being recovered from the parking lot and a empty field next to Ralph's Coffee. A car was found to have had its drivers side window shot out and the owner was inside Ralph's when this occurred. No one was injured and reports were filed.
- 23. On 12/05/11 at 10:07 pm, Milwaukee police were dispatched to 44th and North for a Shots Fired complaint. While canvassing the area, officers pulled into the parking lot of Ralph's Coffee and could smell a strong odor of marijuana. Police then observed two males inside an auto that was parked in the lot. Investigation revealed these subjects were in possession and smoking marijuana and were arrested. Officers were not able to obtain video surveillance from the business, due to the fact it does not record.
- 24. On 12/13/11 at 7:01 pm, a citizen who flagged down police was pointing to the parking lot of Ralph's Coffee, stating that someone had been shot. Investigation revealed two patrons had been inside the business eating food. The two patrons left and were sitting inside the car that was parked in the parking lot of Ralph's when they were approached by an unknown male who was asking for a light. The two subjects stated they didn't have a light and the unknown male attempted to open the car door. The driver attempted to drive out of the parking when several shots were fired striking both subjects. Police interviewed the bartender and brother of the licensee, Willie Neely, who both stated they did not see or hear anything. The surveillance system for the business does not record; therefore officers were unable to view this incident.
- 25.On 01/03/2015 a subject walked in to Milwaukee police district #3 to report he had been robbed at gunpoint in the parking lot immediately after leaving Ralph's Coffee Shop Bar (4538 West Lisbon Avenue). Milwaukee police incident report #150030058 filed.
- 26. On 05/07/2015 a Milwaukee police Sergeant observed shots being fired in the parking lot of Ralph's Coffee (4538 West Lisbon Avenue). Investigation revealed two subjects went to Ralph's to pick up food. There was an argument between the victims and suspect inside the business and the suspect left. The suspect fired approximately ten shots at the victims when they exited the business. Both victims sustained gunshot wounds requiring medical attention. Milwaukee police incident report #151270171.
- 27. On 11/14/15 at 11:30pm, Milwaukee Police were dispatched to St Joseph's Hospital regarding a shooting that occurred at Ralphs Coffee (4538 West Lisbon). The victim stated he was leaving the establishment when the suspect approached him from the alley. The suspect produced a handgun and a struggle ensued over the weapon. The suspect shot the victim once to the back then robbed the victim of \$30.00. The premise had working surveillance cameras that captured the incident. No calls were made from the establishment regarding the incident.
- 28. On 11/16/15 the agent, Ralph Neely was mailed a notice of nuisance premise (80-10 Chronic Nuisance Premise) for Ralphs Coffee (4538 West Lisbon). The notice directs the agent to contact the Milwaukee Police Department within 10 days of receipt of the notice with a course of action to abate nuisance activities occurring at the establishment

- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/18/2014 a Milwaukee police officer responded to 5007 West Center Street (Uptown Café) in an attempt to retrieve video regarding a burglary. After several failed attempts by phone and in person to contact the applicant, the officer gave up and no video was obtained regarding Milwaukee police incident report # 140460041.
- 2. On 04/27/2014 Milwaukee police responded to a shooting at 5004 West Center Street. Two subjects were struck by gunfire. These subjects told officers they were in the area to patronize Jay's Uptown Café, but they were shot prior to entering the business. Additionally, a vehicle owned by a patron of Jay's Uptown Café was struck by gunfire. Milwaukee police incident report #141170023 filed.
- 3. On 11/09/2014 Milwaukee police responded to a subject with a gun complaint at 5007 West Center Street (Jay's Uptown Café). Chuck Brady, the head of security, stated there was a fight inside the premise. Brady stated two of the subjects that were fighting were kicked out and they were armed with guns. Brady believed the subjects retrieved the guns from their cars. Brady further stated a security guard was taken to the hospital. James Perry was interviewed at St Joes Hospital. Perry stated a fight broke out and when he attempted to help other security guards he was knocked to the ground by an unknown subject. While on the ground he felt a poke to the left side of his head. Perry than used his mace and sprayed the crowd. He then felt someone bite his ear. Perry received 30 stiches to the back of his head, 4 staples to

his right hand, 4 stiches to his right ear and 3 stiches to a puncture wound. The agent was on scene but did not witness the fight. No video was available for this incident. Milwaukee police incident report #143130014 filed.

- 4. On 03/29/2015 Milwaukee police responded to a shots fired complaint in the area of North 50th Street and West Center Street. Police received calls from citizens about shots being fired in the area as well as Shotspotter activity in the same area. After the initial call for shots fired, officers were dispatched to St. Joseph's hospital to meet a shooting victim. The victim told officers he had been at Jay's Uptown Café around 11:20pm. When he exited the business around bar close and returned to his car. The victim decided to urinate outside of his vehicle when he observed an unknown subject fire numerous shots in his direction from a long gun. The victim suffered 11 wounds as a result of this incident. Officers later discovered 15 spent casings in the area of the shooting and that the victim's car sustained damage from 15 gunshots. The agent stated there was a large crowd that night for his birthday but there were no problems inside the tavern. Milwaukee police incident report #150880024 filed.
- 5. On 08/23/2015 Milwaukee police were dispatched to 5007 West Center Street for a shooting and fight complaints. While at that location, officers were informed a victim had gone to St. Mary's hospital indicating he had been shot in a tavern in the area of North 49th Street and West Center Street. The victim stated he left the business with other patrons when he heard 7-8 gunshots. The victim later realized he'd been shot and was taken to the hospital. The victim suffered a gunshot wound to the foot during this incident. A total of 17 casings and 2 bullet fragments were recovered from the shooting scene. Milwaukee police incident report #152350026 filed.
- 6. On 01/03/2016 Milwaukee police responded to a battery complaint at St. Joseph's Hospital. One witness told officers she believed the victim had been involved in an altercation at a bar named "Jays", but she could not provide a location. The victim had a laceration to his head, and indicated there had been an incident at an unknown bar on the south side. The victim declined to make any other statements. An officer determined the only tavern in the city of Milwaukee named "Jays" is Jays Uptown Café (5007 West Center Street). An officer conducted follow up on 01/06/2016 at Jays Uptown Café. The officer viewed video from inside the business on the night of the incident. The officer observed nothing on camera indicating an altercation had occurred on the premises. The applicant indicated he was on scene the night of the incident and reported no problems that night. Milwaukee police incident report #160030027 filed.
- 7. On 01/30/2016 a Milwaukee police officer observed patrons arguing and pushing each other while exiting Jay's Uptown Café (5007 West Center Street). The disturbance ceased when the officer activated the squad's lights and siren.
- 8. On 03/06/2016 Milwaukee police were dispatched to a battery complaint at 5007 West Center Street (Jay's Uptown Café). The caller told officers she was with a group of females who caused disturbance and were asked to leave. When she refused, a security guard removed her from the premise. The caller told police she was mad because security did not have to put his hands on her.

- 9. On 06/11/2016 Milwaukee police responded to a theft complaint at 5007 West Center Street (Jay's Uptown Café). There had been an altercation inside the business that was broken up by security. A security guard from the business intervened, drawing his firearm. The security guard was arrested for endangering safety by use of a dangerous weapon. The victim told officers that around 2:15am there were 20-25 patrons on the sidewalk outside Jay's Uptown Café (5007 West Center Street). Officers needed to physically remove the security guard from the vehicle and escort him out of the taped off area. Patrons became upset while officers cited the parked cars and additional squads responded. A total of 12 parking citations were issued for obstructing the roadway.

Officers spoke with the agent and explained to him they had received a call that a subject wearing specific clothing was in the business and possessed a firearm. - 15.On 11/03/16, at 1:56am, officers responded to a shot spotter call at 5001 W Center. They also received an additional call that someone was shooting inside of Jays Uptown Café. It was later determined no shots were fired from inside the establishment. Officers did locate vehicle that was struck and a casing at 4917 W Center.
- 16. On 11/06/16 a Sergeant observed a large crowd gathered in front of Jays Uptown Café(5007 W Center). She then observed a fight between multiple people break out on the sidewalk. Multiple squads arrived and were able to disperse the crowd. A bouncer stated a fight between multiple females began inside and made its wat to the front of the tavern until police arrived.

Witnesses interviewed by Officers stated fights/arguments/commotion began to sprout inside the premise at closing and spread into the street. The witness stated the victim was involved in an altercation with a male with the victim spitting in the males face. The male punched the victim and proceeded to chase her around a vehicle. Then the security guard approached to separate the 2 subjects. The witnesses then tried to walk past the victim's vehicle when the victim began to back up towards the witnesses. A verbal argument began between the victim and the witnesses. The witnesses stated they observed the security guard with his firearm in his hand pointed down and against his side and stated he never pointed it at the victim.

The security guard stated he had seen a male chasing a female around a vehicle in the parking lot to the North of the premise. The security guard stated it chose to intervene to prevent the victim from being injured. The security guard put himself between the 2 subjects when another subject pulled the male away from the situation and he attempted to keep the victim from further engaging physically with the male. The security guard stated the victim struck him several times, but it did not cause injury. The security guard stated he told the victim to get into her car and leave. He stated he yelled at other vehicles that were stopped on 50th St. to move so the victim could leave. The victim then began to back her vehicle as 2 females were passing by. A verbal argument between the victim and the 2 females began, with the victim stating, I'll run everybody over I don't care. The security guard stated he drew his firearm from his waist band and kept it down at his side, because he believed the victim may run him and the 2 female over with her vehicle. The security guard stated he gave the victim his name and location when she told him she was calling Police and remained on scene.

The security guard was taken into custody for Endangering Safety by Use of a Dangerous Weapon.

We recently met with our neighbors and other stakeholders and based upon that meeting we will be implementing the following:

We will be installing additional light fixtures, which have been designed and will be installed to minimize the impact on adjacent properties while providing adequate lighting levels to assure security and discourage loitering.

We have put into place a Mitigation Management Plan to deal with neighborhood complaints, control of noise, litter, graffiti, etc., and provide a protocol for communicating with police to resolve potential problems with loitering, noise and other problems.

Mitigation Management Plan:

Specifically – Litter Control – We shall control the litter emanating from our site on a daily basis (every hour) for a distance of 300 feet along public streets and right of way from our site.

We will continue to be closed on Mondays.

We will stop serving alcohol 30 minutes before bar close.

We will stop playing music 30 minutes before bar close to promote a more calm departure.

We will increase our food sales from 45% to 50% and reduce our alcohol sales from 55% to 50%.

We will add additional security video cameras in and around the perimeter of the establishment.

We recently purchased an ID Scanner so that everyone that enters will have his or her identification recorded. This will allow us to ban trouble customers and allow us to help identify individuals for law enforcement.

We will maintain a liaison with the Milwaukee Police Department and continue our relationship with Alderman Stamper's office to effectively control, noise, litter, traffic issues and crime. In fact, every time any issue has arisen over the past license year we have contacted and met with Alderman Stamper. We have already spoken with MPD Neighborhood Liaison Officer Dolan and will be scheduling a meeting with him in early December 2016.

We are employing six (6) security guards over the weekend and three (3) during the weekdays. They will operate the metal detectors, ID Scanners, and patrol the surrounding area in a security vehicle to deter nuisance/criminal conduct.

We are willing to provide additional enhanced lighting to address neighbor & police concerns and to their satisfaction.

Customers will be discouraged from loitering on the property and blocking or parking in surrounding neighborhoods. We have posted signs that police will be called for loitering, littering and loud noise. Any customer who violates these rules and regulations will have their name entered into our ID Scanner and will be banned from our premises.

Exterior cleanup and maintenance activities including garbage pick-up and deliveries shall not take place later than 9pm or prior to 7pm. We have contacted all of our vendors to inform them of this new policy.

We will provide the neighbors with a contact sheet to contact us regarding any issues that come up. We will meet with neighbors on an as needed basis to discuss and address any issues or concerns.
