The Department of Public Works requires Emerging Business Enterprise participation in almost all of its formal public works contracts. The percentage required on any particular project is determined based on the availability of EBE firms as certified by the EBE office. On each project, DPW and EBE office staff meet to discuss availability of firms and match these firms with specific items or part of any contract. For example, if a sewer contract contains 20 items, some items such as pavement restoration, erosion control, and traffic control are quantified and labeled as EBE items based on the fact that there are several EBE firms who can perform such work. If the total cost of these items exceed 18%, then the higher percentage is required on this project. The rare exceptions are those projects where certified EBE firms are not available for the particular work involved. In such cases, zero or very low percentage is required. An example of such project is a cured in place sewer contract. This work is verv specialized, and the cost of the material constitutes a significant portion of the total project cost. As such, the opportunity for EBE participation is either reduced or eliminated. Despite having a limited number of contracts every year that have either no EBE requirement or a requirement of less than the standard 18 percent, DPW is able to achieve the overall 18% required by Chapter 360 of the Milwaukee Code of Ordinances.

As of the writing of this report, 61 contracts were closed, of which 25 of them had EBE performance that ranged from 20 to 27 percent. The average <u>achieved</u> EBE percentage for the 2007 year is shown below. The numbers shown for the previous three years are % required and not achieved.

Included as an exhibit is a table displaying a comparison between the *Required* EBE percentages and *Actual* EBE percentages on the 2007 contracts that are closed out. This analysis offers, for the first time, a direct performance assessment of each contractor. Typically the EBE office provides a running analysis of EBE performance which is valuable in terms of evaluating the overall compliance with the program but does not present the direct relationship between required and actual achievements on individual contracts. This table also illustrates that the closed 2007 contracts are averaging an EBE requirement of about 17.5%. More importantly than the required EBE is the percentage of EBE work that is being achieved. The actual performance based on the bid amount is about 25.2%, and the EBE performance based on the final

project cost is approximately 27.2%. Meaning, on average, DPW contracts are achieving about 6% higher EBE participation than is required by City Ordinance.

Not all contractors actually achieve the level of EBE participation established in their contracts. So far in 2007, three (3) of the closed contracts have fallen slightly short of their required EBE participation rate. In all cases, the shortfalls were because the work in the field changed from original expectations as the project progressed. Virtually all sewer or water main relay contracts require pavement restoration. Typically this type of work is performed by EBE firms. Some of these relay projects precede a paving project. If the timing is such that the paving contract is occurring immediately after the underground work, then restoration is no longer needed.

As a result, less or no pavement is restored and the opportunity for an EBE is eliminated. Contractors cannot be held accountable for shortfalls that are beyond their control. In another instance, the prime contractor could not find any EBE firms to perform any work on the project. The EBE office was consulted to help us find any EBE firms to introduce to the prime and none were found.

So far, as mentioned above, three of the 2007 closed contracts have shortfalls in EBE participation. The contractors were not able to achieve their EBE requirements because of the modifications that were made in their original contract, when the EBE standards were set. Should there be any in future contracts and the contractor cannot offer a reasonable explanation why, DPW will issue a warning if the shortfall is a first time offense. Subsequent offenses can be cause for debarment.

DPW's formal contracting accounts for the vast majority of the Department's contract expenditures. In 2007, DPW awarded \$46,978,184.18 in formal contracts and \$4,595,052 in professional service contracts. Our EBE program management and enforcement has always been very diligent for these formal contracts, and as of 2005, a new procedure has been set in place to address service and informal contracts. Attached hereto is an example of the Department's monthly EBE summary report. The report can be found on the DPW web site contracts page (<u>www.mpw.net</u>). They are also regularly provided to the EBE office.


As of July of 2008, service contracts within all DPW Divisions show a lower rate of EBE participation at 15.2%. The calculation of this percentage value does not take into consideration money spent to pay utility bills or other municipalities for service provided to the City. In these instances, an EBE opportunity is not possible. If these expenditures are considered in the calculations, then the percentage will naturally be higher than reported.

Exhibit B illustrates the EBE requirements and performance for the closed 2007 contracts based on the type of project. The project types in this analysis include Buildings & Fleet, Paving, Sewer, and Water. The chart below points out that every type of project has performed significantly higher than the 18% required by ordinance with Water performing the highest with over 28% EBE participation.

The analysis contained in Exhibit B also points out that the Water projects are responsible for over \$13 million in closed contracts. This is followed by Sewer with \$6.2 million, Paving with \$2.3 million, and Buildings and Fleet with about \$750,000 in closed contracts for 2007.

EBE Performance

The chart below illustrates the amount of wages that are paid to emerging business enterprises based on the types of projects that are performed. The projects include contracts for Buildings and Fleet, Paving, Sewer, and Water. EBE performance is measured in two ways. It is shown as the percentage paid to emerging business enterprises based on the original bid amount and as a percentage of the actual final cost.



Average EBE Performance by DPW Division for 2007 Closed Contracts

Each project type/division surpassed the 18% threshold for EBE participation when analyzing actual performance based on the bid amount.

It is evident that certain DPW Divisions have more opportunity for EBE participation. Paving projects achieved the highest amount of EBE participation for the 2007 contracts closed to date with over 28 percent.

During 2007 DPW entered into formal contracts with nine new prime contractors. One of these nine was a certified EBE. As of October of 2008, DPW entered into contracts

with eleven new prime contractors, of which three were EBE certified. This report includes a list of these contractors.
