The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/12/2015 officers received a call regarding a sexual assault complaint regarding a taxi driver who was identified as the applicant. The victim stated she got into the cab with her boyfriend with the driver telling her to sit in front. The boyfriend was dropped off first and the applicant drove the victim around for 30-45 minutes. The victim stated the applicant was touching her leg and kissing her. He asked her to go to Potawatomi Bingo with him and made other advances. He did eventually drop her off at home and she accepted his phone number so she could give that number to the police. The applicant was located and denied kissing the victim and stated he did nothing wrong. The victim refused to prosecute.

On Monday, 10-12-15, at approximately 5:04pm, squad 1240, Police Officer Rick BUNGERT and I were dispatched to a sexual assault complaint at 1129 N. Jackson St. # 1420. Upon our arrival, we were met by the caller/complainant, Kayla M. KRECKEL, w/f, 07-31-90 of the above listed address, phone of 262-527-3113. KRECKEL stated that early Sunday morning, 10-11-15, some time after 2:30am to approximately 3:30pm, a taxicab driver named "Dave" who was driving a blue minivan taxicab sexually harassed her.

KRECKEL stated that early Sunday morning after bar closing time, she and her friend, Andrew MORGAN, phone of 262-501-1165 hailed a cab being driven by an unknown black male with a possible, unknown accent. Upon getting into the cab, KRECKEL stated that the cab driver told her to get in the front seat while Andrew got in the back. KRECKEL added that since she was going to her residence and Andrew to his, the cab driver dropped MORGAN off at his residence first. While en route to her residence, KRECKEL advised the cab driver that she did not have her debit/credit card on her to pay him upon his arrival at her residence and asked if it would be okay for her to go to her apartment to get it. KRECKEL stated that the cab driver replied that it was fine and proceeded to drive her back in the direction of the downtown area.

While en route back to the downtown area, KRECKEL stated that the cab driver was being very evasive in not wanting to take her home right away as she expected. KRECKEL stated what should have been about a ten minute drive back downtown to her residence, turned into a 30-45 minute ride with the cab driver making multiple, random stops along the city streets (including in front of the Whiskey Bar located at 788 N. Jackson St), sending out various texts and phone calls. KRECKEL added that the cab driver was asking her very inappropriate questions, trying to get her to hang out with him at Potawatomi Bingo & Casino, stating that he could call up some of his friends to get some weed. KRECKEL also stated that the cab driver was grabbing at her, touching her thighs, and trying to pull her into him to hug her, and kissed her, tongue in mouth, several times.

KRECKEL stated that when she realized that the cab driver, later identified via his cell phone number as Leul A. AMARE, b/m, 01-20-93 of 8629 W. Capitol Dr. # G, Milwaukee, WI 53222, phone of 414-595-0414 had not planned to immediately take her home, she did whatever she could, within reason, to get home alive as she was not sure what AMARE was capable of doing to her. KRECKEL added that such is part of the reason why she did not run out of the car any one of the several times that she stated AMARE had pulled off to the side of the road. KRECKEL also stated that her cell phone was dead, so if she were able to flee, it would have been in an area where people were as she was not able to call for help due to her cell phone being dead.

After declining AMARE's advances and attempts to "hang out," KRECKEL stated that AMARE eventually dropped her off across the street from her residence at which time AMARE asked her out on a date. In an attempt to get some type of identifying information on AMARE, KRECKEL stated that she accepted his phone number in which he did call her shortly after having dropped her off to state that it was his number "Dave" that called her phone.

After explaining to KRECKEL how this incident would proceed through the criminal justice process, KRECKEL declined to prosecute stating that she was the victim of a sexual assault when she was fourteen and did not want to have to deal with the court system again. KRECKEL did ask that if AMARE's identity was revealed that we speak to him so that what happened to her doesn't happen to another female.

. Upon locating and speaking with AMARE, AMARE initially denied having any knowledge of the incident and circumstances of the complaint that was filed against him. AMARE then stated that he did nothing wrong to KRECKEL, adding that she got into the front passenger seat on her own without his urging. AMARE also denied kissing KRECKEL but did admit that he invited her to Potawatomi because he also works there. AMARE further stated that he would not "speak to or have any unprofessional contact" with any females while he's working.
