It has just come to our attention that the above occupancy certificate for Judy's Red Hots located at 848 N. 27th St. was issued in error. Information received from the Milwaukee Health Department, indicates this establishment was closed on October 9th, 2007 as a result of a license revocation hearing and appeal. You indicated to the plan examiner that this establishment was closed for less than 6 months.

Since this establishment was closed longer than 6 months, based on the occupancy application date, City ordinance requires that inspection be conducted by the construction, plumbing and electrical section of the Dept of Neighborhood Services. Records do show that the plumbing inspection was completed, but not the construction and electrical inspection. These inspectors must conduct an inspection of the premises, and only, after they verify no violations exist, would an occupancy certificate be issued.

You must apply for a new occupancy application. The fee from this occupancy will be credited to this new application, which is enclosed.

Be advised that occupancy # 794840 has been cancelled.

Dear Mr. Tufail:

I am writing to follow up on our September 15th, 2006 meeting at the District Three Milwaukee Police Department (MPD) station concerning the above-referenced property. As you know this meeting was attended by District Three Captain James Harpole, several of the District Three Community Prosecution Officers, and representatives from the Avenues West and West End neighborhood Associations.

During the course of our meeting, we discussed various Department of Health and Neighborhood Services, MPD and community concerns regarding your property, including the complaints of ongoing drug dealing occurring in or around your property. Such activity included the arrest of one of your employees in connection with marijuana that was recovered from his vehicle parked at your business. You indicated you were aware of some of these complaints and pledged your cooperation in attempting to remedy these problems. However, you also indicated that given the ongoing problems at that location and a decline in your business, you were seriously contemplating selling your business at that address.

Nevertheless, you also indicated that in the interim, you were solidly committed to trying to contribute to a positive transition in the neighborhood. To this end, in order to improve security in and around your property, you agreed to install a new digital security camera system in your business at 2635 W. Kilbourn within the next thirty (30) days. You indicated that this system will have the capacity to record and store images for up to three months and you indicated your willingness to share any pertinent images with MPD.

In addition, in order to address some of the other issues associated with your business, you had agreed to meet on Monday, September 18th, 2006, at 4:00 p.m. with Mr. Keith Stanley of the So-Ho Main Street District to discuss plans for a façade improvement to

your building, along with other aesthetic improvements such as decorative fencing, additional lighting, awnings, and new pavement of the parking lot.

Unfortunately I have learned from Mr. Stanley that you failed to appear at the meeting as scheduled and have not returned his phone calls attempting to reschedule. This is certainly disappointing and contradicts your repeated assertions of cooperation.

Please contact Keith Stanley immediately at (414) 350-4079 to reschedule this meeting. His remains available to discuss with you the items you indicated you wanted to address at your property.

The District Three Community Prosecution Unit remains committed to addressing the issues discussed at our meeting and anticipates your continued cooperation in connection with the above-referenced matters. Please do not hesitate to contact me at (414) 935-7033 with any questions or comments prior to our next scheduled meeting at District Three on October 20, 2006 at 3:00 pm.

This report is being submitted by P.O. Eric WURTH, assigned to District 3, Early Shift, Squad 3294, with my partner P.O. Mitch ROSS.

On Friday, July 13th, 2007, at 3:24pm we were dispatched to 2635 W. Kilbourn Av. for a complaint of a theft. Upon arrival we were greeted by a w/m, who identified himself by WI ID as M.R. BRESLAUER (w/m, 10/09/30).

BRESLAUER stated that he had been in Judy's ordering his food, when a unknown b/m came into the store asked about a restroom, then went outside to use the bathroom. He stated that he saw the b/m coming back into the store, and as he was getting ready to pay for his food the b/m took a \$20 bill right out of his and and then ran s/b on N. 27th St.

BRESLAUER stated that he followed the b/m, S/B on N. 27th St. and then E/B on W. State St. He said that he followed him for two blocks and then lost him, due to becoming tired and unable to follow. He said he believed the b/m turned N/B down the alley between N. 25th St. and N. 24th St.

BRESLAUER described the b/m as being 509 tall, 220 lbs, heavy build, dark complected, wearing a med colored shirt w/white stripe around the center, med colored pants, he could give no further description.

After questioning BRESLAUER, we spoke to the owner of Judy's, Amjad T. TUFAIL (w/m, 11/19/50) who stated that he did not observe the theft, but did have video from the inside of the store.

Amjad tooks us back into his office and showed us the video, which clearly shows, BRESLAUER standing at the order window and a b/m coming into the store then leaving out and coming back into the store. The video then shows the b/m running out of the store and BRESLAUER running out after him.

Squad 1824, ID TECH HAYES arrived on scene and recorded a copy of the video for this investigation. Video was placed on MPD inv #384556.

Fall, B/M, 03-02-89, who was the only one present at the time. Mr. Fall said the owner, Amjad T. Tufail, had just left to make arrangements to get the door that was broken into, fixed. I observed the glass smashed in the door located on the S/W side of the business when I first pulled up. I also saw a chunk of concrete rock laying on the ground just outside the door. Mr. Fall confirmed the chunk of concrete wasn't there before and was probably used to smash the glass door.

According to Mr. Fall, he and his brother, Ahmadou R. Fall, B/M, 10-05-83, worked until closing last night, 12:00 am. When Mr. Fall left about 12:45 am this date, his brother was still there but almost ready to leave himself. Mr. Papa Fall returned to work about 10:00 am this date to open up, he found the glass door pane had been smashed and the door was unlocked. Mr. Fall cautiously went inside and checked around. When Mr. Fall went to get the cash register change drawer, which is hidden inside an oven in the back when the restaurant isn't open, he opened the oven door, which has a window in it, and found the change drawer was empty. Mr. Fall said \$100.00 in denominations of \$1, \$5, \$10, and \$20 bills had been in the change drawer.

Mr. Fall further stated that he didn't see anything else disturbed and nothing else appeared to be taken. Mr. Fall called his brother and while telling him what happened, the restaurant owner, Mr. Tufail, called. Mr. Tufail told Mr. Papa Fall to call police and he was on his way to the restaurant. Mr. Papa Fall went ahead and opened the restaurant. Mr. Fall stated he used the \$80.00 he had to start the cash register out and when he went to put the change drawer back in the cash register, the drawer was already open. Mr. Fall said the key to the register was left in it so all anyone had to do was turn the key and hit the button to open it up.

According to Mr. Fall, there is no alarm on the restaurant and the security camera is currently not operational. Mr. Fall states his brother, Mr. Ahmadou Fall, is suppose to come in at 2:00 pm this date to work. I tried calling Mr. Ahmadou Fall at the cell phone number given to me, 640-4586, but got no answer. I also talked to Mr. Tufail, via telephone. Mr. Tufail stated he wouldn't be returning to the restaurant unless it was necessary. Mr. Tufail didn't find anything else missing from the restaurant other than the money when he checked and nothing eles was disturbed. Mr. Tufail was burglarized back in April of 2005 and is not insured.

I notified (Act. Lieutenant), Sgt. Dudenhoeffer, about the burglary, and he in turn notified CIB. Sgt. Dudenhoeffer then advised me CIB would not be responding and I was to handle the investigation and file the necessary reports. I did request a B of I technician to my location and SQD 382, PO Alan Winter, repsonded. PO Winter took 5 photos of the scene. There appeared to be no chance for latenet prints as the cash register change drawer was never handled by the unknown actor(s) and nothing else was disturbed.

I contacted Judy's Red Hots by telephone about 2:30 pm in order to talk to Mr. Ahmadou Fall and was told by Mr. Papa Fall that his brother weasn't coming it until 3:00 pm. I then reached Mr. Ahmadou Fall by telephone and he stated he left the restaurant about 1:00 am. The cash register change drawer was left with \$100.00 in it inside the oven in back. Mr. Fall currently resides at 2108 W. Layton Ave. Milwaukee, WI 53204.
