Program Goals

This project seeks to build community capacity to reduce crime and disorder by establishing a network of cross-sector partners focused on developing a strategic plan for crime reduction and prevention driven by data, best practices, and input from community stakeholders. MPD has partnered with Kathleen Pritchard, Ph.D. to conduct independent research and evaluation of the targeted area. Impacting public safety serves as a tipping point for improving the 53206 zip code and surrounding area. Working in concert with the community, the overall goal is to develop a comprehensive plan to reduce crime and improve the quality of life in Amani.

Programmatic Summary

Amani is one of the most economically distressed neighborhoods in the City of Milwaukee. Located in the heart of Milwaukee's 53206 zip code, Amani has been challenged by extreme poverty, social and economic disadvantage and high rates of crime and disorder. The overall unemployment rate is 34%, and may be as high as 65% for men in some census tracts; poverty levels are as high as 62%. The violent crime rate in Census Tract 89, located within Amani is 55.5 per 1,000 compared to the citywide rate of 14.2 per 1,000 in 2015. Crime and disorder threaten the city's plans for redeveloping the 30th Street Industrial Corridor, which falls within Milwaukee's Investment in Manufacturing Communities Partnership (IMCP) designation. Amani has been a part of the White House Neighborhood Revitalization Initiative's Building Neighborhood Capacity Program (BNCP) since 2012, due to



its concentrated poverty and crime. Financial constraints impede the city's ability to undertake this project without federal funding. In cooperation with our stakeholders and partners, MPD is uniquely positioned to implement this innovative, evidence based program. MPD recently joined the Violence Reduction Network (VRN) and is considered a model for comparable cities nationwide. The proposed project provides an opportunity to assess these goals of crime reduction while improving trust and confidence in police.

The target area spans approximately 0.7 square miles from West Keefe Av to West Center St and North 20th St to the 30th Street Industrial Corridor. The population is 11,878 residents, the majority of whom are African-American (93%).
