Response to Communication File #161148 Queries

- How many properties with delinquent property taxes are owned by LLCs, and what is the total amount owed on these properties?
 - 1,356 delinquent tax parcels are owned by LLCs with \$7,469,547.99 in outstanding property taxes due as of December 30, 2016.
- Which LLCs with delinquent property taxes own multiple tax-delinquent properties?

- Which 10 LLC-owned properties owe the most in delinquent taxes, and how much is owed on these properties collectively and individually?

- Which 10 LLCs with delinquent tax balances owe the most, collectively and individually?

- How many LLC-owned residential properties has the City foreclosed upon in each of the last 5 years (2011-2015)?
 - In 2011, 126 LLC tax delinquent parcels were foreclosed upon.
 - In 2012, 136 LLC tax delinquent parcels were foreclosed upon.
 - In 2013, 127 LLC tax delinquent parcels were foreclosed upon.
 - In 2014, 110 LLC tax delinquent parcels were foreclosed upon.
 - In 2015, 194 LLC tax delinquent parcels were foreclosed upon.
- Which LLCs that currently owe delinquent property taxes have had properties foreclosed upon in the past?
 - Please reference Exhibit D attached.
- What problems does the City have in collecting delinquent taxes owed by LLCs?
 - For years, the Sherriff's Department in Milwaukee County has informed the Kohn Law Firm (KLF) that they will not execute civil bench warrants or hold defendants on the warrants. Essentially, this renders KLF contempt motions totally ineffective, as there is no real penalty for failing to appear at either the supplemental or contempt hearing. Many of the more problematic debtors are aware of this and know they can ignore the various orders to appear in Court without fear of experiencing any consequences. As an example: a defendant recently failed to appear at a supplemental and contempt motion hearing. Even after he was arrested on a bench warrant by MPD, he was immediately released by the Sheriff's Department once he was transferred to the County Jail. It is worth noting that he was released without satisfying any of the conditions attached to the warrant.
