shown. Handles will be brass or bronze and shall be the profile shown in attached image. The hinges,

if any portion of them is visible, must be in a matching finish to the handles.

Staff must approve any changes or additions to this certificate before work begins. Work that is not completed in accordance with this certificate may be subject to correction orders or citations. 






Present conditions as of November 2016. Since that time the aluminum and glass front entry doors have been shattered and damaged.
