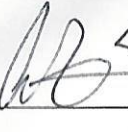
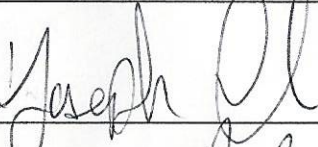
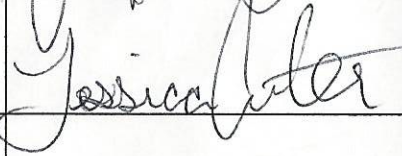


Opposition to Journey House Clark Square Apartment Complexes
