Milwaukee residents eligible under the Residents Preference Program (RPP) have performed 45.6 percent of the construction hours on the project to date.

Northwestern Mutual is committed to Milwaukee's success.





Dollar Value of Applicable Contracts Awarded



Participation Performance Report

This Northwestern Mutual Tower and Commons Participation Performance Report details Northwestern Mutual's progress toward meeting the goals of the Human Resources Agreement it has with the City of Milwaukee. In constructing the 1.1 million-square-foot expansion of its downtown Milwaukee office complex, Northwestern Mutual has agreed to:

- Use certified Small Business Enterprises (SBEs) and/or businesses certified under equivalent programs for 25.0 percent of applicable construction costs.
- Use underemployed City of Milwaukee residents via the Residents Preference Program (RPP) for 40.0 percent of the construction hours worked.
- Ensure payment of prevailing wages where applicable.

Northwestern Mutual has engaged a building design, construction and consulting team that understands the critical importance we have placed on meeting these SBE and RPP goals.

SECTION 2

OUR STORY

Northwestern Mutual has called Milwaukee home since 1859. Today, more than 4.4 million people rely on Northwestern Mutual for insurance and investment solutions.





Even our retirees give back by volunteering their time. In 1967, retirees volunteered to help tabulate United Fund campaign contributions.



In 1986, the "Girls Club" donated proceeds of a holiday raffle to local charities. This type of activity continues through a variety of employee groups.



Orphaned children living at St. Joseph's Institute benefited from our charity and compassionate employee volunteers in 1951.

We've grown up with Milwaukee as our hometown for nearly 160 years.

We are stewards of our communities by bringing together groups of people and organizations and leveraging the power of our employees, field and financial resources to improve the lives of children and families.

In December, our Northwestern Mutual Foundation awarded \$225,000 in grants to deserving nonprofits during our annual Days of Sharing. The campaign awards \$1,000 to \$10,000 grants to 25 nonprofits chosen at random from employee nominations. In addition, employees can vote for pre-selected nonprofits to receive grants totaling \$125,000. The six chosen this year are Alzheimer's Association of Wisconsin, Diverse & Resilient, Make a Difference Wisconsin, Make a Wish Wisconsin, Milwaukee Homeless Veteran's Initiative and PEARLS for Teen Girls. Since 2007, we've awarded more than \$1.3 million in grants on behalf of employees through our Days of Sharing program.

Learning and creativity were the focus in November when Northwestern Mutual welcomed 60 students from six area high schools to our Franklin campus to learn about careers in technology. Employees volunteered their time and expertise as the students learned about technology trends, innovation and cyber security. Participants gained hands-on experience through fun, interactive exercises. The day-long job shadow program, part of our continuing partnership with IT United, drew students from St. Joan Antida, Washington, Carmen, Hartford Union, Reagan and Mukwonago high schools.

Northwestern Mutual and the City of Milwaukee share an interest in promoting a healthy local business environment. Strong businesses, especially small- and medium-sized companies, are the backbone of the city's economy. They create jobs, pay taxes, and contribute to the vitality of the city.

That's why we set a goal for our downtown development to not only have an impact on our business, but to help raise the tide for many businesses in the city. Small Business Enterprises are companies with annual revenues below a stated floor and typically owned by one or more individuals who are at an educational, social, economic or other disadvantage. SBEs, including many businesses owned by minorities, women and military veterans involved in building design and construction, are an integral part of creating our Tower and Commons.



Joe Torres, after working in construction for four years, was out of work when the tile and terrazzo layers union called him about a potential marble job. He's now an apprentice tile setter working for Wisconsin Terrazzo & Tile on floors in The Tower and Commons.

Before construction, Joe worked as an over-the-road-trucker, making good money but spending too much time away from family. When he was in between trucking jobs one day, a friend who was a journeyman tile setter asked Joe to help him out. "My friend's union steward came in

to check on him the next day, saw my hustle and tried to sign me up right there," said Joe.

The former trucker headed off to the Wisconsin Regional Training Partnership/BIG STEP, where he received training and attained Residents Preference Program certification. Now his work on The Tower and Commons is helping pay the bills and giving him hope. "Wisconsin is really picking up, and there's going to be a lot of building going on here," Joe said. "If it wasn't for BIG STEP and the union, I'd still be driving a truck, so I'm grateful."



Apprenticeship Participation

Northwestern Mutual includes apprenticeship requirements in its construction contracts.

Apprenticeships combine classroom instruction with on-the-job learning while working on construction projects under the supervision of experienced journey workers. The availability of construction apprenticeships varies by trade, employer and market fluctuations.

Contractors on The Tower and Commons project are asked to maximize the number of apprentices utilized in accordance with guidelines issued by the Wisconsin Department of Workforce Development. The table below includes only those trades considered apprenticeable in the state of Wisconsin.
