

ADDITIONAL COMMENTS/RECOMMENDATIONS:

This report submitted by P.O. Thomas Kline, assigned as the Community Liaison Officer for District One. On 03/02/2017, at 11:30am, I met with Mr. Atkinson regarding his application for a Class B Tavern license for 754 N 4th Street. Also present was Community Prosecutor ADA Kelly Hedge.

Upon arrival I observed the building is attached to the north of the Marriot Hotel, and is directly on the corner of N 4th Street and W Wells Street across from the Convention Center. The main entrance to the restaurant is on the northeast corner of that location. This location is still under construction and had 10-12 workers onsite. I was not able to observe the lighting due to the current status of the interior.

Mr. Atkins will be the head chef and has worked at a different well established restaurant in the downtown area prior to this. We discussed the importance of security cameras covering the entrances and exits to the building, along with the cash stations. We also discussed the posting of his capacity. Mr. Atkins stated he will work with the Police Department if a situation arises where he can assist us.




