Communication from ANTOINETTE JACKSON

Dear Ms. Jackson:

We have received your claim for the amount of \$56,419.00 in relation to the property damage you sustained on September 15, 2016 at 4947 North 19th Street.

Our investigation determined the Department of Public Works sewer maintenance section received a complaint at 9:05 pm on September 15, 2016 reporting a sewer back up at 4947 North 19th Street. The sewer was investigated and found to be clogged with sand. A sewer Jet-Vac was used to open the clog. The sewer main was opened at 1:00 am, and to prevent further backwaters, a pumping operation was initiated to redirect the sanitary water to another manhole. The pumping operation was stopped on September 16, 2016 to perform additional cleaning, and the sewer was found to be in good condition.

Milwaukee Water Works was also notified of a possible leak in the area. A distribution crew investigated the area and confirmed a leak at 4950 North 19th Street on the owner's side of the water service lateral pipe between the curb stop box. This leak caused subsequent dumping into the sanitary sewer. The property owner was notified of the leak and given 10 days to complete the repairs. The leak was not related to Milwaukee Water Works, and the water service was shut off at this property to prevent further damage. The distribution crew also replaced the curb stop box and the city side of the lead water service lateral pipe at 4950 North 19th Street.
