Program Goals

The purpose of this grant is to fund overtime expenses for seven officers assigned to the South-eastern Wisconsin Regional Task Force. Its purpose is to identify and target criminal enterprise groups and/or individuals responsible for crimes of violence and gather intelligence and evidence that will lead to prosecution. The task force will focus on the apprehension of dangerous fugitives where there may be a federal investigative interest. Southeastern Wisconsin Regional Task Force

The Southeastern Wisconsin Regional Task Force (SWRTF) focuses on violent criminal offenders to reduce overall violent crime in the City of Milwaukee. Between 2015 and 2016, the City of Milwaukee experienced a 4% decline in total violent crime. The table below compares 2015 to 2016 totals for violent crime including homicide, rape, robbery and aggravated assault. In 2016, the Milwaukee Police Department recovered 2,419 guns within the City of Milwaukee. Furthermore, arrests for felon in possession of a firearm in 2016 was the highest in 10 years (798 arrests). The graph below includes MPD arrests for felon in possession of a firearm for 2007 through 2016.
