Data Summary:

The Milwaukee Area Violent Crime Task Force works to lower the levels of violent crime throughout the City of Milwaukee. Between 2015 and 2016, the City of Milwaukee experienced a 4% decline in total violent crime. The table below compares 2015 to 2016 totals for violent crime including homicide, rape, robbery and aggravated assault.

The violent crime map includes distinct incidents of homicide, rape, robbery, and aggravated assault for the time period of January 1st-December 31st, 2016. Density layer illustrates concentrations of violent crime incidents per square mile. Darker red shaded areas represent higher concentrations of violent crime. Violent crime is concentrated in specific areas within the City of Milwaukee. The Milwaukee Area Violent Crime Task Force works to reduce levels of violent crime in these areas specifically.
