In accordance with the provisions of Section 320-21 (11) and (12) of the Milwaukee Code of Ordinances, the Milwaukee Historic Preservation Commission has issued a certificate of appropriateness for the work listed above. The work was found to be consistent with preservation guidelines. **The following conditions apply to this certificate of appropriateness:** 

- 1. Violations relating to the sidewalk vault are not included in this mothball certificate. These violations are to be independently and expeditiously addressed directly with DNS staff.
- 2. The owner must obtain a Certificate of Appropriateness for all work that affects the exterior including retroactively for any emergency repairs already completed.
- 3. Any replacement windows must be wood and applicant must provide a bid for restoration of existing windows to HPC staff before replacements will be approved.
- 4. Applicant must make a progress report to the Historic Preservation Commission's December 2017 regularly scheduled meeting and every six months thereafter until project completion and at project completion.

All work must be done in a craftsman-like manner, and must be completed within one year of the date this certificate was issued. Staff must approve any changes or additions to this certificate before work begins. Work that is not completed in accordance with this certificate may be subject to correction orders or citations.
