- 3. Pursuant to Chapters 68 and 85 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation.
- 4. On May 9, 2017, the City Clerk's Office provided notice to the Licensee pursuant to Chapters 68 and 85 of the Milwaukee Code of Ordinances of the police report and neighborhood objections and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on May 16, 2017 at 2:30 p.m. in Room 301B of the third floor of City Hall. - 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- 2. An application to renew said licenses was filed with the Office of the City Clerk on April 12, 2017.
- 3. Pursuant to Chapters 68 and 85 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation.
- 4. On May 4, 2017, the City Clerk's Office provided notice to the Licensee pursuant to Chapters 68 and 85 of the Milwaukee Code of Ordinances of the police report and neighborhood objections and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on May 16, 2017 at 9:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee did appear and was represented by Attorney Joshua Gimbel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Robert Theunis, 1315 South 87<sup>th</sup> Street, West Allis, WI stated issues are being addressed. Vandals drove through front door requiring repair to front entry. Theunis acknowledged issues with trash and maintaining the fence around the dumpsters; increased cleaning schedule; vacant parking lot with accumulations of trash; management team has been changed; new manager has been there approximately 10-weeks. This is the second store manager in the last year; turnover went from 180% to 60%.; assistant mangers were promoted from within the store.



- B. Dameon Ellzey, 15<sup>th</sup> District Legislative Assistant, stated Alderman Stamper has concerns about the cleanliness and the constant inconsistency in requested improvements. There are frequent changes in management which makes it difficult to hold the store accountable for requested changes and improvements. Specific issues include: fencing around the garbage, damage to front door, exits being blocked, cleanliness, and aisles not cleared. He wants to recommend a 10-day suspension.
- C. Attorney Gimbel stated that a warning letter would be more appropriate.
- D. Ald. Lewis moved for 10-day suspension based on aldermanic testimony.

- D. Ald. Zielinski moved to reconsider the previous recommendation.
- E. Ald. Rainey moved for 10-day suspension based on neighborhood and aldermanic testimony.

## FINDINGS OF FACT

1. Ural P. Jackson, Jr. (hereinafter "the Licensee") is the holder of a Class "B" Tavern, Food Dealer, and PEP Licenses for the premises located at 731 North Water Street in the City and County of Milwaukee, Wisconsin ("Good Life"). Said licenses expire at midnight on June 20, 2017.

- 2. An application to renew said license was filed with the Office of the City Clerk on April 10, 2017.
- 3. Pursuant to Chapters 68, 85 and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On June 16, 2016, the Milwaukee Police Department responded with a report that could from the basis for renewal of said license.
- 4. On May 5, 2017 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 68, 85 and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on May 16, 2017, commencing at 1:45 p.m. in Room 301A of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was represented by Attorney Emil Ovbiagele.



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Stacy Calise, Westown Association, 224 East Mason Street stated that Mr. Hinton has violated the affidavit and she has witnessed trash, bottles, fighting, and illegal parking, though she has not seen the people involved in these incidents come out of Good Life. She stated that the business has not been open in the morning for breakfast as advertised.
  - B. Malita Brown, N66 W15498 Raven Way Drive, Menomonee Falls, WI, Representative for Hertz Investment Group; Senior Property Manager for 100 East Wisconsin Avenue. After repetitive repair of the parking gate and manipulation the gates have to be replaced ahead of their normal useful life of 5 to 7 years. She added that she has added staff to monitor pay stations on Thursday and Saturday nights and may have to add a third security officer to the 3<sup>rd</sup> shift detail. The reputation of the Good Life is that of a night club rather than a restaurant due to the incidents. She has also witnessed broken fire extinguisher cabinets in the parking garages. Ms. Brown mentioned that other businesses have purchased parking validations for their customers but Good Life has not.
  - C. Debbie Tomczyk, Downtown Bid 21 stated the group is in opposition.
  - D. David Hinton, III, 606 South 5<sup>th</sup> Street stated steps were taken to address the noise issues and there is never a live Disc Jockey. Instead they use a customized play list. He stated that they have disciplined and fired employees that fail to follow policies and rules and that the establishment will be remodeled with smaller speakers.
  - E. Sheldon Oppermann, 735 North Water Street stated Mr. Hinton is a good tenant. He is working with Mr. Hinton to improve the business and facilitate its conversion to more of a restaurant. Mr. Oppermann stated that he has visited Good Life on Thursday and Saturday nights, including during closing, and was not concerned with anything he witnessed. As the landlord, he also has staff in the building 24 hours a day, but stated that no one has informed his staff or called him about issues regarding Good Life or its patrons. He also shared that he has not seen a DJ or observed people dancing in the establishment.
  - F. Ald. Bauman stated he will support a suspension based on the police report. Ald. Bauman will challenge the ruling of the Committee on the Council floor.
  - G. Ald. Perez moved approval with 10 day suspension based on neighborhood, Aldermanic, applicant testimony and police report. The motion failed.
  - H. Ald. Rainey moved approval with a warning letter based on neighborhood, aldermanic and applicant testimony, and the police report.
  - I. Ald. Bauman stated he does not agree with the action of the Committee and will object at Council.

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 68, 85 and 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Ural P. Jackson, Jr., has not met the criteria to allow renewal of his Class "B" Tavern, Food Dealer, and PEP licenses without the issuance of a warning letter.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern, Food Dealer, and PEP licenses of Ural P. Jackson, Jr. for the premises located at 731 North Water Street in the City and County of Milwaukee, Wisconsin ("Good Life") with a warning letter based upon the police report, neighborhood, aldermanic and applicant testimony.

# RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, and two (2) noes and recommends that the Class "B" Tavern, Food Dealer, and PEP Licenses of Ural P. Jackson, Jr. for the premises located at 731 North Water Street ("Good Life") in the City and County of Milwaukee, Wisconsin be renewed with a warning letter.
