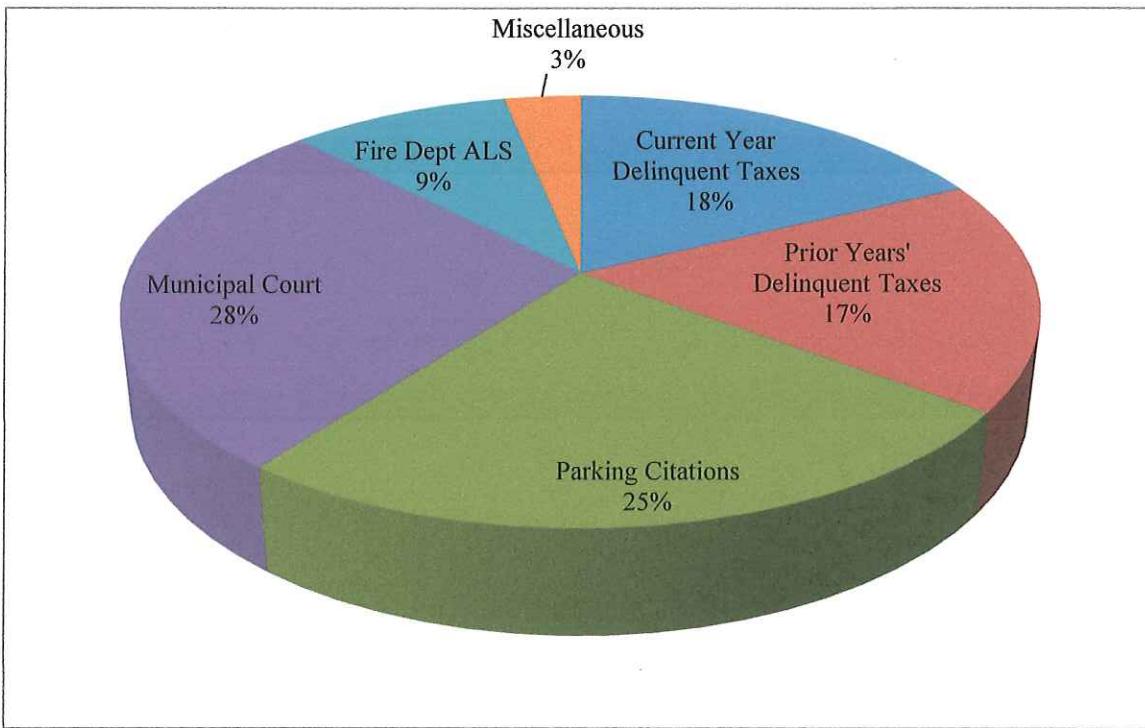
## **Introduction**

The Comptroller's 2017 Report on Outstanding Receivables as of December 31, 2016, (unaudited) is being issued as required by Ordinances 304-3-3 and 304-1-5. Ordinance 304-1-5 requires the Comptroller to submit an annual report analyzing delinquent outstanding debt. Sections II through V of this report provide summary information on City outstanding receivables including Delinquent Taxes, Parking Fund Citations, Municipal Court Judgments, Miscellaneous Accounts Receivable, and the Fire Department Advanced Life Support (ALS) Billings.

Ordinance 304-3-3 requires the Comptroller to submit an annual report listing all cancellations and adjustments of City claims. Section VI of this report presents account cancellations and adjustments for 2016.

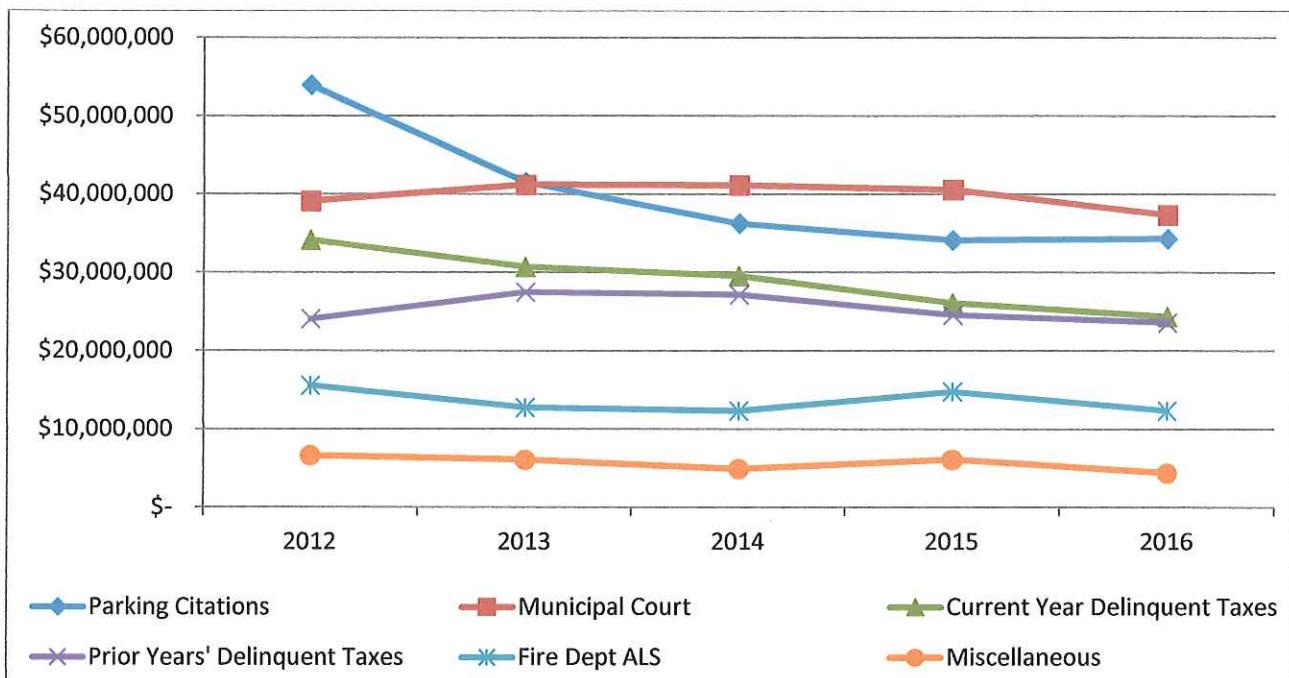
Resolution 160845 directs City departments to provide annual collection rate data to be included as an appendix to the Comptroller's annual Outstanding Receivables report. Section VII of this report presents collection rate data provided by City departments for 2016.

## Outstanding Receivables as of December 31, 2016



Outstanding receivables for the City of Milwaukee as of December 31, 2016, total \$136.4 million. The largest category of outstanding receivables is Delinquent Taxes, totaling 35%. Current Year Delinquent Taxes (2015 taxes for 2016 purposes) account for 18% of this total, while Prior Years' Delinquent Taxes (2014 taxes and prior) total 17%. Municipal Court outstanding judgments and Parking Citations are the next largest categories, 28% and 25% respectively. Fire Department Advanced Life Support (ALS) Billings total 9% while Miscellaneous Accounts Receivable is the smallest category totaling 3%.

## Outstanding Receivables at Year End 2012 – 2016



\*Fire Department ALS Billings totals include Intermedix and Harris & Harris reporting.

Outstanding receivables, by category from 2012 through 2016, are shown in the chart and table above. Total 2016 receivables decreased \$9.8 million compared to 2015.

Current year delinquent taxes decreased \$1.7 million from 2015 to 2016, a continual decline since 2012. Prior years' delinquent taxes also decreased \$976,000 from 2015 to 2016.

Municipal Court receivables decreased \$3.2 million from 2015 to 2016. Municipal Court has experienced a continual decline since 2013.

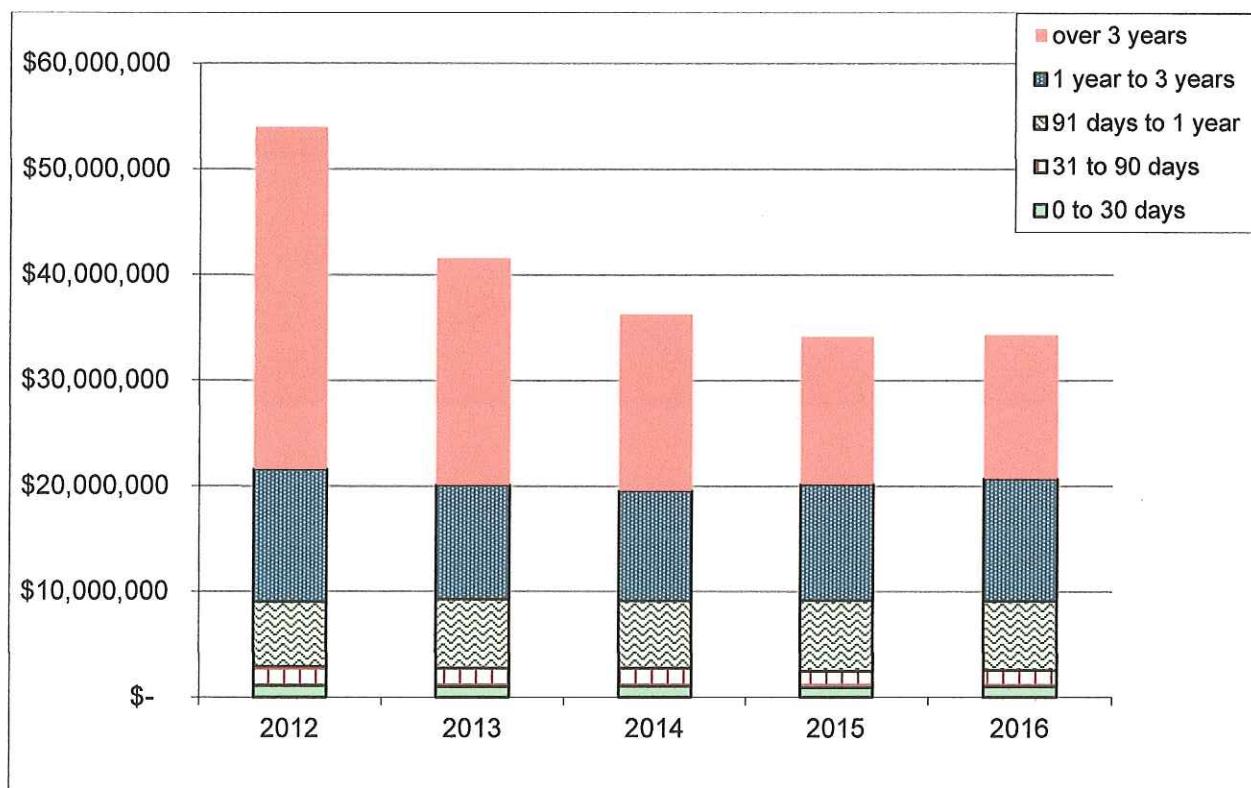
Parking citations decreased from \$53.9 million in 2012 to \$34.3 million in 2016, a \$19.6 million drop. This reduction is due mostly to the write-off of uncollectible receivables along with the use of the State Tax Refund Intercept Program (TRIP).

The balance of Fire Department ALS billings decreased by \$3.2 million between 2012 and 2016. This decline is due to the on-going coordination between the Fire Department, Intermedix and the collection agency of Harris and Harris.

Miscellaneous accounts receivable, which includes billings from various general city departments, decreased \$1.7 million from 2015 to 2016.

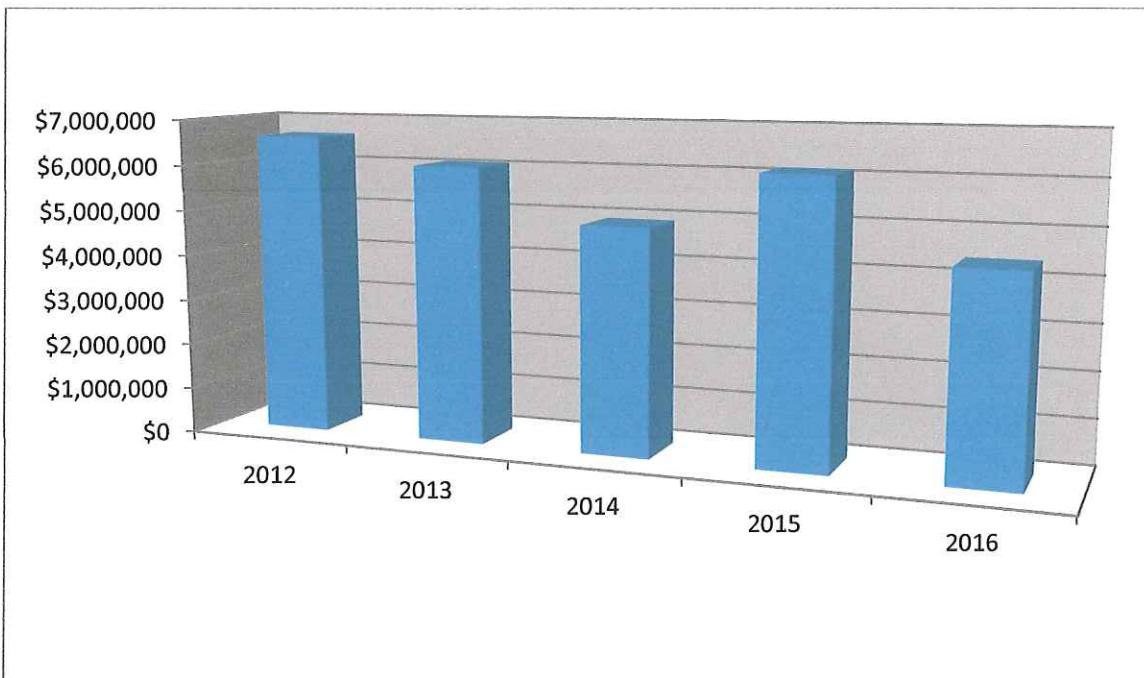
The Parking Fund writes off delinquencies that are six years or older, due to the statute of limitations rendering these uncollectible. Miscellaneous receivables and tax delinquencies of \$5,000 or more may be cancelled or adjusted through Common Council action. An interdepartmental process is followed for delinquencies less than \$5,000. Municipal Court judgments are settled either through cash fines, jail time or community service. Judgments that are at least seven years old, and meet City Attorney criteria, may be written off pursuant to Common Council resolution authorizing such write-offs.

### Parking Citation Receivables Aging



The chart above shows the aging of parking citation outstanding receivables from 2012 to 2016. Of the current outstanding balance, \$25.2 million or 73%, has been outstanding for one year or longer.

The above chart and table show the change in outstanding Miscellaneous Accounts Receivable (MAR) by year for various City departments. MAR includes a variety of billings, such as damages to City property, leasing of City property, and employee health care costs to non-City agencies such as the Wisconsin Center District. In total, the year-end balance for outstanding MAR decreased \$2.2 million from 2012 to 2016.

The table above shows the 2015 year end balance and the current year changes to the MAR by City departments. In 2016 City departments billed \$17.4 million and received payments of \$17.6 million. The total write offs and adjustments account for a decrease of \$1.5 million.

Write offs can be grouped into three categories; uncollectible, billing errors and rebilled. Accounts deemed uncollectible are due to bankruptcy, the cost of litigation exceeding the balance, attainment of a judgment, settlements, and the account being over 7 years old. Billing errors include wrong amount billed, incorrect responsible party and payment made in full prior to issuance of invoice. Adjustments are associated with prior year accounting entry errors.
