FINDINGS OF FACT

1. Don L. Taylor (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, December 31, 2008.
2. An application to renew said license was timely filed with the Office of the City Clerk on October 21, 2008.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On October 22, 2008, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On November 19, 2008, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on December 5, 2008, commencing at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On July 4, 2007 the applicant was charged by Milwaukee County Circuit Court for battery and bail jumping. He was

found guilty of these two charges on January 8, 2008 and sentenced to the House of Corrections and put on 18 months probation.

- B. On September 3, 2007 the applicant was charged by Milwaukee County Circuit Court for disorderly conduct and found guilty put on 18 months probation on January 8, 2008.

CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the licensee, Don L. Taylor, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license without undergoing a ten (10) day suspension based upon the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Don L. Taylor with a ten (10) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes and two (2) excused, recommends that the Class "D" Bartender License be renewed with a ten (10) day suspension denied based upon the police report.

Said suspension is to be in effect from 12:01 a.m. on January 1, 2009, through midnight, January 10, 2009.

- B. The applicant has a warrant with Milwaukee Municipal Court for a building and zoning violation in the amount of \$320.00.





Box 342603, Milwaukee, Wisconsin, 53234 is the address given by the Licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on December 5, 2008.

- B. On November 5, 1994, officers of the Milwaukee Police Department were dispatched to 3235 West Scott Street, where the applicant was the licensee. The complaint was of loud music. Upon arriving, officers observed the rear door open and could hear loud music. The door was closed before officers could enter. Officers found approximately 200 persons on the premises, which had a capacity of 80. There was no placard posted. Some underage persons were observed on the premises, consuming alcoholic beverages. The licensee, Vickey Mendez, was issued a citation for posting of occupancy capacity and found guilty on December 22, 1994 and fined \$330.00. Licensee was also charged with presence of underage person on Class "B" premises (licensee responsibility) and the warrant refused by City Attorney when subject paid the companion ticket on November 23, 1994.
- C. On January 30, 1995 at US-45 and Hampton Avenue, a Milwaukee County Deputy Sheriff arrested the subject for operating a vehicle under influence of an intoxicant. The complainant told the officers the bar is a nuisance to the neighborhood every weekend, "The music is so loud, it keeps the neighbors awake at night. The patrons of the bar

also throw their empty beer bottles on neighbor's lawns." He said he has tried to work things out with the bar but they become hostile. The officer spoke to the applicant, who stated she didn't think the music was loud at that time. She also stated she did not talk to anybody "tonight" regarding the music. She thinks the neighbors keep calling the police because of their race. "They are Mexican and the neighbors don't like them." The licensee was issued a citation for noise nuisance and found guilty of this citation on February 6, 2003 and fined \$50.00.

- E. On October 6, 2002, officers of the Milwaukee Police Department were sent to a shooting at 3235 West Scott Street, The Last Chance Bar. Officers found a male shot in the back who stated that he did not know who shot him. The licensee was on the premise and cooperated in the police investigation.
- F. On April 5, 2003 at 8:20 p.m., an underage Milwaukee police aide entered The Last Chance Tavern at 3235 West Scott Street at the direction of Milwaukee police officers. The aide was able to purchase a 12 ounce bottle of Miller Lite Beer from the bartender. The licensee, Vickey Mendez, was issued a citation for sale of alcohol to underage person which was dismissed without prejudice on August 29, 2003. The bartender was issued a citation for sale of alcohol to underage person and found guilty on June 3, 2003 and fined \$150.00.
- G. On February 3, 2006, the licensee was cited by Milwaukee Police Department for presence of minor prohibited, which was dismissed without prejudice on June 13, 2007. This item was previously considered, but the disposition was added on October 21, 2008.
- H. On July 28, 2008, the licensee was cited by Milwaukee Police Department for noise nuisances which was pending a pretrial on November 5, 2008.
- I. On July 29, 2008, the licensee was cited by Milwaukee Police Department for licensed premises-safe egress required which is pending pretrial on November 5, 2008.
- J. On August 23, 2008, the licensee was cited by Milwaukee Police Department for noise nuisances, which are pending pretrial on November 21, 2008.



Re: Report on the Renewal Application of the Class "D"
Bartender License of Tyrone C. Winters

FINDINGS OF FACT

1. Tyrone C. Winters (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, December 31, 2008.
2. An application to renew said license was timely filed with the Office of the City Clerk on September 25, 2008.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 26, 2008, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On November 19, 2008, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on December 5, 2008, commencing at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Tyrone C. Winters, 5279 North 35th

Street, Milwaukee, Wisconsin, 53209 on November 19, 2008 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 5279 North 35th Street, Milwaukee, Wisconsin, 53209 is the address given by the Licensee on his application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on December 5, 2008.

- B. On February 4, 1999, the applicant was arrested by Menomonee Falls Police Department for possession of a controlled substance for which he was found guilty on March 18, 1999 and an undisclosed fine imposed.
- C. On April 10, 2006 at 12:00 a.m., the applicant was cited under the name of Winters, Tyrone C., by City of Milwaukee for building code violations at 3916-3918 North 17th Street.


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the licensee, Tyrone C. Winters, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance, and the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Tyrone C. Winters based upon nonappearance, and the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes and two (2) excused, recommends that the Class "D" Bartender License be denied based upon nonappearance and the police report.

Shorewood Municipal Court


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the licensee, Shermica E. Young, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance and the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Shermica E. Young based upon nonappearance, and the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes and two (2) excused, recommends that the Class "D" Bartender License be denied based upon nonappearance, and the police report.
