## BHD FUNDING UPDATES – Relevant to City County Heroin, Opiate, Cocaine Task Force (CCHOCTF) and Alignment with CCHOCTF Work Plan July 21, 2017

**Stage One proposal to the 2017 WPP Community Impact Grants Program**. "Addressing the Opioid Crisis" proposal submitted by BHD was not chosen to move forward to Stage Two of the 2017 Community Impact Grant review process. 23 competitive proposals were submitted; 6 chosen to move forward. Comments offered by reviewers will be available by July 31.

## Family Treatment Drug Court (SAMHSA, 2017-2022; \$2,124,441) was awarded on July 12,

**2017.** Treatment Service Enhancements for the Milwaukee County Family Drug Treatment Court (MCFDTC) will be provided to address gaps in the treatment continuum for court involved individuals who need treatment for a SUD and/or co-occurring SUD and mental disorders while simultaneously addressing the needs of their children. Treatment services address the needs of the family as a whole and include direct service provision to children (17 and under) of individuals served by MCFDTC. Project objectives are focus on increasing access to and utilization of services that promote parent child bonding; providing access to regular clinical consultation to the MCFDTC team; increasing access to screening and in-home assessments for children; and transitioning MCFDTC clients and their children to Comprehensive Community Services (CCS) for continuity of care.

- More than one-half (54.9%) of MCFDTC clients report opiates as their primary drug of choice (<u>The Life We All Deserve</u> PowerPoint Presentation, Honorable Mary E Triggiano and Rebecca Foley, JD/MSW, March 24, 2015).
- CCHOCTF Work Plan, Goal D. Enhance and broaden the continuum of care for substance use disorder throughout the county.
- CCHOCTF Work Plan, Goal F. Enhance collaboration between community-based initiatives and government agencies.

## Opioid Crisis State Targeted Response Program Funding Request (July 1, 2017 – April 30, 2018; \$505,639) was awarded on July 13, 2017.

**Submitted June 14, 2017.** State Targeted Response (STR) to the Opioid Crisis Grant funding from the Department of Health Services (DHS) Division of Care and Treatment Services (DCTS) for the purpose of decreasing waitlists, service denials, or other unmet needs for individuals seeking treatment services for an opioid use disorder. Milwaukee County was identified as a high-need area. Over a ten-month period from July 1, 2017 – April 30, 2018, comprehensive treatment and recovery support services for opioid use disorders will be provided to individuals currently on the AODA transitional residential waiting list for whom opioids are the primary drug of choice (including IV drug users); and additional individuals with unmet needs (needing but not receiving opioid treatment). Draft service descriptions are currently under review by the MCBHD Chief Medical Officer to ensure access to Suboxone and Methadone as two additional MAT medications by the second year of the grant award.

• Residential Treatment Waiting List, n=240. 75 (31%) identify Opioids as Primary Drug of Choice at intake, 46 (61%) of whom are IV Priority (Program Participation System – PPS data set, June 9, 2017).
