5. **DESCRIPTION OF PROJECT:**

Restoration of the front entry portico base. The work includes demolition and infill of the existing hollow plinth.

The new portico floor will be 8" of concrete with heating coils embedded in the top 3". The hollow plinth is infilled with rigid insulation topped by a 5" structural concrete base and a 3" topping of red tinted concrete.

The granite stairs will be removed, cleaned and set on existing stringers with heating coils installed underneath the treads.

The Lake Superior Red Sandstone column bases and a portion of the fluted column is replaced like for like matching the existing profiles. This is necessitated by salt damage to the stone bases.
