Milwaukee's Historic Preservation voted to approve the Temporary Historic designation on April 24, 2017. The Temporary Historic Designation expires on October 20, 2017.

Milwaukee's Historic Preservation Commission voted to recommend Permanent Historic designation on May 15, 2017.


This building served as the brew house then malt house for Gettelman and was reconfigured over time into offices




This portion of the brew house/malt house shows original features at the first and second stories



In 1856 George Schweickhart purchased the foundations of a brewhouse and a beer lagering cellar (1854) and constructed the residence, the above ground structures you see in the photo and built a second lagering cellar. Both cellars are extant today.




Adam Gettelman 1847–1925 Adam Gettelman worked for George Schweickhart, married his boss's daughter then became owner. He renamed the brewery the A. Gettelman Brewery in 1885 and officially incorporated on March 17, 1887.




The brewhouse was enlarged and converted to malting. Other related buildings like a stock house were added to the complex by the time this image was created. The Schweichart House was lived in by the Schweicharts as well as the Gettelmans. Other brewers like Pabst, Blatz, Schlitz and Miller also lived right among or near their breweries. All the others are gone.

The Watertown Plank Road completed in 1853 opened up the valley area to development.








The complex as depicted in 1892. Like many views of manufacturers at this time period, some artistic license was taken with the buildings.




The brewery in the 1920s-1930s

Note the malt house adjacent to the house with its foundation and windows and the one and a half story wing at the rear (left) of the house





A remodeling in 1948 resulted in the front entry being located facing State Street. A new porch was built at this entry.



By 1951 the entry porch had been enclosed.








Map of Gettelman in 1937. Buildings with an "X" have been demolished.






