

I am the home owner in your district, located at 4327 N. 75th Street. The City of Milwaukee began a construction project some months ago where sidewalks were replaced. In preparation for their jobs, the removed portions of the grass in front on my home. I am very dissatisfied with the work that has been done and frustrated with the delay in replacing/repairing the portions of my lawn they removed. I started by contacting the Department of Public Works for answers regarding the completion of the project. I contacted them several times, yet to receive a call back from a project manager. This led me to contact your office. I have contacted your office over the past several weeks and spoken with your legal assistant Michael. He informed me that the city is working to complete the project "soon". One day this week I observed some men looking at my lawn and various neighbors lawns. I also noticed that they worked "one day" this week, replacing dirt to some of the lawns.
