## ATF Firearms/Violent Crimes Impact Team (VCIT) 2016/2017

#### Data:

During the 2017 federal fiscal year, MPD CGIC assigned eight police officers/detectives to work on the Violent Crimes Impact Team (VCIT). The focus of VCIT was placed on the reduction of gun violence in neighborhoods impacted by high percentages of violent crime. VCIT members worked within the Crime Gun Intelligence Center. Between January I<sup>st</sup> and September 30<sup>th</sup>, 2017, the VCIT initiated 645 investigations based on NIBIN investigative lead developments. VCIT investigations resulted in the following accomplishments: 66 arrests, seven (7) firearms trafficking investigations, three (3) straw purchase investigations, 30 issued warrants for suspects, 20 residential search warrants, 28 other search warrants, 140 witness interviews, and 143 photo arrays. The VCIT made 76 referrals to the Milwaukee County District Attorney's office for state criminal charges and eight (8) referrals to the United States Attorney's Office for federal criminal charges.
