This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/11/2008 the applicant was charged in Milwaukee County with Possession of THC §961.41(3g)(e).

Charge:Possession of THCFinding:GuiltySentence:2 days house of correctionDate:09/17/2008Case:2008CF002959

2. On 11/12/2016 Milwaukee police were dispatched to a fight/subject with a gun complaint at 634 West North Avenue. Investigation revealed there had been a fight inside the bar and all the involved parties were pushed outside. A gunfight ensued, during which several rounds were fired into the air and two subjects chased each other while firing weapons. One round struck a vehicle. The armed security guard told officers that "shooting in the air and at people was not a danger towards anyone" so he didn't take action during the gun battle. Milwaukee police incident report # 163170011 filed.

- 3. On 09/29/2017 at 2:35am officers observed cars parked in the bus zone in front of 634 W. North Av. The officer began issuing parking citations and the owners began moving their cars. The officers attempted to speak with owner of the tavern at 634 W. North Av but as they approached they heard the door being locked. The officer looked in the window and observed several people hide behind the bar. On 10/05/2017 the officers spoke with Terence SMITH, the bar manager. He stated he was aware of the incident. He was advised they could not lock the bar in an attempt to keep officer out. The officers checked the posted licenses which stated their closing hours were 1:30am Monday through Saturday.
- 4. On 10/13/17 at 6:15pm officers responded to Levels on North Bar (634 W North Ave) regarding a complaint that the establishment was open even though their license was expired. Upon arrival officers observed the open sing on and people inside the establishment with drink in their hands. Officers spoke with a bouncer and advised him that the bar was no supposed to be open. The bouncer called the owner by phone and explained the situation. The owner stated he didn't know the license was expired and stated he would comply and close the business.
- 5. On 10/17/17 at midnight officers conducted follow up regarding Levels on North Bar being open for business when their license was expired. An officer drove past the business and found it to be closed. The officer received an email from Terence Smith, the manager, asking why they could not be open. The officer responded by email explaining the Class B Tavern license was expired and the application for a provisional license was denied. Smith responded to the email stating he would comply and that they would be doing some remodeling until the license was renewed.

This police report is typed by PO Michael LEES, assigned to the Fifth District, Power Shift.

On Friday, November 12, 2016, while assigned to squad 5448, I along with my partner PO Kyle GRAF, were dispatched to a Fight/ Subject with gun complaint at 634 W North Av, which is located in the city and county of Milwaukee, Wisconsin.

Upon our arrival, PO GRAF, had spoke with Security Officer Vincent ASHFORD, who stated that they had a fight between females inside Level S On North tavern, and they had pushed everyone outside in front of the establishment. ASHFORD stated the fight had escalated and several fights had broken out. A subject described as a B/M wearing a white t-shirt, red pants, dreads had gotten hit with a unknown object causing him to sustain injury. ASHFORD states that this same subject had gone to the corner of N. 6th St and W. North Av, retrieved a gun walked back towards the bar and stated, "I'm going to shut this motherfucker down!!!!!" ASHFORD states the subject fired several rounds into the air at first between the bar and a closed business next door and then walked in the gangway and pointed the gun at another subject. ASHFORD states, a gun battle erupted and both were chasing each other while shooting at one another. ASHFORD who is an armed security guard, stated that he had his gun out at his side. He further stated, "shooting in the air and at people was not a danger towards anyone," so he didn't do anything when the gun battle was going on. ASHFORD was indicating that he didn't fire his gun.

We then discovered several spent casings in between the buildings. One round had struck a parked vehicle which was located in the back of the building. The auto a 2007 GMC Yukon, tan in color, bearing WI plate, 713sfp, listed to David STOKES, (B/M, 10/16/79, of 2873 N 39th St). I had then asked ASHFORD if he knew who owned the auto. ASHFORD stated he didn't, but the owner of Level S On North, Jeffrey HENDERSON(B/M, 05/26/78) stated that "was his cousin." I asked HENDERSON if he knew where STOKES was and he replied, "he got into a car with a bunch of people, that he knew about his auto being shot up, and it wasn't a big deal, he'd be okay" he stated.

I asked HENDERSON if he knew what happened, he stated that their was an incident inside with girls, they were arguing and fighting, everyone was pushed outside and he was inside but heard shots fired. I asked HENDERSON to review his cameras at which point he stated the cameras were not working.

I advised our tavern squad, PO David LETTEER of this incident, and was informed that he personally knows the cameras to be working from a prior incident which occurred within the month from an incident not related to this tavern in which he helped get them back running.

This report is written by PO Russell MACRAE assigned to District 5 - LATE POWER TAVERN CAR

On 10-05-17 at 10:30pm, PO David LETTEER and I conducted a Tavern Check at 634 W North Ave (LEVEL'S on NORTH Bar) regarding follow-up from 09-29-17.

On Friday 09-29-17 at approximately 02:35am, PO LETTEER and I observed many patrons' vehicles parked in the bus zone in front of 634 W North Ave. We began to issue parking citations to the vehicle illegally parked. While doing so, the owners of the vehicles began to move their vehicles to leave.

Due to our cooperative relationship with the bar's owner in the past I attempted to go speak with him regarding the parking issue. While walking up to the front door, I observed the noise of the door being locked and observed the interior lights immediately turn off. I shinned by flashlight in the windows and observed 3-4 subjects immediately dive to the ground behind the bar in an attempt to hide from police. The bartender identified as Andrea P. TAYLOR (B/F 03-10-1988) was standing outside waiting for her ride to go home. I informed her to notify her boss that we would be back to speak to the owner regarding this violation.

On 10-05-17 at 10:30pm, PO LETTEER and I made contact with the working bar manager on site identified as Terence J. SMITH (B/M 10-19-1987). I informed SMITH of the incident from 09/29/2017; SMITH stated that he was aware of the incident. We informed SMITH that the tavern was NOT allowed to lock the front door in an attempt to keep police from entering. SMITH stated that he was present on that day, however had left at approximately 02:30am and later came back after police were gone due to leaving his cell phone.

We informed SMITH of the stiff consequences of future violations. SMITH stated that he understood and would be more proactive to ensure that there were no future issues. SMITH stated that he had recently taken over as "Manager" and was still learning his role functions. We informed SMITH that it was the responsibility of the tavern to ensure that their patrons did not park in the bus zone outside their establishment as well. We offered the idea to have their licensed/armed security staff stay after bar close and ensure during bar hours that no one parked in the bus zone as well. SMITH stated that the problems would be taken care of. PO LETTEER and I then checked the tavern's licenses and discovered that their closing hours for their Class-B License were Sun 12:00pm-01:00am/Mon-Sat 02:00pm-01:30am.

I informed SMITH that we would also be contacting the owner identified as Jeffrey L. HENDERSON (B/M 05-26-1978) regarding the incident on 09/29/17 and our contact with him (SMITH) tonight.

This report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Tavern Squad.

On 10-17-17 at or about midnight. I drove by the licensed premise, Level's On North Ave., in order to see the tavern was open or closed. The Tavern should be closed due to their Class B Tavern license having expired and the owners application for a provisional license was denied. The premise has a licenseing committee hearing on October 24th, 2017 at 9:45 a.m.

The premise was closed and not open for business. It should be noted I did receive an email from the "Manager", Terence SMITH (b/m 10-19-87) asking why they could not be open.

I replied to SMITH by informing him that when we were last in the bar, we informed him that the license was going to expire on 10-11-17. I informed SMITH, in the email, since the Class B Tavern license exipred, they could not be open. I also informed SMITH that the application for a provisional license was also denied. SIMTH or the licensee, HENDERSON would have to wait until the 24th of October to have a license provided or reinstated.

I did received a follow up email from SMITH informing me that he appreciated the information on the license. He stated while closed, they will be doing some remodeling in the bar and that we may see people going in and out of the bar while this was going on. I also informed SMITH that if we did observe people coming in and out, we would check on them to make sure there were no problems.

I attempted to send my email to the owner, HEDERSON, but the email listed in LIRA came back as an invalid email from Gmail.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 10/24/2017 at 9:45 AM, in Room 301-B, Third Floor, City Hall. If you wish, you may provide testimony at the hearing regarding the request; see below for further information. You are not required to attend the hearing. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing. Please review the information below and if you have further questions regarding this process, please contact the License Division at (414) 286-2238.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


