N. 22nd St. – W. Stark St. to W. Fairmount Ave. (WT410160684) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$170,000). The total estimated cost for this project including the requested amount is \$185,000. This project is anticipated to be completed during the 2018 construction season.
