There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

My name is also known as Im writing today to file a complaint of discrimination against Ugly's night club located at 1125 N Old World 3rd St. On Friday September 15, 2017, me and a friend also known as attempted to enter the tavern. We was refused entry because the bouncer at the door said couldn't have his custom made teeth in his mouth. Im curious as to why licenses keep getting granted to these establishments like Ugly's but they constantly discriminate against minorities simply looking for a place to enjoy themselves.

I asked another bouncer present as to why he couldn't enter and the only reason given was because he had a grill in his mouth. Not because our clothes were baggy, not because we were irate at the door, or being disgruntle. In fact the ONLY reason the bouncer saw his teeth is because i opened his mouth and said "Hey how are you doing, I hope you're evening is going well tonight". I wonder if they ask every customer to open their mouth and show their teeth. To my knowledge these are the same group of owners of NOVO, an establishment that was getting ready to do a young professional urban night with a promoter I know very well and the day of the event they slapped a sign on the door that said no neck or exposed tattoos, gold chains, and other restrictions.

This is one of the many cases where someone of color was refused entry for a very ridiculous reason. I'd like to know when their next license hearing is so we can be present. I would also love to know if there is legislation that can be put in place to hold businesses accountable, or to prevent things like things from happening in the future. Unfortunately Ugly's isn't the only culprits of these terrible practices. I truly look forward to your response and would like to thank you all for your committed hard work in representing your individual respected districts.

My profession has taken me to countless of , also known as My name is establishments around the world and I can honestly say I've never been treated so unfairly when frequenting downtown Milwaukee clubs. Therefore, I'd like to take this opportunity to bring to the Licensing Committee attention a situation of discrimination I encountered on the evening of September 15, 2017 at Ugly's Night Club located at 1125 Old World Third Street.

I can appreciate a dress code and a standard in which it is upheld, what I can't understand is how this same code is also used to denied access for reason outside of this code. I simply asked how the bouncers night was going and in return told me I could not enter Ugly's with custom made teeth. I wasn't denied access because I was wearing a hat, out of dress code, or drunk and belligerent. I was being polite and friendly and still denied entry. Being discriminated against is embarrassing and disrespectful and should not be allowed. Night clubs that participate in this type of discrimination should be held accountable and action be taken.

Myself as well as other minority members of this community are greatly concerned of the treatment displayed and this cannot be supported. This is just one of countless examples of how minorities are being treated and for a very ridiculous reason and for that reason I ask that this matter is given immediate attention.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/27/2015, Milwaukee police responded to a complaint of loud music at Ugly's tavern (1125 North Old World Third Street). The officer was advised that the caller lived two blocks away and the bass from the music being played on the rooftop of the business was shaking his residence. The officer spoke to the caller and then did follow-up by checking CAD calls and found there had been eight calls for noise nuisances made from 09/16/15 to 12/27/15. On 01/09/16 the officer met with the caller, Mr. Kapella at his residence, 1113 North Edison to listen to the problem firsthand. The officer could faintly hear music being played while inside the residence. The officer went out onto the balcony and determined the music was coming from Ugly's. On 01/15/16 the officer met with the bar manager, Thomas Little to discuss several complaints of loud music emanating from the business by area residents. The officer reviewed the business license which stated "No music on exterior terrace". The officer stated there was uncertainty as to which portion of the terrace was considered exterior. The officer advised Little to adhere to Milwaukee ordinance 108-23(1)(b) pertaining to Outdoor Public Entertainment. While on scene, at 11:23pm, the officers received a complaint of loud music coming from the tavern. At 12:00am Little stopped the rooftop music and at 12:16am Kapella made complaint of loud music coming from the rooftop. Kapella was advised the music on the roof top had ceased at midnight, but he insisted that the bass level was excessive. Little lowered the bass level which satisfied Kapella.

- On 01/02/2016 an officer discovered that someone had pulled the fire alarm inside the business at 1125 North Old World Third Street (Ugly's). The fire department was on scene and expressed concern that there was no audible indication inside the business that the fire alarm had been pulled.
- On 01/01/2016 Milwaukee police conducted a tavern check at 1125 North Old World Third Street (Ugly's). During this check, officers were advised of a fight on the second floor of the business. One subject was arrested and cited for both disorderly conduct and resisting an officer.
- 4. On 01/26/2016 a meeting was held at City Hall regarding the noise nuisances at Ugly's tavern (1125 North Old World Third Street). Attending this meeting were representatives from the Milwaukee police department, the city attorney's office, the alderman's office, and the applicant along with Nathan Harris and Attorney Michael Maistelman. During this meeting, it was determined that the "No Music on Exterior Terrace" provision of the business's permit meant that the business was prohibited from playing music from both the exterior and enclosed portion of the rooftop.
- 5. On 01/31/2016 Milwaukee police conducted a tavern check at 1125 North Old World Third Street (Uglys). Officers discovered a female inside the business that was holding a napkin to her lip and had blood on her right hand. The victim told officers there had been a fight inside the business between some guys and she had been punched in the face.
- 6. On 01/31/2016 Milwaukee police responded to a battery complaint at 1125 North Old World Third Street (Ugly's). Investigation revealed a patron had called police after being pepper sprayed by someone from the business's security while in the ladies room. The security officer told police he had used pepper spray in the ladies room to break up a fight. The caller, and two other patrons inside the ladies room at the time of the incident, told officers the fight had been resolved and felt the use of pepper spray by security was uncalled for.
- 7. On 02/18/2016 Milwaukee police, along with the Wisconsin Department of Revenue, conducted an investigation at 1125 North Old World Third Street (Ugly's Tavern). Eleven bottles of contaminated alcohol were discovered and disposed of.
- 8. On 02/22/2016 Milwaukee police investigated a battery complaint that occurred at 1125 North Old World Third Street (Ugly's bar) on 02/21/2016. The victim, Brittani Bauer, told officers she had been punched in the face about 15 times by an unknown subject while inside the ladies room in the business. Bauer also told officers she had reported this incident to security at the business and was told there was nothing they could do because she could not identify her assailant.
- On 06/19/2016 while walking outside 1125 North Old World Third Street (Ugly's), a patron on the rooftop threw a glass bottle down onto the sidewalk. The sidewalk was crowded with pedestrians and officers, but no one was injured. This subject was identified and arrested for disorderly conduct.
- 10. On 07/23/2016 Milwaukee police were flagged down regarding a trouble with a subject complaint at 1125 North Old World Third Street (Ugly's). Investigation revealed an altercation had taken place inside the business and three females were now outside indicating a male that had been involved was still inside the business. Officers checked, but were unable to locate the described male. The females left the scene without supplying additional information.

While inside, the officers noticed several patrons that were dressed in a manner inconsistent with the posted dress code.

- 11. On 10/23/2016 at 1:04am officers observed a fight being pushed out of Ugly's, 1127 N. Old World Third St. More officers were called and the parties fighting fled on foot. Security stated the fight started on the second floor and continued outside after they were pushed out. No arrests were made.
- 12. On 12/31/2016 through 01/01/2017 officers responded to five calls for service at Ugly's, 1125 N. Old World Third St. On 12/31/2016 at 11:33pm officers responded to a possible fake ID call. They determined the ID was valid. 01/01/20174 at 12:18am officers responded to a trouble with a patron who was kicked out for sleeping inside. She was upset with the way she was kicked out stating she was "man handled". She left when officers advised she could receive a citation for Disorderly Conduct. At 1:16am officers responded to a call for a subject arguing with security. The officers found a subject outside refusing to leave. He only left when threatened with arrest. The subject was upset because he was denied entry for a dress code violation. At 1:29am observed a fight in front. They found the previous subject had returned and was fighting with security. He was cited and released from District 1. At 2:21am officers responded to a fight where the same subject again returned and was again fighting with security. He was again arrested and conveyed to District 1.
- 13. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Ugly's Pub, 1125 N. Old World Third St. The Police Aid was denied entry by security at the door.
- 14. On 06/26/2017 at 2:04am officers were dispatched to a subject with gun complaint at Ugly's, 1125 N. Old World Third St. The officers spoke with security who stated a subject was let out at closing. The subject wanted to get back inside believing he left his ID inside. He was denied entry and began threatening them. He then walked around the corner and produced a handgun. He racked the slide and security got everyone back inside for their protection. The subject then left in a SUV. The bar has cameras outside but the manager could not access them at this time.
- 15. On 07/16/2017 at 2:09am an officer, working Code Red, observed a fight outside Ugly's, 1125 N. Old World Third St. The officer attempted to break up the fight but additional squad were required do to the number of people fighting. The officer observed several people exit Ugly's to join in the fight. Security from the Pub Club a half block away came to assist while Ugly's security staff stood and watched the fight. The manager told the officer the outside security cameras did not work.
- 16. On 08/28/2017 officers investigated a fight at Ugly's, 1125 N. Old World Third St. Two patrons of Ugly's got into a fight inside the bar. Bar patrons separated the parties. One of them grabbed a glass off a table and threw it at the victim who received a cut above her eye. Ugly's did not call 911 for medical attention and security pushed the parties outside and did not attempt to disperse them. Video surveillance was provided when requested.

17. On 09/09/2017 officers were dispatched to Ugly's, 1125 N. Old World Third St for a battery complaint. The caller was no longer on scene and the officer spoke with the manager, Tony REYES. Reyes stated there was an upset patron who was swearing at a bartender. The patron threw a drink in the bartenders face so security was escorting her out. While being escorted out the patron struck one of the security officers in the face with her phone causing his nose to bleed. The officer was advised the patron was at District one and wanted to file a complaint. The patron stated she was dragged out of the bar and security broke her phone. She could not tell the officer what had happened and had no injuries. She was issued a citation for Disorderly Conduct.

On Sunday, October 23rd, 2016 at approximately 01:04 while I was walking outside of the tavern Ugly's (1125 N Old World Third St) I observed a large fight roll out of the tavern.

Additional squads were called to help break up the fight outside the tavern. As additional officers started arriving the actors fled the scene. After the fight was broken up no persons were found claiming injuries. Security personel informed me the fight began on the second floor and came downstairs and outside as security pushed patrons out.

Milwaukee Police uniformed officers performed a walk through the tavern finding the second floor dance area with drinks and broken glassware and plastic cups on the floor. Upon exiting the tavern employees were notified a PA33 would be filed regarding the altercation, but no citation's were being issued.

On the evening of 12/31/16 to the morning of 01/01/17, I had to respond to 1125 N Old World Third St Ugly's on five separate occasion's. The following is a summary of the calls for service that the Milwaukee Police Department responded to that evening.

- On Saturday, 12/31/2016 at 21:33 I responded to address of 1125 N Old World Third St for a potential fake ID being presented at the door of Ugly's. Upon my arrival I determined the ID was indeed valid, not a fake being misrepresented. I informed the manager SIDHU, David P M/W 02-22-1992, that he should compliment his staff on doing a good job and continued my beat patrol of the area. CAD 163662575
- On Sunday, 01/01/2017 at 00:18 I responded to 1125 N Old World Third St, for trouble with subject call. Upon arrival the security staff was having problems with a B/F who they had just thrown out of the tavern for sleeping inside. The B/F identified verbally as ORMOND, Antoinette J F/B 01/29/89, 3640 N 12th St, Milwaukee, WI 53206. ORMOND said that the staff had man handled her out of the tavern, and she wanted to press charges. When informed she would also receive a citation for D.C., ORMOND walked away without further complaint. The manager SIDHU, David P M/W 02-22-1992, was reminded of excessive force being used on patrons when removing them from the tavern. I left continuing my beat patrol of the area. CAD 170010181
- On Sunday, 01/01/2017 at 01:16 I responded to Sq 3216 (Sgt. BROCK, Raymond) calling out a trouble with subject at 1125 N Old World Third St (Ugly'S). Upon my arrival I found a B/M arguing and threatening door staff of Ugly's. He was verbally identified as DAVIS, Joesph H M/B 08/04/1989, 1715 S. 18th St, Milwaukee, WI 53204. DAVIS resisted orders of uniformed police to leave the area until officers approached him with handcuff's, out to take him into custody. At that time he turned and walked away, shouting profanities as he left. The manager SIDHU, David P M/W 02-22-1992 stated that DAVIS was refused entry because of dress code requirements, and he became belligerent. At that time I again left continuing my beat patrol of the area. CAD 170010414
- On Sunday, 01/01/2017 at 01:29, I observed a fight at the front door of 1125 N Old World Third St (Ugly's). Upon my arrival I noticed the previous actor DAVIS, Joseph H M/B 08/04/1989 fighting with staff of Ugly's. DAVIS was arrested for Disorderly Conduct and removed from the property. The manager SIDHU, David P M/W 02-22-1992, stated he would be the complainant for DAVIS' arrest. DAVIS was cited and removed from the area for his action's, being conveyed to District One. Where he was cited and released, telling officer's Ugly's was racist tavern that he wasn't afraid of. At that time I returned to my beat patrol of the area. CAD 170010453
- On Sunday, 01/01/2017 at 02:21, Sq 3216 (Sgt. BROCK) called for additional squads to 1125 N Old World Third St (Ugly's). The actor DAVIS had returned again and was attempting to fight with the staff at the tavern again. Sq 1490 (P.O. JOHNSON, Zachary/ P.O. DAVIS, John) arrived and again arrested DAVIS removing him from the property. Once again the manager SIDHU, David P M/W 02-22-1992 agreed to be a complainant again. CAD 170010644

On the evening of Thursday March 30, 2017 through the morning of Friday, March 31, 2017 District One personnel performed an underage tavern enforcement initiative. There were three teams that were part of this initiative. Each team had an MPD Police Aide, a Police Officer, both of which were acting in a plainclothes capacity with a uniformed Police Officer or Sergeant monitoring from a short distance. The Police Aide for each team was under the age of 21. This was verified by their respective Wisconsin driver's license. Police Aide Ana Romero-Perez (PS 024687, 03/18/1997) and Police Officer Paige Carloni (PS 024035) were in plainclothes while Police Officer Mariolys Flores (PS 024325) was in full uniform.

Prior to attempting any checks of licensed establishments the Police Aides and Police Officers were given instructions. All plainclothes members of this initiative were advised they are not allowed to consume any intoxicating beverages. If asked about their age, the members were told to tell the truth. The Police Officers were directed to produce ID's, but the underage Police Aides were directed to not produce any form of identification. It was explained that the Police Aide was to order an alcoholic beverage. It was explained that at all times the plainclothes Police Officer should be in visual sight and observe the financial transaction for alcoholic beverages.

On March 30th 2017, at 9:29 PM, PO Carloni and PA Romero-Perez attempted to gain entry to the class "B" licensed tavern, Ugly's Pub, located at 1125 N. Old World Third St. PA Romero-Perez was not allowed in the tavern by security at the enterance to the tavern.

On April 5, 2017, at 9:32 PM, PO Matthew Anderson informed Tony W. Reyes, II that the establishment successfully passed the initiative.

On Monday, June 26, 2017 at 2:04 AM, I was dispatched to the address of 1125 N Old World Third St, Uglys Pub, for a Subject with Gun complaint.

Upon arrival, I spoke with Terence B WALKER (B/M 11/01/85). WALKER stated the suspect described as a H/M, mid 20's, 5'07"-5'11", 145-160 pounds, last seen wearing a white t-shirt, khaki pants, with a black jacket around shoulders, and armed with a black handgun, caused a disturbance outside the bar. WALKER stated the suspect left the bar at closing and later attempted to gain entry again due to possibly leaving his ID inside. WALKER stated he and other security personel told the suspect he was not allowed back in that the bar was closed. WALKER stated the suspect started to yell and curse at him and said that he would be back to damage the property. WALKER stated the suspect went around the north east corner and produced a handgun and racked the slide. WALKER stated he feared the suspect would use the gun and told everyone outside to get back in the bar. WALKER stated he observed the suspect get into a gray newer model Nissan SUV unknown make model plate and drive away. WALKER seemed to be shaken up by the incident.

I then spoke to Antonio R GOMEZ (W/M 01/17/90) who was the first caller. GOMEZ stated he was at the front door when the intoxicated suspect tried to come back in the bar. GOMEZ stated when the suspect was denied entry he made comments and threats but GOMEZ did not think anything of them. GOMEZ stated when the suspect went around the corner he heard a sound that he described as a firearm's slide being racked. GOMEZ stated he did not see the gun or the suspect after that.

I also spoke with the manager, identified as Tony W REYES (W/M 10/12/90). REYES stated he was outside helping get people out of the bar when the suspect made threats to damage the property. REYES stated he heard the sound of a gun being racked after the suspect went around the corner but REYES stated he did not see this happen. REYES stated there are cameras that watch the door but he is unable to access them at this time. REYES stated he would talk to his technical employee and would inform us when we could review and make a copy of the video.

This case is pending.

This report was written by PO Eric NORTHWOOD, assigned to District 1, Late Power Shift.

On Sunday, July 16th, 2017at approximately 2:09 AM, I was working Code Red Deployment on the 1100 block of N Old World Third St on squad 1430.

I observed a fight in front of Ugly's Tavern located at 1125 N. Old World Third St. I rode up to the fight on my police bicycle and activated my red and blue emergency lights.

I was also with PO Gerald SCHMIDT, as well as PO Stephen COOK. This caused multiple individuals to exit Ugly's and either join in on the fight, or gather to observe. I announced myself as a Milwaukee Police officer, and attempted to separate the two individuals fighting. During the initial fight, multiple other fights broke out due to the lack of control by Ugly's Tavern Security Staff through out the evening. I observed about 15 to 20 individuals all fighting.

I separated multiple males and females who were fighting and attempted to escort them away from Ugly's tavern in an attempt to diffuse the situation.

While I was escorting a female across the street, PO Gerald SCHMIDT was attempting to detain one of the initial combatants, who was identified as Kenneth L. MCDADE (B/M 05-07-94).

During the fight I radioed to dispatch requesting for more squad's to our location, due to number of indivduals fighting, as well as the fight going into N. Old World Third St. This required other Code Red resources to leave their area of responsibilities and assist the fight in front of Ugly's Tavern.

After the other Officer's arrived and the fights were concluded, I went over the squad that MCDADE was in. I spoke with PO SCHMIDT, who informed me MCDADE attempted to pull away from SCHMIDT and at some point they fell to the ground, causing injury to PO SCHMIDT. I observed abrasion's to PO SCHMIDT'S right hand and left knee. PO SCHMIDT also stated his left knee was sore from falling. I was also informed that after MCDADE was placed in handcuff's he spit in PO SCHMIDT'S face hitting him on the left side of his face.

I have spoken with the bar manager Tony W. REYES (W/M 10-12-90) previously about prior incidents that have occurred outside of Ugly's during closing. After the fight was concluded REYES came outside and asked what had happened. There were still individuals loitering in front of Ugly's, and I advised REYES that he inform his Security staff to clear the area.

The security staff from Pub Club half a block away left their location to help assist officer's break up the fight. The security staff with the exception of one inside security personnel from Ugly's stood around and watched the fight.

PO Andrew FUERTE checked with REYES about video servellience, who stated the incident was on on camera. I also spoke with REYES who stated the cameras outside of Uglys do not work. REYES also stated that they could see the fight from the top balcony and tried saying the individuals were not inside the Uglys. However, I observed multiple individuals exit Uglys and join in on the multiple fights occurring outside.

PO Daniel O'CONNELL (squad 1340) conveyed MCDADE to District 1 for processing

While at Ugly's Bar both parties engaged in a verbal argument with one another which led to both parties being separated by bar patrons. The glass makes contact with OWENS' head just above her left eyebrow. The result led to a small half inch laceration which required 5 stitches. The tavern did not call 9-1-1 but a friend of OWENS. The tavern did their own first aid without calling for medical attention. While investigating, the bouncers corralled the crowd just to north of the driveway and left them there in front of The Loaded Slate without trying to disperse them any further. They did immediately provide video surveillance regarding the incident. DAHL was located on scene and taken into custody.

This report was written by PO Eric NORTHWOOD assigned to District 1-Late Power.

On Saturday, September 9th, 2017 I was dispatched to Ugly's located at 1125 N. Old World Third St.

Upon arrival I activated my body worn camera and spoke with the manager Tony W. REYES (10-12-90) as well as Security staff. I informed REYES I was dispatched here for a battery complaint. REYES stated that they just removed a patron for throwing a drink at the bartender. The individual later identified as Alexa S. MCDOWELL (B/F 02-10-93) that was removed from the bar was no longer on scene.

REYES stated that MCDOWELL was with a group of people and ordered some shots of Patron. MCDOWELL began yelling and swearing at the bartender, which required Security to leave their assigned positions. Security attempted to verbally persuade MCDOWELL to leave Ugly's due to her loud and unruly behavior.

MCDOWELL refused to leave, then grabbed a drink off the bar and threw it in the bartenders face. Security began to escort MCDOWELL out of Ugly's and continuted to refuse to leave. At some point while being removed from Ugly's MCDOWELL struck one of the Security staff in the face with her cellular phone, causing the employee's nose to bleed. Once MCDOWELL was escorted outside she was advised she was no longer allowed inside Ugly's.

I called the number listed in the CAD, and spoke with MCDOWELL's sister, who stated MCDOWELL was arguing with the bartender, and then after aruging for a few minutes MCDOWELL threw the drink at the bartender and was escorted out of the bar.

I was advised that MCDOWELL was at The Police Administration Building at the Municipal Court entrance, and wanted to report an assault. When I arrived to that location I spoke with MCDOWELL. I did not observe any injuries to MCDOWELL. MCDOWELL also claimed she was dragged out of Ugly's and the staff broke her phone. I explained to MCDOWELL that I spoke with her sister, the manager at Ugly's as well as Security Staff. I told MCDOWELL that all three of their stories matched, and I would like to hear her side of the story.

MCDOWELL could not tell me what happened other than she wanted justice for what had occurred at Ugly's. When I informed MCDOWELL that she would be issued a citation for Disorderly Conduct, she stated that wasn't fair and she studied Law at Marquette. She continued to say I was racist because I would not hear her side of the story.

Ugly's staff handled themselves in a professional manner in dealing with MCDOWELL and how she had acted towards staff and security.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/23/2014 Milwaukee police responded to an injured person complaint at 720 North Milwaukee Street (720 Nightclub). Investigation revealed the injured party was walking down the stairs to exit the business when she lost her footing and fell down. Employees from the business summoned emergency services, and the injured party was conveyed to Columbia St. Mary's hospital where she was treated for several injuries.
- 2. On 05/03/2014 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Apartment 720 (720 North Milwaukee Street) but was turned away at the door when she could not produce proof that she had attained the legal drinking age of 21.
- 3. On 06/01/2014 Milwaukee police officers were posted in the 700 block of North Milwaukee Street to assist with the disbursement of patrons when the business's located in that area closed. Employees from Apartment 720 (720 North Milwaukee Street) were helpful and assisted Milwaukee police officers move customers away from the entry to the business. A fight broke out at 730 N Milwaukee. During the fight one subject was observed by a sergeant, retrieving a firearm from the subject's auto. The sergeant arrested the subject.

4. On 03/29/2015 Milwaukee police conducted a count of patrons inside Apartment 720 (720 North Milwaukee Street). That count revealed there were 319 patrons inside the business at one time. According to the Department of Neighborhood Services, the legal capacity at the business is 150 people. The applicant was cited.

5. On 04/17/2015 the applicant and Milwaukee police met regarding the over capacity violation that occurred on 03/29/2015 at Apartment 720 (720 North Milwaukee Street). The applicant told police that when officers had previously discussed the business's capacity, he believed the issue was how many people could safely be in the business, not the legal capacity as determined by the Department of Neighborhood Services. Additionally, he told officers he did not expect such a large crowd on 03/29/2015, and that night (03/29/2015) would be the last night the business would be open until it had undergone remodeling. He hoped that the remodeling would allow him to substantially increase the bar's legal capacity.

6. On 01/01/2016 officers observed a large mass of people waiting in line at Apartment 720,

- 6. On 01/01/2016 officers observed a large mass of people waiting in line at Apartment 720, at 720 N. Milwaukee St. The crowd was blocking the sidewalk so the officers advised the applicant to organize the line so the sidewalk was usable by pedestrians. The officers then went inside and observed a female sleeping on the floor with no one attending to her. The applicant was advised and he had someone wake her up. The applicant advised he was using a promoter for this event and he stated he would not use this promoter again.
- 7. On 04/02/2017 officers observed a disturbance on the stairs leading to Apartment 720 at 720 N. Milwaukee St. The bounce was escorting a subject down the stairs when the subject used a racially insensitive term and the bounce punched the subject. The officer intervened and escorted the subject out. The bouncer stated the subject was asked to leave several times and when he refused he was escorted out. The subject refused medical treatment and did not want to press charges.
- 8. On 04/08/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Apartment 720 at 720 N. Milwaukee St. The police Aid was denied entry by security.
- 9. On 05/21/2017 at 1:00am officers observed security at Apartment 720, at 720 N. Milwaukee St, escorting a group out. The group walked down the street and was advised to leave the area. At 2:00am when the bars were releasing patrons, the group attempted to continue the altercation that started inside the bar. A group began fighting in the street causing a crowd to gather. One of the female subjects that had been kicked out of Apartment 720 was found to be 19 years old. She stated she knows one of the security staff who let her in.
- 10. On 06/08/2017 at 11:40pm an officer was flagged down by security at Apartment 720, 720 N. Milwaukee St. Security stated they believed they had a female using an ID that was not hers. The officers determined the ID was not the subjects and she was cited.

This report is being submitted by P.O. Matthew ANDERSON assigned to District One, Power Shift.

On Sunday, April 2nd, 2017 at approximately 12:30 am I was on foot patrol in 700 block of N Milwaukee St. While on patrol I was observed a disturbance in the stairwell of a tavern located at 720 N Milwaukee St (Apartment 720). I observed a male later identified as Ariya A. KHALILI (W/M 4/1/1995) yelling and being escorted down the stairwell by a bouncer from the tavern later identified as Malcom D. JONES (B/M 9/10/85). KHALILI was struggling with JONES while being escorted down the stairwell. KHALILI was yelling, and when they reach the middle landing about half way down the stairs I heard KHALILI yell to JONES, "Get off me NIGGER, FUCK you NIGGER!" I then observed JONES strike KHALILI with a closed fist to the right eye, causing swelling to the right eye and pain. I then at this point I intervened escorting KHALILI down the stairs further at which point he became irate with me and I placed him in handcuffs in the rear of my patrol vehicle in an attempt to calm the situation. I spoke to JONES who stated that KHALILI was inside of the tavern bothering people in the VIP area and was asked to leave multiple times and did not. JONES stated after multiple times asking him to leave he physically escorted KHALILI out of the tavern and down the stairs. JONES stated that he was sorry and that he just snapped when he heard KHALILI call him a "nigger." I spoke to KHALILI who was highly intoxicated, and he stated that he did nothing wrong. I called for medical attention for KHALILI for his eye, and when MFD arrived he refused medical service. I asked KHALILI if he wanted to be the victim of a battery to which he stated to me that he would not say anything more without talking to a lawyer. KHALILI was released on scene after calming down. On Tuesday, April 4th, 2017 I returned a phone message left for me from KHALILI. KHALILI asked me what had happened at Apartment 720 on April 2nd, to which I informed him, what he had said to JONES and what happened following that. KHALILI stated that he did not remember yelling profanity at JONES and when he was informed of the exact language that he used with JONES he stated that he was sorry and that if he was in JONES shoes he would have struck him too. KHALILI stated that he was drunk of the night in question, and did not want to be a victim of a battery.

On Sunday, May 21, 2017, at approximately 1:00am, while working in the 700 block of N Milwaukee Street while being assigned to Code Red P.O. Steven COOK and I (Squad 1431) were standing outside of night club No. 720 located at 720 N Milwaukee Street when members of No. 720 security removed Jaylyn P ADAMS (B/F 1/18/98) along with her group of unknown three unknown black males and one unknown black female for creating an altercation inside of the club.

After being removed from the club, ADAMS yelled at the bouncers, "I am 22, I am grown as hell and y'all better catch those white girls before we do." P.O. COOK and I spoke with the group and informed them they had to leave and would not be asked again. The group walked down to the corner of W Wisconsin Avenue and N Milwaukee Street where vehicle valet was located. P.O. COOK and I continued to monitor the group.

At approximately 2:00am, No. 720 began to release their patrons from the bar, when P.O. COOK and I observed ADAMS and her group at 728 N Milwaukee Street waiting when they began to attempt to entice the group in which they were involved in the altercation with inside the club. ADAMS continued to be loud and boisterous continuing attempts to start another altercation, when approached by P.O. COOK and I for a second time ADAMS stated, "Don't touch me you racist ass cops." At this point the group of black males started a physical altercation in the street in front of No. 720 which involved approximately twenty individuals.

I took ADAMS into custody while P.O. COOK called for more Police Officers to respond to the 700 block of N Milwaukee Street. These actions caused approximately one hundred to one hundred and fifty people who were leaving No. 720, Lucid Night Lounge and Dick's Pizza and Pleasure to stop on the side walk and street to watch and video tape the events that were taking place in the street.

While speaking with ADAMS she stated her friends and her were out at No. 720 and consumed an unknown amount of alcoholic beverages.

Once I identified ADAMS it was discovered she is nineteen years old which is under the legal limit in the state of Wisconsin to gain entrance into a bar or night club and to consume alcohol. ADAMS stated she went to No. 720 because she knew one of the club's security members, who she showed her identification with her name and birthday on it and was let into the club.

ADAMS was conveyed to the Police Administration Building for cite and release.
