**Regarding:** Your Class B Tavern, Food Dealer, and Sidewalk Dining License Renewal Applications as agent for "KIKU LLC" for "KIKU" at 200 W WISCONSIN Av.

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/09/04, applicant was charged with 4<sup>th</sup> Degree Sexual Assault in Milwaukee County. On 08/24/08, the charge was amended to Disorderly Conduct.

2. On 10/16/10 at 1:35 am, while on patrol, a police officer observed a dance going on at 200 W Wisconsin Avenue, Kiku Restaurant. The officer entered the establishment and observed patrons that appeared to be under 21 drinking towards the back of the bar. Upon seeing the police, these patrons exited the bar. The officer observed the center of the bar was cleared out to allow dancing and a laser light show was projected on the walls and floor. A Mac computer plugged into the sound system playing MP3's provided the music. A license check revealed the bar had a class B Tavern license but no music or dance permit. The officer spoke with Man Feng Zhang who stated he did not know he needed a license to have a dance floor. Zhang was warned about music and dancing without a license and also was advised to thoroughly check ID's of his patrons. Zhang stated the patrons left because they were scared and that his door guy checks everyones ID's.

3. On 10/18/10 at 5:35 pm, Milwaukee police conducted follow up at 200 W Wisconsin. Officers spoke to the bartender who stated the owner Man Zhang had just left to run errands. The bartender was asked for his bartenders license to which he stated he was not bartending, just standing there. This subject was identified as Sai Lee. A check of employees on scene found there was no licensed bartender on scene. Lee was advised that the business would have to be closed until contact was made with Mr Zhang. While officers were waiting for a supervisor to respond to the scene, the owner Man F Zhang arrived. Zhang stated that he was aware that none of his employees were licensed bartenders and that he knowingly left the business without a responsible license person on scene. Zhang was advised he would be receiving a citation and became angry with officers. No other violations were observed.

The striking auto went through a red light, struck the officers and then crashed into the Steins Jewelry store at 715 W. Wisconsin Av. The driver then got into the auto he was racing prior to the accident. A passenger in the second car then fired shots at the officers, striking their auto. The owner of the car was Kristopher WEAH. He was located at home and arrested. He stated prior to the accident he was drinking at Kiku, 202 W. Wisconsin Av. He stated he bought a bottle of Hennessy to share with his friends. He stated he left at around 2:30am with two friends who were in the other car he was racing prior to the accident. Officers viewed the video surveillance from Kiku, which showed the establishment was open after 2:00am with patrons inside being sold alcoholic beverages. Crista MARTINEZ, the manager, stated the applicant sold WEAH the bottle of Hennessy for \$125.00 and they were drinking straight from the bottle. The applicant was interviewed and stated the three suspects are regulars at the restaurant and he knows them by their first names only. He stated he allowed them to stay in the restaurant while he counted the money and cleaned up. He stated they did not drink any alcohol after closing hours. He stated he closed at 3:10am because he had to check into the House of Corrections at 3:30am. The video surveillance also showed patrons playing music on a music player sitting on the corner of the bar and dancing inside. The tavern does not have a PEP license.

**PA-33E Narrative**

This report is submitted by P.O. Christine GONZALEZ assigned to district 1, late power shift as squad 1430 with P.O. Cullin WEISKOPF.

On Tuesday, December 5, we responded to a squad accident and officers being shot at, recklessly endangering safety and hit and run accident causing injury IR#17-339-0020. The striking hit and run vehicle crashed into a Steins Jewlery store at 715 W Wisconsin Av on scene, 813XVY, a 2015 Chrysler, 4dr, silver, 1C3CCCAB8FN591751, listing to WEAH, Kristopher Wolo (B/M, 8/14/96, 6444 N 58<sup>th</sup> St). The owner was located at home and was arrested. WEAH stated that he was intoxicated and was drag racing when the light turned red and he struck another vehicle and then his car crashed into a store front. WEAH exited his vehicle and gets into a vehicle that stopped. WEAH stated that the back passenger shot at the officers whose vehicle he hit.

Detective Daniel WILCOX interviewed WEAH on 12/5/17 at 2:10pm. WEAH stated that he had been drinking at Kiku located at 202 W Wisconsin Av and that he bought a bottle of Hennessy to drink and share with friends. WEAH stated that he left around 2:30am with the other two suspects who were in the black vehicle that he was drag racing, who came and picked him up. WEAH has known them since October 2017 and has hung out with them at Kiku many times.

On Wednesday, December 6, 2017 I asked to review video evidence from 12/5/17 from 200 W Wisconsin Av (Kiku) regarding the establishment being open after hours where the suspects from the RES had been patrons at prior to the incident. The establishment was open after 2:00am with patrons inside being sold alcoholic beverages as indicated by the time stamp on the video. The video time stamp is 20 min behind real time according to Det. Scott LACKOVIC's report who recovered the video evidence on 12/6/17 at 8:15am. Det. Brian STOTT recovered evidence and placed it on inventory #17047121. Items 1-5 were bottles of Hennessy Black and item 6 was Hennessy very special.

Detective LACKOVIC spoke to MARTINEZ, Crista (8/22/97) who is the day shift manager at Kiku who stated that the owner Zhang, Man sold WEAH a bottle of black Hennessy for \$125.00 and they were drinking straight out of the bottle. MARTINEZ stated that she had her 3 year old and 4 month old children inside the establishment that night.

Detective Jorge SUAREZ interviewed the waitress who was working the morning of 12/5/17, SILVA, Zamyda (W/F, 5/11/97) who stated that she was working from 10 pm to 2:30 am and left after 3 am along with the suspects and other patrons. SILVA stated that later that evening two of the suspects were inside and were talking about the accident and then shooting at the police. SILVA did not call the police to report this information.

Detective Tiffany SKONIECZNY interviewed the owner ZHANG, Man (A/M, 1/6/78). ZHANG recalled being at work Monday night and into Tuesday morning. He worked his normal shift, 6 PM (Monday 12/4/2017) - 3:10 AM (Tuesday 12/5/2017). ZHANG said who was present and working at the restaurant with him. ZHANG stated there was one cook, one bartender and him (the owner) working at the restaurant. ZHANG could not recall his cooks name but stated he was of Puerto Rican descent. The bartender was a female and he stated her first name, Zamyda.

ZHANG relayed what customers were present on 12/5/2017 after 12:00 am. ZHANG stated the following were present: Juan, Juan's brother, and Chris (unknown last names and spellings) are regulars at his restaurant, and were present. Also, there were 3-4 tables with 2-4 people at each table ordering food. Later, he recalled SILVA's boyfriend and MARTINEZ'S 18 year old sister (unknown name) were taking care of her 2 children, who were all present at the restaurant.

ZHANG recalled WEAH arrived at Kiku around approximately 12 AM, Tuesday morning. At about 1 AM Juan and Ramone arrived at the restaurant. WEAH ordered a bottle of Hennessy liquor and Juan ordered approximately 6 cocktails throughout their stay. He was unsure whether they ate food at the restaurant.

ZHANG stated that he allowed WEAH, Juan, and Ramone and others stay in the restaurant after it was closed while he cleaned up and counted the money. ZHANG relayed he did not necessarily trust them to stay in the restaurant while he counted the money, yet he allow them to stay because there was not much money. He did not allow them to drink any more alcohol after closing hours. Everyone left the restaurant and he locked the doors at 3:10 AM. He was sure he closed the restaurant at 3:10 AM, because at exactly 3:30AM he must report to HOC. ZHANG recalled he check into HOC on time (3:30am) on 12/5/2017.

On Wednesday, December 6th, 2017, P.O.'s Jose VIERA, Stephanie SEITZ and Michael RUBLEE along with several other District 2 Police Officers conducted follow up at the address of 1518-A W. Scott St. in search of Juan and Ramone GARCIA, who both had valid Temporary Felony Wants for their arrests. Squads located Juan and Ramone GARCIA inside the residence and placed them both under arrest. Ramone was conveyed to Central Booking for processing and Juan to District 2 for processing. WEAH was arrested for attempt 1<sup>st</sup> degree reckless homicide, 1<sup>st</sup> degree reckless endangering safety, hit and run, and reckless driving. Garcia, Juan was arested for attempt 1<sup>st</sup> degree reckless homicide, hit and run occupied vehicle, reckless driving, discharging a firearm/veh. Garcia Ramone attempt 1<sup>st</sup> degree reckless homicide, hit and run occupied vehicle, reckless driving, discharging a firearm at a vehicle.

The video evidence was placed on inventory #17047331 of Kiku operating after hours. I observed the video starting at 2:00am and finishing at 4:00am. The time stamp is 20min prior to real time. So the true time is 1:40am to 3:40am. The lights are turned off at 3:10am. The patrons are playing music on what appears to be an electronic music player sitting on the corner of the bar. The patrons are dancing inside the establishment. The tavern did not have a current public entertainment premise.

On Thursday, December 7, ZHANG was issued citation # 6158911-3 for class "B" premises allow Patrons After hours violation, the listed liscensee for the class "B" tavern allowed 14 patrons to remain on premisis and consume and purchase alcohol after 2:00AM, citation # 6158912-4 for on premises sale violation, licensee allowed on their premises the sale of intoxicating liquor to be consumed by the bottle, not the glass and citation # 6158913-5 for public entertainment premises license required violation, licensee for the class "B" tavern that does not have a public entertainment premise license allowed music to be played above a conversational level and patrons to dance throught the licensed premise.

DNS conducted an inspection and issued orders for fire code and maintence violations.

Daniel O'CONNELL), was dispatched to District 7 to meet with the victim, E.C. (W/F, 05-01-98), regarding a sexual assault that occurred at Kiku restaurant located at 200 W. Wisconsin Av., which is located in the City and County of Milwaukee, at approximately 04:01am.

E.C. named the owner/manager Man (Peter) F. ZHANG as the suspect. The complete details of the investigation can be obtained through IR#17-048-0026. To summarize the complaint; ZHANG has been accused of fondling the victim's breasts over her clothing while kissing her face and neck. The victim did not consent to these actions and told ZHANG to stop, to which he not comply with. It should be noted that ZHANG was ultimately arrested regarding his involvement.

Upon follow-up it was determined that the surveillance cameras inside the location were not functioning at the time of the incident. ZHANG related they have not been working for at least the last 3 months. There was no way to confirm his claim. However, a check with the license application shows ZHANG marked "yes" to having security cameras.

On the evening of Saturday April 8<sup>th</sup>, 2017 District One personnel performed an underage tavern enforcement initiative, consisting of an MPD Police Aide, a Police Officer, both of which were acting in a plainclothes capacity with a uniformed Police Officer monitoring from a short distance. The Police Aide was under the age of 21. This was verified by their respective Wisconsin driver's license. PA Jada GREER (PS 026047, 08/30/1997) and PO Markel McKinley (PS 019200) were in plainclothes, while PO Matthew Anderson (PS 018926) was in full uniform.

All plainclothes members of this initiative were advised they are not allowed to consume any intoxicating beverages. If asked about their age, the members were told to tell the truth. The Police Officer was directed to produce ID, but the underage Police Aide was directed to not produce any form of identification. It was explained that the Police Aide was to order an alcoholic beverage. It was explained that at all times the plainclothes Police Officer should be in visual sight and observe the financial transaction for alcoholic beverages.

On April 8<sup>th</sup>, 2017 at 10:00 PM, PO McKinley and PA Greer attempted to gain entry to the class "B" licensed tavern, Kiku, located at 200 W. Wisconsin Ave. There was no security at the door of the establishment. PA Greer ordered, and was served, a Miller Light beer at the bar for \$4.18.

The bartender who served PA Greer was later identified as France M. Montegalo h/f, dob 4/19/1997.

On April 8<sup>th</sup> 2017, at 11:30, PM Police Officer Daniel Boeck informed Man Zhang that they failed.
