Amendment No. 1 to the Project Plan for Tax Incremental Financing District No. 50

Sub-Section I.A. "Introduction" is amended to state the following:

Section 66.1105(4)(h)(1), Wisconsin Statutes, permits the Redevelopment Authority, subject to the approval of the Common Council, to amend the project plan for a tax incremental financing district.

Section 66.1105(2)(f)1.n., permits that amendment to fund projects located outside, but within one half-mile of the district's boundary.

The City of Milwaukee created Tax Incremental District Number 50 (the "TID") in 2002 to support environmental remediation at a former paint manufacturing plant located at 5375 South 9<sup>th</sup> Street.

To date, \$775,151 in project costs have been incurred, including interest on debt and associated carrying charges, and approximately \$809,280 of incremental revenue has been generated in the TID.

Per Section 66.1105(5)(b) the percentage of territory within the District that will be devoted to retail business at the end of the maximum expenditure period is estimated to be 0%.

In summary, Amendment No. 1 to the Project Plan will provide \$65,000 for the purpose of paving two street segments located within one-half mile outside of the current TID boundary. The segments are listed below:

- West Clayton Crest Avenue between South 14<sup>th</sup> Street and South 15<sup>th</sup> Place
- West Upham Avenue between South 14<sup>th</sup> Street and South 15<sup>th</sup> Place

The following amendments are made to the Project Plan. All other sections of the Project Plan remain unchanged.

- West Upham Avenue between South 14<sup>th</sup> Street and South 15<sup>th</sup> Place


