On the evening of August 16<sup>th</sup> / morning of August 17<sup>th</sup> 2017, the Milwaukee Police Department was looking for a suspect believed to be in the lower unit of a property under my management. In their search, the officers forcibly entered the detached and locked garage located on the west side of the house. I use this garage for storage and neither the lower or upper unit tenants have access to it. The exterior door was damaged beyond repair, as well as the locking system and door knob.

In addition, two padlocks; one leading to a storage area under the basement stairs and one leading into the attic, were forcibly removed. The frame on the basement door was damaged and the attic lock was pried open and left on the ground. Entry was attempted to the interior rear entry door for the upper unit; located at the top of the shared rear stairs and adjacent from the attic door, in a manner causing the existing locking system to fail. Unable to repair the door to lock effectively, the door and locking system had to be replaced as well.



This supplement report is written by, Detective Jake PUSCHNIG of the Criminal Investigation Bureau/ North Investigation Division Early Shift, assigned to squad 9222.

On Monday, 08/07/2017 at 9:34pm a Mitsubishi Endeavor with three actors pulled up to the entrance and two unknown armed actors entered the Guaranty Bank at 7901 W. Brown Deer Rd. and ordered everyone into the lobby area to get down on the ground. Actor #2 monitored the employees in the lobby area by pointing his handgun and ordering everyone not to move. Actor #1 pointed a handgun and order the manager and assistant manager to get up and open the vault. Manager and Assistant manager opened the safe in the vault. Actor 1 then ordered them out of the vault area and proceeded to place stacks of US Currency along into a book bag that he was carrying. Actors then fled the bank reentered the Mitsubishi Endeavor. All three actors then exited the Mitsubishi Endeavor and fled westbound on foot from the bank.

Actor #1 was identified as Brushae BROWN (B/M 5/18/1989). BROWN confessed to this incident and stated he committed this Armed Robbery with Malik GILLIAM(B/M 12/08/1993) and Darius MITCHELL(B/M 03/22/1989). BROWN stated Darius MITCHELL was the subject that went into the bank and robbed the bank with him.

On Thursday, August 17th 2017 Milwaukee Police Department Officers observed MITCHELL going into his residence located at 4053 N. 12th St. Officers surrounded the residence and advised MITCHELL to come out of the residence. MITCHELL mother and other occupants of the residences came out of the residence. MITCHELL refused to come out the residence and failed to comply with police orders to come out of the residence. MITCHELL stayed in the residence for 3 hours and 46 minutes with 62 Sworn Milwaukee Police Officers on-scene attempting to have MITCHELL voluntary come out of the residence. MITCHELL did look out the back door
