THIS TERMINATION OF LEASE is made by and between City of Milwaukee, a Wisconsin municipal corporation ("City"), and BMO Harris Bank NA ("BMO"), as of April 28<sup>th</sup>, 2017.

WITNESSETH

WHEREAS, City is the "Lessor" under that certain Lease recorded on May 24, 1966, in Reel 309, Image 1509, as Document No. 4256418 (the "Lease"); and

WHEREAS, BMO is the successor "Lessee" under the Lease, and fee title owner of the real property commonly known as 778 North Water Street and 769 North Broadway, Milwaukee, Wisconsin and legally described on Exhibit A attached hereto and incorporated herein by this reference (the "Property"); and

WHEREAS, the purpose of the Lease was to grant certain air space rights over a public north-south alley on the Property (the "Alley");

WHEREAS, the City vacated the Alley pursuant to Common Council File Number 161322, adopted on March 28, 2017, thereby eliminating the need for the Lease;

NOW, THEREFORE, City and BMO do hereby agree that the Lease is terminated as of the date first set forth above and neither party shall have any further rights or obligations thereunder.
