


We have received your claim in the amount of \$522.67, relating to damage allegedly sustained to your vehicle on February 15, 2008 when it collided with a pothole while you were traveling northbound on Teutonia Avenue at 2157 North 12th Street.

Our investigation reveals that the Infrastructure Services Division records indicate that prior to February 15, 2008 the City had no notice of this hazard in the roadway and because of this lack of notice the City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
