Enforcement of Vehicle Registration Ordinance

Dear Aldermen Donovan and Puente:

Prior to hearing File Number 081322 at the Public Safety meeting on Thursday, January 29, 2009, I would like to provide you with some background information regarding the enforcement of Ordinance 101-24.7 "Unregistered Motor Vehicles".

In early 2007, the State of Wisconsin enacted s.341.18(1) that prohibits parking on public right-of-way (alleys, streets, highways, public ways or thoroughfares) of any vehicle that <u>either</u> is:

- 1) unregistered for more than 31 days; or
- 2) fails to display proof of registration on the state-issued license plates.

As you are aware, people who do not pay their parking violations are unable to register their vehicles. The law seeks to motivate people to register and provide proof that they are registered. One of the benefits of the law is to provide better parking availability for those citizens who comply with laws and who promptly pay their parking citations.

The City formally adopted this statute in Ordinance 101-24.7 and the Department of Public Works began enforcing it in April 2007. Originally, the ordinance did not differentiate between the penalty for unregistered vehicles versus failure to display proof of registration. Citations issued for Violation Code 636 had a \$50 penalty and the vehicles were ordered towed.

Soon after the inception of this new ordinance, the parking operations staff received calls from people indicating that their registration stickers were stolen. The MPD does not complete a report for stolen registration stickers, so there was no method by which to determine whether someone was telling the truth. However, in response, in May 2007, DPW did alter their enforcement policy and required the enforcement officers to call the Parking Information Desk to determine whether or not the vehicle was actually registered. If the vehicle was not registered, the policy remained the same. If the vehicle was registered but did not display proof of registration, it was just ticketed with the \$50 citation. If the same vehicle was found again five or more days later and it still did not display proper registration, it was ordered to be towed.

As people objected to being fined for \$50 when they claimed that their registration stickers were stolen, DPW in conjunction with Alderman Donovan developed another policy and an ordinance change was passed. As of August 2008, anyone whose vehicle was registered but failed to display proper registration was cited with a fine of \$15, while the fine for those unregistered vehicles remained at \$50. Unregistered vehicles continue to be towed.

As you will note by the following table, the number of tickets issued to vehicles for not being registered dropped after the latest change to the ordinance in August 2008. However, the number of vehicles ticketed for failing to display has increased significantly, thus illustrating the magnitude of the problem that exists in the City of Milwaukee with vehicles parked with improper registration display. Because it is impossible for DPW or the Municipal Court to determine which tags were really stolen as claimed by many people who are cited for failure to display, the lower fine (now \$17) serves as a warning to alert people to the need to properly display their registration proof.
