This is to notify you that on January 29, 2009, the City's Public Safety Committee voted to recommend to the City's Common Council that your renewal application for a public passenger vehicle driver license be granted with a thirty (30) day suspension based upon the police report.

On January 29, 2009, you were sent a true and correct copy of the Findings of Fact, Conclusions of Law and Recommendations of the Public Safety Committee with respect to your renewal application for a public passenger vehicle driver license. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of February 10, 2009, commencing at 9:00 a.m., in the Common Council chambers, on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections and to appear personally or by counsel to address the Common Council. You did not appear nor did you file written objections.

Following consideration of the report of the Public Safety Committee, the Common Council adopted the Committee's recommendation and renewed your license with a thirty (30) day suspension based upon the police report.

Said suspension is to be in effect from the date of the Common Council action on February 10, 2009 through midnight, March 11, 2009.

Dear Mr. Martin:

This is to notify you that on Thursday, January 29, 2009 the City's Public Safety Committee voted to recommend to the City's Common Council that your application for a Public Passenger Vehicle Driver license be denied. You are eligible for a refund of your license fees, except for a \$25 administrative fee, by bringing in your receipt or filing an affidavit for refund, within one year to date of action with the License Division, Room 105, City Hall. Per section 100-50-10-a, Milwaukee Code of Ordinances, you may not be granted a Public Passsenger Vehicle Driver's license for 12 months since the date of denial.
