Part 1. There is added to the Milwoukee Code of Ordinances ("Code") a new sectian to read as follows:

(1) In accordance with the provisions of Section 295-907 af the Code relating to the establishment of planned development, districts, the Cammon Cauncil opproves the subject Detailed Plonned Development, a copy of which is ottached to this Camman Council File as Exhibit A which is an file in the office af the City Clerk and made a part as though fully set forth herein.

(2) The zoning map is amended to change the zoning for that part af the Nartheast 1/4 and the Southeast 1/4 of Section 32, Township 6 North, Range 22 Eost, in the City of Milwaukee, Milwaukee Caunty, Wisconsin, bounded and described as fallaws:
Cammencing at the Nartheast corner of said 1/4 Section; thence South 00

waukee Caunty, Wisconsin, bounded and described as fallaws:
Cammencing at the Nartheast corner of said 1/4 Sectian; thence South of deg. 36 min. 07 sec. East alang the east line of said 1/4 Section 900.09 feet to the point of beginning; thence South 89 deg. 12 min. 36 sec. West 447.00 feet to a point; thence South 60 feet to a point; thence South 89 deg. 12 min. 36 sec. West 233 feet to a paint; thence Sauth 00 deg. 36 min. 07 sec. East 130 feet to a point; thence Sauth 89 deg. 12 min. 36 sec. West 926.24 feet to a paint; thence Narth 04 deg. 48 min. 41 sec. West 578.42 feet to a point; thence North 89 deg. 12 min. 36 sec. be subject to the penalties pravided in Section 200-19 at the Code. Part 3. If any section, subsection, sen-tence, clause, phrose ar portion of this ordinance is for any reason held invalid or unconstitutional by any court of com-petent jurisdiction, such portion shall be petent jurisdictian, such portion shall be deemed a separate, distinct and independent provision, and such halding shall not affect the validity of the remaining portions. The Comman Council declores that it would have passed this ordinance and each section, subsectian, sentence, clause, phrase or partian irrespective of the fact that any one armore sections, subsections, sentences mare sections, subsections, sentences, clauses or phrases or other portions be declared void or invalid.
