My name is Audwin Short, and on **September 19**th **2017**, I received a Night Parking Ticket indicating that my Night Parking sticker for my car needed to be renewed. On **September 21**st **2017** at 4:35pm I purchased a new sticker online for my car.

A few days later, I received another Night Parking ticket **September 23**rd and when I called to inquire, I was told that my "payment probably wasn't processed in the system yet." On **September 27**th, I received another Night Parking ticket and my car was towed.

I called the number again to inquire and was told that they couldn't find my payment in the system under my Plate numbers or my payment under my name. After looking at the receipt that I printed online, I noticed that you Renewal System did not register the last 4 digits of my plate numbers that I entered. When I went to the **City Attorney's Office** about the error, they said it was my fault.

I entered in the correct numbers for my License Plates and your system took the payment as a correct transaction. Your system gave no indication that the wrong numbers were entered and the only reason I had a receipt was because I printed the webpage after the payment was made. Your Night Parking reps couldn't even find it in their system.

I would like to be reimbursed for the Cost of the Tickets following my purchase of the Sticker online and the cost of the towing. The total cost I am seeking is \$130 for the towing. I am going to court to dispute the 2 Night Parking tickets listed, as well as other I tried talking to people at the City Attorney office but they said their was nothing anyone could do even though I had the receipt and what I mentioned showed that I wasn't at fault.

Attached is a copy of the Night Parking Sticker purchase receipt, a printout of the Tickets around September, and receipts showing my payment to get my car out of tow.
