

Re: Report of the Renewal Application of Mohamad T. Hamdan for a Public Passenger

Vehicle Driver License.

FINDINGS OF FACT

- Mohamad T. Hamdan (hereinafter the "Licensee") is the holder of a Public Passenger 1. Vehicle Driver License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, February 25, 2017.
- 2. An application to renew said license was filed with the Office of the City Clerk.
- 3. On June 18, 2018, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances § 349.24 of the Wisconsin Statutes, of a police report that could form the basis for suspension or non-renewal of the license and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on June 27, 2018 at approximately 9:30 a.m. in Room 301-B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel.
- 4. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Notice was sent to Mohamad T. Hamdan at 5890 South Madeline Avenue, #2, Milwaukee, Wisconsin 53221, along with a copy of the police report on June 18, 2018 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, Wisconsin 53202. The address of 5890 South Madeline Avenue, #2, Milwaukee, Wisconsin 53221 was the address given by the applicant on his renewal application. The licensee failed to appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.



CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Mohamad T. Hamdan, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver License based upon nonappearance.
- In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, 3. it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver License held by Mohamad T. Hamdan based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends by a vote of five (5) ayes and zero (0) noes that the Public Passenger Vehicle Driver License of Mohamad T. Hamdan be denied based upon nonappearance.
