In March of 2008, the State of Wisconsin Government Accountability Board applied for a \$2,000,000 grant from the U.S. Election Assistance Commission to improve the collection and reporting of election data. The purpose of the federal grant is to enhance the capacity of states and their jurisdictions to collect accurate and complete election data and to develop an elections data collection protocol that can be replicated by other states.

The Government Accountability Board developed the business practices, systems and methodologies for election data collection. The Election Commission was responsible for reporting the results of the November 4, 2008 Presidential Election in accordance with the systems and methodologies developed by the Government Accountability Board. In turn, the Government Accountability awarded the Election Commission \$100.00 for each of the City's 314 reporting units (wards).
