I feel the City's procedure was improper due to the following reasons and I have attached any supporting evidence, including city employee's names/dates which I spoke to regarding this issue and copies of any city orders received:	
City left a warning sticker on May 23, 2018 for "tall grass/weed	
destreuction notice" stating we had to hours to abate and that	
Reinspection would take place on May 28, 2018. The timing was suspect	
as weather archives demonstrate it had poined consistently for the weaks leading	
up to May 23, 2018; but neverthelpss, the owner above and moved all grass	
and weeds within 48 hours of the notice. No further correspondence or notices	
were peclifed until this violation on June 25, 2018. Owners called the city to	
dispute/inquire and were told that a contractor mowed our lawn which is false. City only has pictures from May 23, 2018: day of notice. owner mowed; not contractor.) Further, arbitrary enforcement violates owners due procede	85
