Dear Mayor Barrett and Council Members:

As a component of Internal Audit's comprehensive audit work plan, the consulting firm Securance, LLC was engaged to conduct a citywide Information Technology (IT) risk assessment and formal report to City management. The risk assessment focused on identifying, evaluating and ranking the auditable technology units and processes in terms of high to low risk. Internal Audit recently received the enclosed final report detailing the results of the IT risk assessment performed by Securance, LLC.

The scope of the IT risk assessment included the City's critical technology departments and their systems including all significant applications, databases, network appliances, IT processes and platform/servers. The consultant interviewed a variety of the City's business users and IT personnel with the purpose of identifying, studying, evaluating, and reporting on IT risks at a detailed and summary level.

The objectives of the IT risk assessment were to:

1. Identify each member of the auditable IT risk universe.
2. Identify the functionality, inputs, processing, outputs and data security for each member of the risk universe.
3. Analyze and evaluate each member of the risk universe using a standardized risk assessment methodology to assign a combined numerical risk rating.
4. Rank each member of the risk universe numerically from high to low risk, including the category of asset, audit technology, department, asset description and final risk score.
5. Provide detail and summary reporting of risk assessment results.
6. Generate recommendations to management for an IT audit plan based on risk.
7. Generate recommendations to management to reduce IT risk, improve the City's security posture and promote best practice.





Securance, LLC has extensive experience and subject-matter expertise in all aspects of IT risk assessment and constructive management reporting. At a summary level, the report contains the names of the risk assessment participants interviewed, a multi-year suggested audit plan and IT risks by score, category and department. Page eight of the report presents a suggested five-year IT audit plan, and starting on page ten, the report presents the citywide, overall risk scores from high to low risk. 291 auditable technologies were evaluated with the vast majority scoring in the medium risk category.

While the consultant's report presents a five year suggested IT audit plan, Internal Audit continuously monitors the priorities of the City's IT risk environment and considers input from City management that may require audit plan adjustments. As a result, the audit plan provides the required flexibility to meet the continually changing needs of the City's IT environment. Internal Audit will make the final decision on the IT audit plan and adjust the plan, as necessary, going forward.

Appreciation is expressed for the cooperation extended to the auditors and the consultants by management and the staff of the City's data centers, departments and divisions.



# Risk-Based Planning

## RISK ASSESSMENT

The process of estimating risk associated with each auditable technology. Risk assessments are typically undertaken to focus attention on significant areas, to allocate scarce resources to the most important areas and to help with prioritizing decisions such as frequency, intensity and timing. The criteria used to assign risk scores are as follows:

ID	RISK CATEGORY NAME AND DEFINITION
1	<i>Commercial vs. Internally Developed</i> – is the application/technology a commercial product vs. one that was developed internally. Internally developed applications/technologies receive a higher risk rating.
2	<i>Internal Customer Impact</i> – what is the impact to internal users of the application/technology if the application/technology is taken off-line?
3	<i>External Customer Impact</i> – what is the impact to external users of the application/technology if the application/technology is taken off-line?
4	<i>Financial Exposure</i> – what is the financial impact to the organization if the application/technology is taken off-line due to a breach or unmanaged administration?
5	<i>Security Threat</i> – what is the level and type of security threat associated with the application/technology. For example, a network perimeter device such as a Firewall has a higher level of a security threat associated to it than an internal file server.
6	<i>Level of Admin Tasks</i> – what is the level of technical administration required to maintain the application/technology in production.
7	<i>Major Recent Change</i> – was there a recent (i.e. within 6 months) major upgrade to the application/technology. If so it may be riskier than if the application has been implemented and stable for a longer period of time.
8	<i>Technology Complexity</i> – in general terms how complex is the application/technology. For example, a SAN is typically more complex than a single member file server.
9	<i>Adequacy of IT Staff</i> – is the staff adequately trained in the technologies they managed, do they receive continual training, and is there adequate cross-training.
10	<i>Hosted by SP or Managed 100% Internally</i> – is the application/technology hosted or managed 100% or in part by a Service Provider. If a Service Provider is involved typically risk is transferred to the SP.

This report is an opinion-based risk assessment. The scoring of auditable technologies is based on the opinions of the participants interviewed. In addition, the level of risk associated with each auditable technology is based on multiple factors. Risk scores alone may not be a sufficient basis for making an audit planning decision. It may be necessary to factor in the cost of carrying out the audit as it relates to the relative risk an organization is willing to assume.

The general opinion, with respect to **Audit Frequency**, is that the riskier technologies should be assessed more frequently. This matrix is a guide that should be used in conjunction with a conditional audit frequency approach. Under a conditional frequency approach, all key technologies are monitored for signs of major changes. Examples of major changes include significant upgrades, reconfigurations and/or the addition of a large number of users.

**Audit intensity** should be determined by assessing the qualifications of the resources and the complexity of the technology. Generally, the more complex the technology, given the same level of staff skills, the more detailed the audit.

**Audit timing** is another component to be considered during planning. Again, audit planning is heavily dependent upon resource availability. A variety of approaches have been used to determine when audits should be scheduled. Fixed time audits are based on the assumption that there are fixed times that are best suited to conduct the audit; whereas, random timing audits are more unpredictable and may be used to motivate IT personnel to maintain their controls and procedures at reasonable levels.

**Audit Frequency, intensity, timing and resources** are key components that should be considered when using the Technology Risk Matrix.

# TECHNOLOGY RISK ASSESSMENT REPORT

## INTRODUCTION AND SCOPE

Securance Consulting has been engaged to perform an IT risk assessment of the auditable technologies and processes deployed and implemented to protect the City of Milwaukee's information assets. The objectives of the IT risk assessment were to: 1) better assess and understand the IT systems that store, process or transmit organizational information, and 2) enable management to make well-informed decisions related to implementing risk management techniques and processes, including IT audits.

## APPROACH AND METHODOLOGY

The approach and methodology for performing the IT risk assessment included gaining an understanding of the City of Milwaukee's diverse IT environment to identify auditable technologies and processes. IT Management selected applicable risk categories to assess each auditable technology/process against. Key personnel were interviewed independently to obtain risk ratings. Individual ratings were entered into a proprietary risk assessment engine for analysis.

Technologies/processes were prioritized based on the following scale:

- **High Risk** – score between **51 – 35**
- **Medium Risk** – score between **35 – 13**
- **Low Risk** – score of **13** or less

The remaining sections of the report include:

- Risk Assessment Participants
- A five (5) – year IT audit plan
- IT Risk by Score
- IT Risk by Category

**SYSTEM GENERATED CONCLUSION**

The audit planning recommendations provided below are based on the results of the system generated risk assessment analysis, our IT audit experience, and interviews with managers from in-scope departments and information technology. Securance utilizes a proprietary system to generate the risk assessment results. The system is based on concepts from multiple globally accepted security and control frameworks, including National Institute of Standards and Technology (NIST), Control Objectives for Information and Related Technologies (CoBIT) and International Organization for Standardization (ISO).

In our opinion, during the year 1, the following technology audits should be scheduled and performed to reduce the greatest technology risk currently being assumed by the City of Milwaukee.

1. Perform a comprehensive application audit of ITMD's system development life cycle process.
2. Perform a comprehensive audit of the Disaster Recovery Plan managed and maintained by ITMD.
3. Perform a comprehensive audit of the database environment managed by ITMD.
