SECOND AMENDMENT TO LEASE AGREEMENT

Lessee shall have the right, in its sole discretion, to change and modify the Communication Facility as more completely described on attached Exhibit 1-_, without an increase in rent. Lessor's execution of this Amendment will signify Lessor's approval of Exhibit 1-_. Exhibit 1-_ hereby replaces Exhibit _ to the Agreement
- 2. **Memorandum of Lease.** Either party will, at any time upon fifteen (15) days prior written notice from the other, execute, acknowledge and deliver to the other a recordable Memorandum of Lease substantially in the form of the Attachment 1. Either party may record this memorandum at any time, in its absolute discretion.
- 3. Other Terms and Conditions Remain. In the event of any inconsistencies between the Agreement and this First Amendment, the terms of this First Amendment shall control. Except as expressly set forth in this First Amendment, the Agreement otherwise is unmodified and

remains in full force and effect. Each reference in the Agreement to itself shall be deemed also to refer to this First Amendment.

4. **Capitalized Terms.** All capitalized terms used but not defined herein shall have the same meanings as defined in the Agreement.
