The site is currently under redevelopment. No crews have been on site the past several weeks, nor is there					
any occupancy at this point. During a visit, prompted by the fine received 7/11/2018, no posted notification					
was found on the site, though admittedly it might have been washed away by the rains. In the past weeks,					
it might be worth considering we've experienced higher than average rainfall in June that no doubt has					
contributed to rapid weed growth. I now understand that written notification is not required, but also					
in light of this building being our first location in the City of Milwaukee, and that it is currently not an active					
job site, I believe it reasonable that this fine be amended. For reference, we did mow the property on 7/13.					
We look forward to being an engaged community partner with the City and believe this to be a great future location for Wheel & Sprocket.
