
We have received your claim in the amount of \$2,240.21, relating to damage sustained to your parked vehicle on December 19, 2008 when you allege that it was struck by a City plow at 4579 North 26th Street.

Our investigation reveals that the Fleet Services Division Accident Report completed as a result of this alleged incident notes that the damage on your vehicle is not consistent with being hit by a plow. In addition, our drivers deny causing the damage. Finally, your witness saw a plow truck pass your car but did not see an impact. There is no evidence to support your belief that a City plow caused the damage. As such, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
