On August 1, 2008 about 7:00pm I was going south on 27th in Locust. As I was going to make a left hand turn which is west of Locust and south of 29th street I heard and noticed the police lights flashing. I turned on 29th Locust and parked.

The officer jumped out and told the passenger, Judale Malone, and I to put our hands on top of the hood of the inside of the car (the top was down). The officer instructed us to get out of the vehicle which at this time they proceeded to handcuff me and Malone. One of the officers put me in the back of the police car and made Malone sit on the curb.

The officer proceeded to run a check on both of us and I did indeed have a warrant for drinking in public. However, both Malone and I had a valid driver's license.

One officer (Badge ID 012421) started to search the car. The search went on for about fifteen minutes. Later a female officer appeared with a search dog. The search dog went thru the car (my vehicle is a two-seater). My vehicle was later towed.

On August 2, 2008 about 10:00am I went to pick up my car from the tow lot and I discovered the interior damages to my vehicle. There were scuff marks and tears throughout my seats from the dog search. The arm rest was under the dash and consol.

The tow lot (tow #136453) took the necessary pictures to prove the damages that occurred during the police and dog search to my vehicle. This is unacceptable to have this amount of damages for a search that was not necessary.


Yes, I did receive citations, but it was not related to the search. Listed below are copies of the citation numbers I received that night.
