Milwaukee, Wisconsin ("El Duranguito Bar")


FINDINGS OF FACT

1. Jesus Lechuga (hereinafter "the Licensee") is the holder of a Class "B" Tavern license for the premises located at 1993 South Muskego Avenue in the City and County of Milwaukee, Wisconsin ("El Duranguito Bar"). Said license expires at midnight on June 30, 2009.

2. An application to renew said license was filed with the Office of the City Clerk on April 13, 2009.

Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On April 14, 2009, the Milwaukee Police Department responded with a report regarding the renewal of said license, which could form a basis of non-renewal or suspension. There were also neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, drug and criminal activity, prostitution, trespassing, public urination, operation of the premises in such a manner that it creates a public nuisance, and conduct detrimental to the health, safety and welfare of the neighborhood.

On May 21, 2009 and June 11, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and the neighborhood objections, and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for hearing on the Milwaukee Police Department report and neighborhood objections on June 1, 2009 and June 22, 2009, commencing at 8:45 a.m. in Room 301B



of the third floor of City Hall. The licensee did not appear the first time this matter was scheduled on June 1, 2009. At said date, time and place, on June 22, 2009, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was not represented by counsel.

- 5. Based upon the testimony heard and evidence received, the Committee makes the following findings of fact.
 - A. On February 17, 2006 at 9:45 p.m., officers of the Milwaukee Police Department were dispatched to El Duranguito Bar for an anonymous drug dealing complaint. Officers checked the bathroom of the bar and observed a subject snorting a white powdery substance suspected cocaine base. The subject was arrested and taken to the Prison Processing Section of the Milwaukee Police Department. The substance tested the suspected cocaine, which tested positive for cocaine base in the amount of .41 grams. Officers spoke to the owner of the bar, Jesus Lechuga, and he stated he did not know that his customer was using cocaine in his bathroom.
 - B. On March 19, 2006, the subject from item A was charged with possession of cocaine and found guilty on July 17, 2006 and sentenced to 25 days in the House of Corrections and had his license suspended for six months. This incident was previously reported but the disposition was added on April 20, 2007.
 - C. On September 10, 2008 at 12:15 a.m., officers of the Milwaukee Police Department conducted a license premise check at 1993 South Muskego Avenue ("El Duranguito Bar"). The investigation revealed a patron in the tavern's bathroom who was found to be in possession of cocaine. This subject was arrested and charged with possession of a controlled substance-cocaine. Officers spoke to the bartender regarding the patron and he stated he only saw the subject twice before and did not know him well. When officers asked the bartender if the owner/licensee was on scene, he stated the owner was in Mexico. He was also found to not be a licensed bartender and was issued a citation for Class "D" Bartender's license required. Police observed the front entrance to the tavern did not have the proper lighting and advised the bartender regarding the lighting of entrance/exit doors. He was issued a citation for Class "D" bartender license required, which was tried on May 21, 2009. On May 21, 2009, he was found guilty and fined \$375.00.
 - D. On January 30, 2009 at 10:35 p.m., officers of the Milwaukee Police Department conducted a license premises check at 1993 South Muskego Avenue. The investigation revealed two patrons were found in the tavern's bathroom with one patron in possession of cocaine. This patron was arrested and charged with possession of a controlled substance-cocaine. Officers spoke to Jesus Lechuga who

was bartending at the time and Mr. Lechuga stated to officers that he did not know anything about what happened in the bathroom.

E. No neighbors appeared in opposition to the renewal of this license.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Jesus Lechuga, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern license without undergoing a ten (10) day suspension of said license. The Committee finds the police report, as stated above, to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern license of Jesus Lechuga, for the premises located at 1993 South Muskego Avenue in the City and County of Milwaukee, Wisconsin ("El Duranguito Bar"), with a ten (10) day suspension based upon his past activities as a licensee, and for the danger the operation of this premises posed to the health, safety and welfare of the citizens of the community.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "B" Tavern of Jesus Lechuga, for the premises located at 1993 South Muskego Avenue in the City and County of Milwaukee, Wisconsin, be renewed with ten (10) day suspension.

Said premises will be closed at midnight, June 30, 2009 due to the expiration of that license on that date. Thereafter, the suspension of this license will be in effect from the time of the Common Council action on July 7, 2009 through midnight on July 16, 2009.

("Milwaukee Foods")

FINDINGS OF FACT

1. Jagdish Patel (hereinafter "the Licensee"), is the holder of a Class "A" Malt license. Said license expires at midnight on July 25, 2009.

2. An application to renew said license was filed with the Office of the City Clerk on May 13, 2009.

Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On May 20, 2009, the Milwaukee Police Department responded with a report regarding the renewal of said license, which could form a basis of non-renewal or suspension. There were also claimed neighborhood objections to loitering, littering, drug and criminal activity, prostitution, trespassing, public urination, loud music, parking and traffic problems, operation of the premises in such a manner that it creates a public nuisance, overpriced sales of food products, and conduct detrimental to the health, safety and welfare of the neighborhood.

On June 12, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and the neighborhood objections, and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Milwaukee Police Department report and neighborhood objections on June 22, 2009, commencing at 10:15 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the



notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was represented by Attorney Roberto Ledesma, 2855 South 13th Street, Milwaukee, Wisconsin 53215.

- 5. Based upon the testimony heard and evidence received, the Committee makes the following findings of fact.
 - A. On April 29, 2006 at 11:00 a.m., Sewak Singh received a citation for sale of cigarettes to minor/underage at 2903 West Clybourn Avenue and was found guilty on June 26, 2006 and fined \$152.00.
 - B. On July 24, 2007, Sewak Singh received a citation for sale of alcohol to underage person at 2903 West Clybourn Avenue and was found guilty on September 12, 2007 and fined \$160.00.
 - C. The chair ruled that items A and B above were considered for the 2008 renewal when Mr. Sewak Singh was the agent, and therefore would not be considered by the Committee for the 2009 renewal year. The chair further ruled that item, D, below, could be considered by the Committee for purposes of the 2009 renewal year. Under Wis. Stat. § 125.07(1)(b) 4., and § 125.12(1)(b)2., to be considered there must be two violations resulting in convictions within a year of the date of the first violation (irrespective of conviction) to be considered for purposes of discipline.
 - D. On May 6, 2008, Sewak Singh received a citation for sale of alcohol to underage person at 2903 West Clybourn and was found guilty on November 24, 2008 and fined \$80.00. Mr. Sewak Singh is no longer the agent of this entity, and Mr. Patel is now the newly appointed agent of the same legal entity, although Mr. Singh retains a 51% ownership of this property.
 - E. On May 11, 2009, there was a neighborhood clean up in which Mr. Singh did not participate. A neighbor testified that there is litter around the store that the store management does not clean up. He saw drug dealing outside of this store. While the witness has seen this activity and called the police, he did not keep a log of the activity and the times he called the police.
 - F. A neighbor testified to drug dealing taking place in the front and along the side of this location. One neighbor, who checks for the welfare of individuals in the neighborhood, testified to congregations of persons going to the back of the store after closing and consuming alcohol that had been purchased at this location. In addition, persons go into the store, purchase alcohol and sit in their cars and drink the beer. Mr. Sewak Singh and the

- other owners of this store, they said, are not proactive in preventing problems form patrons of this store.
- G. A supporter of the store testified that there can be as many as twenty persons in the back of the store consuming alcohol but that they are in fact a neighboring property where they live which is in the back of the store. It only looks like they are on the store property, but it is really on the adjoining property. The individuals sit on a brick wall separating the adjoining property and the neighboring property. One supporter explained that she takes children to play close by and that when they go into to the store to purchase items, they may wait outside of the store until everyone has made their purchases.
- H. Most of the supporters testifying in favor of the renewal of this license were driven to the hearing by the business owner. However, they denied that there is any criminal activity, drug dealing, loitering or improper activity or any kind, or that their testimony was in any way influenced by the transportation to the hearing.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Jagdish Patel, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "A" Malt license for the premises located at 2903 West Clybourn Avenue in the City and County of Milwaukee, Wisconsin, without undergoing a ten (10) day suspension of said license. The Committee finds the neighborhood objections, as stated above, to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "A" Malt license of Jagdish Patel, for the premises located at 2930 West Clybourn Avenue in the City and County of Milwaukee, Wisconsin ("Milwaukee Foods"), with a ten (10) day suspension based upon his past activities as a licensee, and for the danger

the operation of this premises posed to the health, safety and welfare of the citizens of the community.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) no recommends that the Class "A" Malt license of Jagdish Patel, for the premises located at 2903 West Clybourn Avenue in the City and County of Milwaukee, Wisconsin ("Milwaukee Foods") be renewed with ten (10) day suspension.

Said premises will be closed from 12:01 a.m., July 26, 2009 through midnight, August 4, 2009.


FINDINGS OF FACT

1. Salvatore Salvo (hereinafter "the Licensee") is the holder of Class "B" Tavern and Tavern Amusement (cabaret/nite club) licenses. Said licenses expire at midnight on July 25, 2009.

2. Applications to renew said licenses were filed with the Office of the City Clerk on May 7, 2009.

Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On May 8, 2009, the Milwaukee Police Department responded with a report regarding the renewal of said license, which could form a basis of non-renewal or suspension. There were also claimed neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, fights shootings, vandalism, thefts, drug and criminal activity, prostitution, trespassing, public urination, complaints of physical violence and property damage by security and conduct detrimental to the health, safety and welfare of the neighborhood.

On June 12, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and the neighborhood objections, and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Milwaukee Police Department report and neighborhood objections on June 22, 2009, commencing at 10:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and



place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was represented by Attorney Michael A.I. Whitcomb, 633 West Wisconsin Avenue, Suite 510, Milwaukee, WI 53203.

- 5. Based upon the testimony heard and evidence received, the Committee makes the following findings of fact.
 - A. On August 9, 2008 at 3:45 a.m., officers of the Milwaukee Police Department were dispatched to St. Mary's Hospital for a battery complaint. Officers were unable to talk to the victim that night due to being sedated on pain medication. On August 15, 2008, officers spoke with the victim who stated he was at Textures with his girlfriend when an unknown patron came up to them and started harassing them. The suspect then began hitting and punching the victim when the bouncer came over and held the victim white the suspect kept punching the victim. The victim further stated he was escorted out of the tavern by the bouncer where again the bouncer held on to him while the suspect and another subject continued to punch him. An incident report was filed. The licensee denied this indecent occurred.
 - On November 13, 2008 at 9:14 p.m., officers of the Milwaukee В. Police Department were dispatched to 606 South 5th Street for a battery complaint. The investigation found the victim was at Textures on November 8, 2008 and was leaving the bar with friends at closing time when he observed a fight taking place in front of the tavern. The victim stated next thing he knew he was being hit in the head with an expandable baton. The victim further stated his friends attempted to get help at the club and that security would not call for police or medical help. The victim was treated at a nearby hospital for bleeding on the brain, skull fracture, concussion and an inner ear injury. The victim could not provide officers with a description of the actor. Police viewed some video surveillance but the fights were never caught on tape. An incident report was filed. At hearing, the license denied anyone stated the victim cannot bleed in the club. The licensee also denies this incident occurred precisely because nothing was shown on the Affirmatively, the licensee stated an offer to call an ambulance was made which was refused by the victim whose friend drove her to the hospital.
 - C. On December 29, 2008 at 1:28 a.m., officers of the Milwaukee Police Department were dispatched to St. Luke's Hospital for a battery complaint. Officers spoke to the victim who stated she was

at Texture with some friends when she saw an old acquaintance who she had an ongoing dispute with over money. Words were exchanged and a fight started with the acquaintance taking a glass and hitting the victim over the head causing several lacerations to her face and head. Security guards broke up the fight and the victim stated they put her out of the club with security telling her she "couldn't bleed in the club." The victim stated her friends came out from the tavern and gave her ride to the hospital. The victim required over 80 stitches to the right side of her head. Officers spoke to a security guard who stated he heard two females arguing in the back hallway and then observed one female hit the other over the head with a glass. Both were punching and pulling each other's hair. Lindsey stated he escorted the victim out of the tavern while another security guard called for an ambulance. An incident report was filed. The licensee denied that they told the victim that she could not bleed in the club and affirmatively stat that she was offered an ambulance call that was declined and her friend conveyed her to medical attention.

- On January 4, 2009 at 2:33 a.m., officers of the Milwaukee Police D Department were dispatched to 606 South 5th Street for a battery complaint. Police spoke to the caller who stated he was beat up by security from Texture nightclub. The victim stated he was leaving in his auto as security was directing traffic. He attempted to make some turns but was told by security he couldn't. The victim stated he was not confrontational with security and the next thing he knew a uniform security guard opened his car door and punched him in the face. Officers spoke to manager, Donato Salvo, who stated he employs inside security for "intimidation." Salvo stated all of his security guards are paid in cash and that he does not have their names or personal information. Officers requested to see video surveillance that would show the outside of the club and Salvo stated his video surveillance was not working. Officers expressed concern to Salvo that this was the third battery complaint made where his employees were the suspects. It was also the second time police requested video surveillance and were not provided any with the owner stating the equipment was not working. An officer spoke with a security guard who stated he works only at the door and was watching the crowd when he observed a fight break out in the street. Kitzman stated he ran over to where the fight was taking place and he was punched and scratched in the face by the alleged victim. A report was filed regarding this incident. The licensee explained that the club was closing, and one individual decided to fight with club security.
- E. The licensee explained that outside security is employed as

- independent contractors and paid and given form 1099s at year's end. Inside security are bar employees. The only time a guard is paid in cash is if they work for a very short time.
- F. On November 22, 2008, a corporate officer, Mr. Mark Hetzel, received a citation for Harvest or Tag a Buck in an Earn a Buck Unit without First Tagging in Dodge County. On January 6, 2009, he was found guilty and fined.
- G. On December 14, 2008 at 1:55 a.m., Mr. Salvatore G. Safina received a citation for Assault & Battery at 236 North Water Street. There was a court date on May 29, 2009 at 1:30 p.m. set for pre-trial. At this time, there is no disposition.
- H. On December 14, 2008 at 1:55 a.m., Mr. Donato Salvo received a citation for vandalism at 236 North Water Street. There was a court date of May 29, 2009 at 1:30 p.m. for pre-trial. There is no disposition.
- I. The licensee asserts their security force has prevented vandalism in the area, and the music is slowed one hour before closing, and closing is one-half hour before standard bar time.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Salvatore Salvo, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern and Tavern Amusement (cabaret/nite club) licenses without undergoing a ten (10) day suspension of said licenses. The Committee finds the police report, as stated above, to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Tavern Amusement (cabaret/nite club) licenses of Salvatore Salvo, for the premises located at 606 South 5th Street in the City and County of Milwaukee, Wisconsin ("Texture"), with a ten (10) day suspension based upon his past activities

as a licensee, and for the danger the operation of this premises posed to the health, safety and welfare of the citizens of the community.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "B" Tavern and Tavern Amusement (cabaret/nite club) licenses of Salvatore Salvo, for the premises located at 606 South 5th Street in the City and County of Milwaukee, Wisconsin ("Texture"), be renewed with ten (10) day suspension.

Said premises will be closed from 12:01 a.m., July 26, 2009 through midnight, August 4, 2009.


FINDINGS OF FACT

1. Andrew Arena (hereinafter "the Licensee"), is the holder of Class "B" Tavern and Tavern Amusement (cabaret/nite club) licenses. Said licenses expire at midnight on July 25, 2009.

2. An application to renew said license was filed with the Office of the City Clerk on May 18, 2009.

Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On May 19, 2009, the Milwaukee Police Department responded with a report regarding the renewal of said license, which could form a basis of non-renewal or suspension. There were also neighborhood objections to loitering, littering, loud music and noise, sales to intoxicated persons, disorderly patrons, operation of the premises in such a manner that it creates a public nuisance, and conduct detrimental to the health, safety and welfare of the neighborhood.

On June 12, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and the neighborhood objections, and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Milwaukee Police Department report and neighborhood objections on June 23, 2009, commencing at 9:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place,



the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was represented by counsel who was himself.

- 5. Based upon the testimony heard and evidence received, the Committee makes the following findings of fact.
 - A. On June 7, 2008 at 2:30 a.m., officers of the Milwaukee Police Department were dispatched to 1044 North Old World Third Street for a fight complaint. Officers spoke with two victims who stated that while they were inside Buckhead Saloon, they were attacked by an unknown female. Officers observed one victim to have a swollen left eye while the other victim complained of pain to her arm. Both refused medical attention. Both victims stated that security for the tavern had the woman detained but let her go prior to police arrival. Officers viewed video surveillance, which was in poor quality and which did not provided enough to identify an actor. The bar manager Shaun Thompson was also injured during this incident.
 - B. On December 6, 2008 at 2:00 a.m., officers of the Milwaukee Police Department were dispatched to 1044 North Old World Third Street for a trouble with subject complaint. The investigation found a patron tried to retrieve his coat from the coat check and he was told they could not locate it. The patron was asked to return the following day when they would most likely find it and could be returned to him. Words were exchanged between the patron and an employee with police being called. Officers removed the patron from the tavern and asked him to come back the following day to retrieve his coat. A citation was issued to the patron for disorderly conduct unrelated to the complaint. At hearing on June 23, 2009, the licensee testified that this patron was issued a claim check for the coat and lost the claim check.
 - C. On December 28, 2008 at 2:30 a.m., officers of the Milwaukee Police Department were dispatched to 1044 North Old World Third Street for a trouble with subject complaint. Officers spoke to the manager who stated a patron who was asked to leave had broken the front glass door of the bar. The subject was still on scene and cooperative with police as was the bar manager. The bar manager stated he did not want any charges issued since the patron offered to pay for the damages. The call was advised.
 - D. On February 21, 2009 at 2:25 a.m., officers of the Milwaukee Police Department were flagged down for a trouble with subject complaint at 1044 North Old World Third Street. Officers spoke to the manager who stated a Buckhead's hooded sweatshirt was being

worn by patron and that the shirts are worn only by employees. He further stated the sweatshirts are not sold for retail purposes. The bar manager stated he tried to approach the patron and ask for the sweatshirt back but the patron refused. Police spoke to patron regarding the sweatshirt who then returned it back to the manager. Call was advised.

- E. On February 26, 2009 at 11:43 p.m., officers of the Milwaukee Police Department were flagged down by security for Buckhead Saloon regarding trouble with subject. Officers observed several security guards physically detaining a patron on the ground in the roadway. Police identified themselves to this subject who then began fighting with officers. The subject was eventually placed into custody. Officers spoke to the bar manager who stated the subject was on the dance floor grabbing women when security approached him and asked to leave. The patron then became irate and started to cause a disturbance. Security escorted the patron out from the tavern and while doing so, the patron attempted to punch one of the guards. Several security officers assisted in detaining the patron until police arrived. Charges of disorderly conduct and resisting arrest were being sought.
- F. On March 6, 2009 at 1:20 a.m., officers of the Milwaukee Police Department were on patrol when they were flagged down by security for Buckhead Saloon. A staff member advised police that a subject tried to enter the tavern using a fake ID and pointed out the actor to officers. Police conducted a field interview and the actor admitted trying to use the fake ID to gain entry into the tavern. The subject was cited and released.
- G. On March 13, 2009 at 12:34 a.m., officers of the Milwaukee Police Department were flagged down by the doorman of Buckhead Saloon for a trouble with subject complaint. Police spoke to an employee who stated an underage subject attempted to enter the tavern by using a false ID. Officers conducted a field interview on the subject and issued him a citation for misrepresenting age.
- H. County Supervisor Theodore Lipscomb testified to an incident which occurred on August 2, 2008 in which a group of people and Mr. Lipscomb were debarking from the Edelweiss (a river cruise boat) and as the group was debarking from the ship was showered with beer from above which was attributed to the patrons on the patio of Buckhead Saloon. The licensee, by his manager, asserted that the security force of Buckhead's did not see any beer being poured over a balcony by any patrons and that there could have been beer tossed by other patrons of the Edelweiss.

I. The local alderman testified that in the prior license year there were six contacts with police, and this year seven. He testified that this location by this conduct is a continuing problem in the district.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Andrew P. Arena, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern and Tavern Amusement (cabaret/nite club) licenses without undergoing a ten (10) day suspension of said license. The Committee finds the police report, as stated above, to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Tavern Amusement (cabaret/nite club) licenses of Andrew P. Arena, for the premises located at 1044 North Old World Third Street in the City and County of Milwaukee, Wisconsin ("Buckhead Saloon"), with a ten (10) day suspension based upon his past activities as a licensee, and for the danger the operation of this premises posed to the health, safety and welfare of the citizens of the community.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) no and one (1) excused, recommends that the Class "B" Tavern and Tavern Amusement (cabaret/nite club) of Andrew P. Arena, for the premises located at 1044 North Old World Third Street in the City and County of Milwaukee, Wisconsin ("Buckhead Saloon") be renewed with ten (10) day suspension.

Said premises will be closed from 12:01 a.m., July 26, 2009 a.m. through midnight, August 4, 2009.

FINDINGS OF FACT

1. Jerome E. Kosmoski (hereinafter "the Licensee") is the holder of a Class "B" Tavern license for the premises located at 3402 South 16th Street in the City and County of Milwaukee, Wisconsin ("Sand Castle"). Said license expires at midnight on July 10, 2009.

2. An application to renew said license was filed with the Office of the City Clerk on June 1, 2009.

Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On June 2, 2009, the Milwaukee Police Department responded with a report regarding the renewal of said license, which could form a basis of non-renewal or suspension. There were also claimed neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, drug and criminal activity, prostitution, trespassing, public urination and conduct detrimental to the health, safety and welfare of the neighborhood.

On June 12, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and the neighborhood objections, and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Milwaukee Police Department report and neighborhood objections on June 22, 2009, commencing at 9:15 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the



- notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was not represented by counsel.
- 5. Based upon the testimony heard and evidence received, the Committee makes the following findings of fact.
 - A. On January 10, 2008 at 12:05 a.m. officers of the Milwaukee Police Department were dispatched to 3402 South 16th Street for a armed robbery complaint. The investigation revealed that an unknown suspect entered the tavern armed with a gun demanding and obtaining money from the register and patrons. No injuries were reported.
 - District officers were notified by the License Investigation Unit that B. the Class "B" liquor license for 3402 South 16th Street was granted but not issued due to a hold that was placed on it by the Department of Revenue for back taxes. On September 10, 2008 at 12:08 a.m., officers observed the tavern to be open for business and contacted Jerome Kosmoski by phone regarding the situation. Kosmoski stated he was not aware of the Department of Revenue hold on his license and would contact them first thing in the morning. Kosmoski contacted police the next day stating he talked with the agent's supervisor and stated everything was taken care of and the Department of Revenue was going to mail his license but that he offered to pick it up instead on Monday. When asked by the officer if he was to remain closed, Kosmoski stated "I wasn't told to stay closed." The officer advised Kosmoski to check because he could be cited if he was not to be open until he received his license. On September 18, 2008 at 7:00 p.m., the tavern was observed to be open for business.
 - C. On September 25, 2008, officers of the Milwaukee Police Department were dispatched to 3402 South 16th Street for a noise nuisance complaint. Officers were aware that the tavern was operating without a valid license and instructed the bartender to close the bar. A patron from the tavern stepped outside and slashed the rear tire of a marked police squad. This subject was arrested and charged with criminal damage. Police talked with Jerome Kosmoski by phone regarding the officer's conversation with Agent Thomas Byrne from the Department of Revenue. Byrne confirmed to officers that he did speak with Kosmoski regarding the hold on his license on July 11, 2008 and that Kosmoski was advised that he could not be open and that he must remain closed until he received his liquor license. Kosmoski was issued three citations for license required for the incidents in which police found him to be open and operating.

- He was found guilty of all three citations and fined \$2,500 on each citation on January 23, 2009.
- D. At hearing it was confirmed that the Department of Revenue placed a hold on this license for nonpayment of taxes on July 11, 2008, which was not cleared until September 25, 2008. Said hold was instituted by the Wisconsin Department of Revenue under the provisions of Wis. Stat. § 77.61(11).
- E. On March 20, 3009, the licensee received a citation for building permit required at 3402 South 16th Street which is pending further proceedings on July 21, 2009.
- F. On February 18, 2009, the licensee was convicted of prohibited alcohol concentration and his license was revoked for six months.
- G. An objecting neighbor complained of noise from patrons starting and revving motorcycles at closing time, urinating on the front door of his property, and littering his property. That individual has complained to Mr. Kosmoski since October 2008. The information supplied by this neighbor is consistent with other complaints the local alderman has received.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Jerome E. Kosmoski, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern license without undergoing a sixty (60) day suspension of said license. The Committee finds the police report and neighborhood objections, as stated above, to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern license of Jerome E. Kosmoski, for the premises located at 3402 South 16th Street in the City and County of Milwaukee, Wisconsin ("Sand Castle"), with a sixty (60) day suspension based upon his past activities as a licensee, and for the danger

the operation of this premises posed to the health, safety and welfare of the citizens of the community.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes and two (2) excused, recommends that the Class "B" Tavern of Jerome E. Kosmoski, for the premises located at 3402 South 16th Street in the City and County of Milwaukee, Wisconsin be renewed with sixty (60) day suspension.

Said premises will be closed from 12:01 a.m. July 11, 2009 through midnight, September 8, 2009.

Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On May 11, 2009, the Milwaukee Police Department responded with a report regarding the renewal of said license, which could form a basis of non-renewal or suspension. There were also claimed neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, drug and criminal activity, prostitution, trespassing, public urination, fights, shootings, vandalism thefts, operation of the premises in such a manner that it creates a public nuisance and conduct detrimental to the health, safety and welfare of the neighborhood.

On June 12, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and the neighborhood objections, and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Milwaukee Police Department report and neighborhood objections on June 22, 2009, commencing at 4:15 p.m. in Room 301B of the third floor of City Hall. At said date, time and



- place, the Licensee did not appear at the hearing. The Licensee was not represented by counsel.
- 5. Based upon the testimony heard and evidence received, the Committee makes the following findings of fact.
 - A. On August 6, 2005 at 1:12 a.m., officers of the Milwaukee Police Department were dispatched to 5666 North Teutonia for an anonymous loud music complaint. The investigation revealed that the tavern owner, Suzana Crumble, had kicked out some patrons and she believes that they were upset about it and was the ones who called in the complaint. A tavern check was conducted and no violations were found
 - B. On January 28, 2007 at 1:24 a.m., officers of the Milwaukee Police Department were dispatched to 5666 North Teutonia for a shooting. The investigation revealed a patron shot another inside the tavern with the victim leaving the scene before police arrived. Detectives interviewed the victim, who was uncooperative and gave several different scenarios as to what occurred. Officers on scene did locate blood and casings inside the tavern along with several witnesses' statements that the shooting occurred inside the tavern. The victim who was shot was the tavern owner's cousin.
 - C. On July 26, 2007 at 2:23 a.m., officers of the Milwaukee Police Department were dispatched to 5666 North Teutonia for an armed robbery complaint. Police spoke to two victims who stated as they left the tavern and walked to the parking lot they were physically assaulted by a male who took one of the victims purse. The suspect then fled in an auto. The victim stated she suffered bruising to her face and nose. Officers spoke to an employee who stated he was employed by Remedies to clean the tavern and that the licensee and bartender were at the location prior to police arrival and that they left before police arrived and refused to return to the tavern. Attempts by officers were made to contact Suzana Ristic-Crumble, who did not answer her phone, and a message was left that she should contact the officers.
 - D. On January 1, 2008 at 1:33 a.m., officers of the Milwaukee Police Department were dispatched to 5666 North Teutonia for a fight complaint. The investigation revealed that security guard for Remedies and a patron got into a physical altercation when two patrons were not allowed into the tavern due to capacity limit. Each alleged that they were punched and all three were issued battery citations. As the patrons were leaving, one punched a window of the tavern, breaking it. A vandalism citation was issued

- to the patron who caused the damage. The security guard was issued a citation for assault and battery which was dismissed without prejudice on March 25, 2008.
- E. On February 25, 2008 at 1:32 a.m., officers of the Milwaukee Police Department were dispatched to 5666 North Teutonia for a fight complaint. Officers spoke to Suzana Ristic-Crumble who stated two patrons who had been in her bar had been physically fighting in the street in front of the business. Ristic-Crumble further stated she told them to stop fighting and leave the area. When police arrived these subjects were gone.
- F. On July 6, 2008 at 1:45 a.m., officers of the Milwaukee Police Department were dispatched to 5666 North Teutonia for a fight complaint. Officers spoke to the licensee, Suzana Ristic-Crumble, who stated that two unidentified female patrons started to argue after bumping into one another while dancing in the premise. Security personnel escorted one patron out of the tavern with the second patron later being escorted out once the first patron left the area. Ristic-Crumble then stated she observed two autos parked at 5668 North Teutonia and saw approximately ten females begin to fight and that is when she called police. Officers checked the area around 5668 North Teutonia and found various women's items in the parking lot which led police to believe that a physical struggle had taken place. No victims could be located.
- G. On August 3, 2008 at 1:04 a.m., officers of the Milwaukee Police Department conducted a license premise check at 5666 North Teutonia Avenue. Officers conducted a capacity count three times and found that 71 patrons were inside the tavern. The licensee, Suzana Ristic-Crumble, was bartending and was notified of her over capacity. The licensee was issued a citation for over capacity and the licensee was found guilty on October 6, 2008 and fined \$2,500.00.
- H. On September 27, 2008 at 2:27 a.m., officers of the Milwaukee Police Department were dispatched to 5666 North Teutonia Avenue for a shots fired complaint. Upon officers' arrival, police found the tavern to be closed but were able to speak with Suzana Ristic-Crumble who stated she called police after hearing two shots were fired from the front of her tavern. While speaking with Ristic-Crumble, another squad was dispatched to an area hospital for two shooting victims that were just brought in. The investigation found that two patrons who were leaving the Remedies parking lot in their auto were shot by an unknown suspect who opened fire on them. One victim was shot in the chest and the other was shot to

his right thigh. The victims were found to be underage and Ristic-Crumble was issued two citations for presence of underage. These citations were not found in the municipal court system.

- I. On November 6, 2008 at 11:45 p.m., officers of the Milwaukee Police Department conducted a license premise check at 5666 North Teutonia Avenue. No tavern violations were found at the time; however, a patron was found to have a warrant and was placed into custody and conveyed to the district station for processing.
- J. Neighbors of this establishment testified to loud music, noise, gunshots and fights involving patrons of this establishment particularly at closing time and disturbing their peace.
- K. A notice of the hearing as well as a copy of the police report was sent to Suzana D. Ristic-Crumble at 5666 North Teutonia Avenue, Milwaukee, Wisconsin 53209 on June 12, 2009 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 5666 North Teutonia Avenue, Milwaukee, Wisconsin 53209 is the address given by the Licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on June 22, 2009.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Suzana D. Ristic-Crumble, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of her Class "B" Tavern and Tavern Dance licenses based upon the police report and neighborhood objections. The Committee finds the police report and neighborhood objections, as stated above, to be true. The licensee, after being noticed, failed to appear and defend the allegations of the Milwaukee Police Department and the objecting neighbors.

3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class "B" Tavern and Tavern Dance licenses of Suzana D. Ristic-Crumble for the premises located at 5666 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Remedies") based upon her past activities as a licensee, and for the danger the operation of this premises posed to the health, safety and welfare of the citizens of the community, as well as nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) no and one (1) excused, recommends that the Class "B" Tavern and Tavern Dance licenses of Suzana D. Ristic-Crumble for the premises located at 5666 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Remedies") not be renewed based upon the police report and neighborhood objections.
