This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/31/10, Milwaukee police were dispatched to 3079 N Holton Street for a Shooting complaint. Officers spoke with Parwinder Bhagat who stated on at approximately 8:00 pm, a male subject entered the store and bought a bottle of liquor. The subject became angry and made a statement to Bhagat stating, "You mother fuckin Arabs come to this county to make money" and then threw Bhagat to the ground and punched him in the face, head and back 15 times causing pain to Bhagat. Bhagat stated he ran to the back room and locked the door. The subject then began kicking and punching the door causing damage. The subject was on scene when police arrived who received several citations. Police also spoke with Herishr Kumar who is also a clerk for the store and was he was questioned as to why he called stating that someone had been shot. Kumar stated that Bhagat was getting punched so he wanted police to come. Kumar was issued a citation for Misuse of 911. No citation was found in the municipal court system.



On June 13th, 2018, members of the Milwaukee Joint Human Trafficking Task Force, conducted surveillance at the Days Inn Hotel (1840 N 6th St, Milwaukee, WI 53212. The following members were involved in conducting surveillance at the listed address:

- *Det. Michael THOMAE (MPD)
- *P.O. Gerardo OROZCO (MPD)
- *Special Agent Kenneth PETERS (DCI)

This surveillance was set up because we received various tips regarding criminal activity being conducted from the Days Inn hotel. (drug dealing, soliciting, trafficking)

We parked around the business in the public city streets to be able to obtain a clear view of the front entrance and parking lot of the listed location.

Let it be noted that we were only stationed for an hour and observed multiple suspicious activities occurring from the Days Inn.

During our hour I observed a gentleman exit the front lobby conduct a hand to hand exchange and walk away. That same gentleman was observed exiting the front lobby multiple times. This activity is consistent with drug dealing.

Later on I observed some females being dropped off by males in cars. The females would enter the hotel with no belonging or a small bag. I also observed multiple male and female companionship exit the hotel. This activity that was observed causes great suspicion of possible human trafficking and prostitution being conducted at the listed location. We observed multiple people loitering in the front of the Hotel. In addition we observed staff members walking around the parking lot with a young females dressed with skimpy clothing.

Let it be noted that all this activity was done on the Days Inn property and most of it right in front of the glass doors.
