Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/01/2009 the Wisconsin Department of Transportation revoked the applicant's driver's license for 6 months for Operating While Intoxicated.

- 2. On 11/29/17 at 12:37 am, Milwaukee Police officers conducted a license premise check at 9012 W. Silver Spring Drive (Courtside Bar & Grill). Before entering the establishment, officers observed several vehicles parked along the north side of W. Silver Spring Drive and in the taverns' parking lot. There were also approximately ten vehicles parked in the BP filling station (9040 W. Silver Spring Drive) and officers observed the people from those vehicles enter the Courtside Bar & Grill. Officers entered the tavern and told the manager on duty that the Class B Tavern license for this establishment had expired and that they were not supposed to be open until the license was renewed and made current. The manager said that he was unaware the license was expired and willingly complied and closed the tavern down for the evening. No other violations were observed by officers and no citations were issued.
- 3. On 01/06/18 at 1:14 am, Milwaukee Police conducted a license premise check at 9012 W. Silver Spring Drive (Courtside Bar & Grill). While talking with the on duty manager, a fight erupted inside the bar area between three to four subject. With the help of security personnel, the officer was able to defuse the physical fight and detain one of the actors. The actor was arrested on outstanding warrants and no violations were observed.

- 4. On 01/12/18 at 12:45 am, Milwaukee Police interviewed the co-licensee at 9012 W. Silver Spring Drive (Courtside Bar & Grill) about an incident that occurred on 01/10/18. During the incident, an employee (victim) called the police about a trouble with subject and upon their arrival, pointed out a subject who threw an object at the employee (victim). During the investigation, another employee decided to get involved and tell the victim not to cooperate with the police. When the officer explained to the employee that any investigation that relates to the tavern needs to be investigated. The employee again told the victim not to get involved. The co-licensee was told that the police need full cooperation from all parties involved, especially those employed by his establishment. The co-licensee understood and said he would speak to the individual who made the comment. The officer also told the co-licensee about his patrons vehicles blocking residences' driveways and he said he would have security personnel monitor the situation.
- 5. On 03/03/18 at 1:27 am, Milwaukee Police were dispatched to 9012 W. Silver Spring Drive (Courtside Bar & Grill) for a battery complaint. The investigation revealed that a patron was hit in the head with a glass bottle which required stiches. While investigating the incident at the tavern, an officer observed a commotion as patrons exited the tavern and another officer found that several employees were not being cooperative with the investigation. The officer said that the employees inside the tavern during the incident did not see it occur and there is not a working surveillance system inside the tavern. Later follow up on the incident revealed that the co-licensee was extremely vague about the battery and that there are working surveillance cameras inside the tavern. An Incident report was filed (180620020).
- 6. On 03/11/18 at 1:00 am, Milwaukee Police were performing a license premise check at 9012 W. Silver Spring Drive (Courtside Bar & Grill) when multiple individuals started fighting outside the establishment. Investigation revealed that the fight started inside the tavern and security escorted them outside, together, and went back inside and locked the door to the establishment. Other issues which were observed by officers were; the surveillance system malfunctions, the door person does not have a counter to know how many people are inside the tavern, patrons vehicles that block the public walkway, and employees not forthcoming with information to officers. A meeting was scheduled with the owner in regards to these issues.
- 7. On 03/23/18 at 10:55 am, a meeting was held, in the Captain's office, at the Forth District Police Station about the tavern located at 9012 W. Silver Spring Drive (Courtside Bar & Grill). The agent was advised about the nuisance activities and complaints lodged against her establishment and she said that she understood. She was told that she could not have a working Jacuzzi, bed, lights, furniture, and food tables in the basement of her establishment because it can only be used for storage. She understood that fact but said she sometimes sleeps down there and uses the Jacuzzi when she is sore. Also discussed in the meeting were; getting the video surveillance system working, providing the name of the security firm they use, pat down search or wand everyone who enters the tavern, having a counter at the door for over capacity issues, and keeping an open line of communication with the Fourth District.

On Friday, September 29, 2017, Squad 4365, conducted a tavern check at the address of 9012 W. Silver Spring Dr (Courtside Bar and Grill). Upon arrival, P.O. PRESTI and I observed several vehicles parked along the north side of W. Silver Spring Dr and in the bar's parking lot. We also observed approximately 10 vehicles parked in the BP gas station (9040 W. Silver Spring Dr) lot and watched as several invidivials exited their vehicles and enter the establishment. Upon entering the bar, I spoke with the bar's manager, Jimmy E. SIMS, w/m 06-13-74. SIMS stated that he was unaware that the bar's Class B had expired (as of Sept 20, 2017) and that the bar was not suppose to be open for business until the license is renewed, made current and displayed properly. SIMS was asked to cease operations for the night, to which, he promptly and willingly complied. SIMS was informed that the bar could not re-open until such matter is resolved.

No other violations were observed while P.O. PRESTI and I were on scene.

This License Premise report was typed by P.O Ralph MCCLAIN, assigned to District Four, Squad 4365, Late Shift...

On Saturday, January 6, 2018, Squad 4365, conducted a tavern check at the address of 9012 W. Silver Spring Dr (Courtside Bar and Grill). Upon entering the bar, I spoke with the bar's manager, Jimmy E. SIMS, b/m 06-13-74. I asked SIMS if the night had been well and if there were any issues. SIMS stated that there were no issues. SIMS did say he had let go of nearly all of his security personnel and hired new security detail. Just as SIMS was explaining why he let go of his old security team, I heard several patrons in the bar yell "They're fighting, they're fighting!" I looked in the direction that the yelling was coming from and observed three to four male subjects actively throwing punches at each other. I grabbed my hand held radio and radioed for assistance. I then restrained (with the assistance of the bar's security personnel), a subject whom I observed throw several punches at another individual inside of the bar. This subject was later identified as Versia M. DORSEY (b/m, 2/20/85, B of I: 349981).. Subsequently, DORSEY was detained while an investigation was conducted regarding this disturbance. All other parties involved in this matter were escorted out the establishment before additional squads arrival and as a result, left the scene. SIMS, the bar's security and the rest of the bar's staff said they did not know who or why the fight started. They also stated that none of the subjects involved looked like regulars. I conducted a wanted check on DORSEY which revealed a Wisconsin Community Corrections warrant# 585363-A (parole violation -confirmed), and Milwaukee Municipal warrant# 15001839 (Frequenting an Illegal Drug House). Note: In the Milwaukee Police Department Database, DORSEY is listed as Versia M. TAYLOR (b/m, 2/20/85, B of I: 349981). DORSEY was arrested on said warrants, conveyed to St Mary's Hospital (MedaCare#272, Dr AUGUSTINE, Admit Time 2:50 AM) for medical clearance as he complained of chest pains, and was then conveyed to District 4 for booking and processing.

No other violations were observed while myself and other officers were on scene.

This License Premise report was written by P.O. Ralph MCCLAIN, assigned to District Four, Squad 4365, Late Shift. On Friday, January 12th, 2018, at 12:45 am, I spoke with the co-licensee, Jimmie SIMMS, regarding an incident that occurred on Wednesday, January 10th, 2018. On this date, at approximately 12:40 am, Squad 4360, (P.O. Patrick RAY and his partner, P.O. Shane DOUGHTY), were dispatched to a Trouble with Subject at the BP gas station, 9040 W. Silver Spring Dr (CAD #18-010-0092) (right next to the bar).

Upon arriving on scene, P.O. RAY was approached by Joseph A. HOLMES, b/m, 08-17-89. HOLMES is part of the security team at Courtside Bar and Grill. HOLMES told P.O. RAY that a female subject threw an object at him outside of the bar and was presently walking to her vehicle, which was parked in the lot of the gas station. P.O. RAY and P.O. DOUGHTY conducted a FI stop of a female subject regarding the incident. P.O. RAY's subesquent investigation revealed that this female subject was not involved. When P.O. RAY attempted to gather more information regarding this incident, another security person from the bar told HOLMES "Don't get involved in that, let the police do their job". P.O. RAY explained that he was doing his job and needed to know more information regarding this matter. Again, this security personnel made the same comment. I spoke with SIMMS about how any investigation that relates to the bar needs to be thoroughly investigated. I told him that meant full cooperation from all parties, especially those employed by the establishment. SIMMS stated he would find out which security personnel made the comment and speak to him regarding. I told SIMMS that I would follow up with him on the bar's next night in operation. I also told SIMMS that I would like to get the names of all new security personnel he has hired since New Year's Day.

In addition, I spoke with SIMMS and HOLMES regarding vehicles blocking residence's driveways on W. Silver Spring Dr. SIMMS and HOLMES stated they would monitor the situation more closely by having at least one security personnel walk down the street occasionally to see if any bar patrons vehicles are blocking driveways.

This report is submitted by Police Officer, Patrick RAY, assigned to the Fourth District, Late Shift.

On Saturday, March 03, 2018, at approximately 01:27 am, I was dispatched to a battery complaint at Courtside Bar, located at 9012 W Silver Spring Dr., in the City and County of Milwaukee, Wisconsin regarding a battery complaint.

The caller / victim BaTrina T. THOMPSON (b/f, 10/20/76) stated that while inside of the premise she was attacked by a known subject Samiah ABDALLA (b/f, 01/27/1976). THOMPSON stated that ADBALLA struck her in the forehead with a glass bottle causing pain and injuries. THOMPSON had to be conveyed by ambulance to Froedtert Hospital for treatment and received multiple stitches to close her wounds.

I responded to the scene almost immediately as I was in the process of conducting a Tavern Check of that same business. I observed a commotion as patrons exited the front door of the establishment but did not find this to be outside of the norm as Courtside generally has what I would describe as an unruly crowd.

During the subsequent investigation Squad 4441, Officer Marshall JONES spoke with several employees of Courtside but did not find them to be cooperative. PO JONES stated that the individuals inside claimed not to have seen an incident and that there was no working surveillance inside of the location.

Per my request Officer Ralph MCCLAIN conducted follow up at the location and spoke with Jimmie SIMS (b/m, 06/13/74) regarding the incident. PO MCCLAIN stated that SIMS was extremely vague about the incident, making statements akin to "people said someone got hit" and "I was near the back...I did not see what happened." SIMS also stated that the surveillance within the establish was operable the night of the incident, contradicting the statements made by uncooperative witness(es) on scene that evening. PO MCCLAIN advised SIMS that police would be back to retrieve the relevant video and instructed SIMS to safeguard the recording(s).

This License Premise Report was typed by P.O. Ralph MCCLAIN, assigned to District Four, Squad 4365, Late Shift. On Sunday, March 11, 2018, at approximately 1:00 am, Squad 4365 (myself and P.O. Anthony PRESTI) responded to Squad 4360 (P.O. Patrick RAY and P.O. Edgar RODRIGUEZ) request for additional squads at the address of 9012 W. Silver Spring Dr (Courtside Bar and Grill). Squad 4360 was performing a routine tavern check when they observed multiple individuals fighting in front of the establishment.

While on scene, I interviewed the bar's co-manager, Shaun THOMAS, b/f, 02-20-71, who stated that while he was handing something to one of the bartenders, he observed two male subjects yelling at each other as they exited the men's restroom. He stated he then observed two female subjects swinging their arms wildly and grabbing each other's hair. THOMAS stated that the bar's security personnel quickly stepped in between the subjects. THOMAS stated the subjects were then escorted out of the bar.

I next interviewed security personnel Samuel G. GREEN, b/m, 07-31-74, who stated that he was at the back of the bar monitoring the patrons. GREEN stated he observed multiple female subjects, midway point of the bar, grabbing each other's clothing and grabbing at each other's hair. GREEN stated that he and other members of the security team promptly escorted the female subjects out of the bar.

I interviewed another one of the bar's security personnel, Jose A. COLON, h/m, 11-11-82, who stated that he was on the inside of the bar, by the front door. COLON stated he noticed that in the middle of the bar, people were scrambling to get out of the way as two female subjects began fighting. COLON stated he and other bar security team members rushed over to where the subjects were fighting and quickly intervened. COLON stated that he and other security escorted the two female subjects out of the front door of the bar and locked the door. I asked COLON if any of the bar's security personnel went outside to ensure the females left the premise. COLON stated that neither he nor any of the other security team left the bar after removing the female subjects. Asked why, COLON replied that "You don't know what type of weapons people may have in their possession. COLON also stated that the main objective to get them out of the bar. I explained to COLON that the ejected subjects are still on the bar's property and need to be escorted totally off the grounds and if need be, monitored by someone on the security team until they leave. COLON then said the reason he and the others didn't exit the bar is that there was too much going inside the bar.

There were four citations for Disorderly Conduct that were issued to participants in the incident. The following are the subjects who received citations; Andrea D. BROWN, b/f, 02-21-92 (cit #J9808L0Q8D); Latisha R. DUPREE, b/f, 07-19-90 (J9808L0Q8F); Leshan U. MCNEIL, b/f, 09-01-94 (AC587089); Roniesha T. FRANKLIN, b/f, 06-24-96 (J980C3B00Q).

Issues

The video surveillance system for the bar is often times malfunctioning.

The door person (which is usually the listed owner, Ernestine GOODSON, b/f, 10-14-52), does not have (or use) a door counter on a consistent basis.

Vehicles parked on the bar's property that blocks the public walkway.

Courtside's security personnel could do a much better job of being forthcoming on information relating to incidents that happen in and around the bar.

P.O. RAY, P.O. PRESTI and I will schedule a meeting with the co-manager, Jimmie SIMMS and owner, GOODSON to discuss issues surrounding the bar's operations.

The question was asked about the camera system only running a live feed. We asked that the camera system is updated, recorded, and available upon Police requests. Mr. Thomas stated they has some reppairs done and that it was possible that something may have been messed up. They will look into getting that repaired.

I asked, what security company is working for them and they could only give the first name of Chris. I asked them to get the information for the company. Thomas stated he will send it to me via email. They stated they have four guards working on the weekends and one is supposed to monitor the door at all times.


