On the date of this notice, tall grass/weeds were observed at the location listed. This is in violation of City Ordinance 80.17, which states, in part:

"... no turf grass or weeds of any kind shall be permitted to grow or stand more than 7 inches on any property in the city..." It further states: "It shall be the duty of the owner ... of any leased or occupied premises, and ... any vacant or unoccupied premises within the city to comply..." with this ordinance by cutting or otherwise destroying said tall grass/weeds.

A property failing to cut turf grass/weeds shall be subject to a special charge of \$50 for a first violation, if the violation is not abated **within 72 hours** of this notice. The special charge for each subsequent violation in the same calendar year shall increase by \$50 from the special charge of the previous violation. Failure to mow or abate any condition that remains in violation will result in an additional special charge of \$100, plus mowing costs for the first violation. Special charges for subsequent violation(s) abated by the City in the same calendar year increase to \$150, per occurrence.

This posting is left as a courtesy notice describing the violation and required abatement action. The City of Milwaukee requests that you bring the property into compliance without the need of further action on the part of the City. If you have questions, please call 286-CITY.
