### Purchase of Pistols with Holsters and Ammunition

- ➤ Current inventory of duty pistols was obtained from Fall 2012 Fall 2013.
- Current duty holsters are 18-19 year old technology.
- ➤ Major improvements have been made to holster designs.
- A change in duty pistol caliber would bring benefits over our current ammunition.
- Advantageous to make a change of duty pistol, holster, and duty ammunition at same time.

- ➤ New version of current duty pistol.
- > 9mm version T&E'd by Range Staff and several members of the department.
- > 35 pistols currently on the street; 10 with Range Staff, 25 with Tactical Enforcement Unit.
- > Slide stop and grip retaining pin issues already identified. Slide stop issue addressed by company.



#### Smith & Wesson M&P 2.0

- > T&E's by Range Staff and fired by several current recruits.
- Modular design. Interchangeability of internal components between different size frames.
- ➤ Sig Sauer pistols were previously issued to members of TEU.
- > Highly reputable brand.
- > Adopted by U.S. Army as M-17&18.
- ➤ Local users: WI DCI, Cudahy PD.



### Sig Sauer P320 Pistol

- ➤ Safariland 7390 tested by Range Staff.
- Approx. 35 holsters in use: 10 with Range Staff, remainder with patrol officers.
- > Increased retention over current holster.
- > Increased speed of draw noticed by all users.
- > Decreased wear on pistol finish.



**New Holster Option** 

- > Desire to change duty ammunition to 9mm from .40 S&W.
- > Similar performance to current duty round.
- Decreased wear on pistols.
- Decrease in recoil leading to increased "shootability."
- > Lower cost for training and duty ammunition.
- Current issue to Executive Command; formerly issued to TEU members.

## Plan

- Transition department members to Sig Sauer P320 pistols, new holsters, and make caliber change at same training session.
- ➤ Better to make the change in one session than spread out over many years.
- This capital investment would satisfy several needed upgrades, and position the department for many years.

# Neighborhood Initiative: Crime Stoppers

Permissive:

#### 1. Permissible Uses

- a. Law enforcement operations and investigations—Support of investigations and operations that further the law enforcement goals or missions. Examples include reward money (annual dues paid to a crime tip organization or payment for a specific reward for information in a specific case), recruitment and advertisement costs, agency accreditation or agency membership dues (but individual dues are impermissible), equitable sharing account maintenance fees, reimbursement to the jurisdiction for payments to informants, purchase of evidence, buy-back programs, and "buy" money.
- Empowers neighborhoods to support investigations
- Crime Stoppers is a non-profit organization operated by a volunteer community board of directors.
- Over 600 Crime Stopper programs nationwide
  - Combines national program with local control
