THIS DEED is made this day of ______, 2018, and it is between the City of Milwaukee ("**CITY**"), a municipal corporation, duly organized and existing under Wisconsin law, as Grantor, and Lone Star Industries("**Grantee**"), as Grantee.

1. The CITY hereby quit claims and conveys to Grantee, on an AS IS, WHERE IS basis, the following described facilities (the "Facilities") subject to all defects, known or unknown, discovered or to be discovered, and without any warranty or representation express or implied:

An 18-inch diameter sanitary sewer main and appurtenances located in Parcel 2 of Certified Survey Map (C.S.M.) No. 4604, a recorded C.S.M., in the N.W. ¹/₄, Section 32, Township 7 North, Range 22 East, in the City of Milwaukee, County of Milwaukee, State of Wisconsin, more particularly described as follows:

Beginning at a proposed sanitary manhole located at $17\pm$ feet northerly of the southerly line of West Canal Street and 402 +/- feet westerly of the northerly extension of the west line of South 6th Street in said ¹/₄ Section, said manhole not to be included in this conveyance;

Thence, southerly $391\pm$ feet to the center of a sanitary sewer manhole, said manhole to be included in and also be the end of this conveyance.

The location of the Facilities is more particularly depicted on the diagram attached hereto as **EXHIBIT A**, Plan File No. <u>198-7-86</u>.

Grantee shall be responsible for maintenance or abandonment of the Facilities. Grantee hereby accepts this Deed and the Facilities, and Grantee agrees to the terms hereof.

Sewer Agreement SA - 2882

Grantee agrees to the following conditions:

A. Grantee agrees to construct a new sanitary manhole $17\pm$ feet northerly of the southerly line of West Canal Street and $402 \pm -$ feet westerly of the northerly extension of the west line of South 6th Street as depicted on the diagram attached hereto as **<u>EXHIBIT A</u>**, Plan File No. <u>198-7-86</u>.

B. Grantee agrees to remove the existing sanitary manhole $6\pm$ feet northerly of the southerly line of West Canal Street and 402 +/- feet westerly of the northerly extension of the west line of South 6th Street as depicted on the diagram attached hereto as **<u>EXHIBIT A</u>**, Plan File No. <u>198-</u><u>7-86</u>.

C. Grantee agrees to extend said 18-inch diameter sanitary sewer from the proposed sanitary manhole to the existing 18-inch diameter sanitary sewer. Grantee also agrees to install a concrete collar to connect the sewer extension to the existing 18-inch diameter sanitary sewer.

D. Grantee shall protect and support the existing 21-inch diameter storm sewer during this work. Any damage to the storm sewer shall be repaired at the Grantee's expense.

E. Grantee is responsible to perform the aforementioned work (A-D) at their own cost.
