Dear Committee Members:

This report recommends recruitment flexibility for the position of Health Communication Officer in Pay Range 1EX (\$58,462 - \$81,844). This position manages the staff and functions associated with marketing and communications, media and community relations, and graphics/web services for the City of Milwaukee Health Department. It serves as the public information officer, represents the department at community events, and is responsible for executing long-term public relations plans.

The Health Department is actively striving to be a strategically forward-thinking organization. Filling this position with the most qualified candidate is imperative to the department and the community of Milwaukee because this position plays a large role in how critical information is communicated to constituents which in turn impacts the health of the community.

A recruitment for this position was held recently in which the Staffing Division received sixteen applications and interviewed four candidates. Upon interviewing these well-qualified individuals, it was realized that recruitment flexibility was needed in order to provide the City with the ability to recruit and retain the best candidates for this critical position. We therefore recommended that a footnote be added to this title that allows appointment anywhere in the range with the approval of the Department of Employee Relations and the Chair of the Committee on Finance and Personnel.
